

of dollars more into fossil fuels than they have into clean energy since the Covid-19 pandemic, despite their promises of a green recovery. As the new analysis reveals that the countries attending committed \$189bn to support oil, coal and gas between January 2020 and March 2021. In comparison, the same countries - the UK, US, Canada, Italy, France, Germany and Japan - spent \$147bn on clean forms of energy. The support for fossil fuels from seven of the world's richest nations included measures to remove or downgrade direct funding of oil, gas and coal. The could be used as a springboard for analysis from the

development charity Tearfund, International Institute Sustainable Development and the Overseas Development Institute showed that the nations missed opportunities to make their response to the pandemic greener. In most cases, money provided for fossil fuel industries was given with no strings

attached, rather than with conditions requiring a reduction in emissions or pollution. The analysis found that eight in every 10 dollars spent on nonrenewable energy came without conditions. This included lifelines that were thrown to the aviation and car industries, which received \$115bn from the G7 countries. Of that money, 80% was given with no attempt to force the sectors to cut their emissions in return for the support. Only one in every 10 dollars committed to the Covid-19 response benefited the "cleanest" energies such as renewables and energy efficiency measures. The UK prime minister, Boris Johnson, will open the G7 summit in Cornwall on 11 June. He has said he wants to unite the nations to "build back better" from the coronavirus pandemic to create a greener, more prosperous future. As well as the G7, the UK has invited South Africa, Australia, India and South Korea to take part. The analysis of the actions of the seven major western economies in the last 15 months reveals they are not yet investing at sufficient scale in technologies that support fast decarbonisation of their economies, and they have not created green jobs at scale in response to Covid-19.Paul Cook, the head of advocacy at Tearfund, which operates in some of the poorest countries in the world most affected by global heating, said: "Every day, we witness the worsening consequences of the climate crisis for communities around the world farmers' crops failing; floods and fires engulfing towns and villages; families facing an uncertain future."Choices

Israeli opposition parties face midnight deadline to form government

London, June 02: Israeli opposition politicians have until midnight on Wednesday to hash out final negotiations to build a coalition government that would end Benjamin Netanyahu's 12-year run as prime minister. Under the country's election laws, opposition leader Yair Lapid's 28day mandate to forge a majority by allying with rival parties ends on Wednesday. By this time, he should have informed the president he has succeeded. If he fails, Netanyahu may be granted a political lifeline in the form of a snap election.Lapid and other party chiefs met near Tel Aviv on Tuesday afternoon to discuss the last agreements for a "government of change", amid reports of a handful of disagreements over control of ministries and committees. Under the proposed deal, Lapid will not immediately become prime minister. Instead, his political rival and far-right politician, Naftali Bennett, whose support is seen as vital to the coalition's success, will become Israel's leader for likely two years of a four-year term. Netanyahu and his ruling Likud party were desperately attempting to find defectors and scupper the plan, appealing especially to politicians on the religious

hard right not to join Lapid, who has described himself as a secular centrist. Lapid needs a 61-seat majority in the 120-seat Knesset, Israel's parliament, so losing one or two seats could end the attempt. US secretary of state warns Pacific leaders about 'coercion' in veiled swipe at China Leaders, and was attended by leaders or

Washington, June 02: The US secretary of state has warned leaders of Pacific countries about "threats to the rules-based international order" and "economic coercion", in what appears to be a veiled swipe at China's growing influence in the region. Antony Blinken was addressing leaders and their delegates from 11 Pacific countries and territories including Fiji, Solomon Micronesia, French Polynesia, Palau and Marshall Islands as part of the Pacific Islands Conference of Leaders, which is held in Hawaii.Blinken reiterated US support for Pacific island nations as they face the "shared challenges that we have to confront together", including Covid-19 and the climate crisis. He also appeared to make a criticism of Australia's action on the climate crisis, calling for "all countries, particularly the biggest emitters, to swiftly and dramatically reduce emissions."But the main focus of his televised address was

The another crisis

Covid-19 has killed millions around the world, but for some who are lucky enough to survive the infection, the nightmare is not over: adding insult to injury are deadly fungal infections that follow in the wake of the virus. Making matters worse, inequities that long predated the pandemic have left some countries without the capacity to combat these serious infections. In India, a fungal infection called mucormycosis has emerged in patients with Covid-19. This infection is caused by a group of fungi that are everywhere on the planet. In fact, all of us are probably inhaling spores of these fungi every day, but these are rapidly controlled by our immune systems. Rarely, our defences are breached, and the fungus takes hold, with devastating consequences. After establishing itself in the nose and sinuses, it begins to invade the tissue of the face, the jaw, the eyes and brain, blocking blood flow and causing tissue death. It is the black discoloration of dead tissue that conferred upon this mould its fearsome moniker in the Indian media: "the black fungus". Although the fungi are ubiquitous, mucormycosis is usually rare, and most specialists around the world will see fewer than a dozen cases in their entire careers. Even before the pandemic, rates of mucormycosis in India were estimated to be about 70 times higher than in the rest of the world. Even so, the tsunami of cases occurring in the wake of Covid-19 is of an unimaginable scale. More than 11,700 people were reported by a government minister to be receiving care for mucormycosis on 25 May. Two states, Maharashtra and Gujarat, have confirmed more than 5,500 cases. Whereas a large referral hospital in London might see three or four cases a year, some Indian hospitals are caring for more than 500 patients with mucormycosis right now. Mucormycosis cases in Covid-19 patients have also been linked to poorly controlled diabetes and therapeutic steroids, a triad of risk factors some have dubbed "the unholy trinity". Although steroids can be lifesaving in Covid-19 patients needing supplemental oxygen, they are a double-edged sword; they weaken the immune system that normally keeps fungi we inhale at bay. Undisciplined prescribing is likely to be playing a major role in driving the epidemic: one study at 16 Indian hospitals found that nearly two in three steroid prescriptions for Covid-19 patients were inappropriate (they were either used in patients who weren't sick enough to warrant them, or the dose was too high). Lack of access to oxygen may have resulted in doctors overcompensating by prescribing higher-than-recommended doses. Additionally, rates of diabetes have been increasing in India, and high blood sugars further weaken the immune system and increase the growth of fungi in the body. High blood sugars are also a well-known side-effect of steroids, particularly in diabetic or prediabetic patients, and overstretched healthcare workers have been unable to adequately monitor blood sugar levels of Covid-19 patients on crowded wards. The confluence of these risk factors, plus higher-thanaverage background rates of mucormycosis, high numbers of spores in both indoor and outdoor environments, and the lack of hospital infection-control resources (like efficient air particle filters in ICU rooms, standard in resource-rich settings to filter out airborne spores) have allowed the fungus to run amok.Mucormycosis is rapidly fatal without prompt diagnosis, administration of antifungal medicines and - most importantly - emergency surgery to cut out the dead and infected tissue. This lifesaving surgery can be extremely disfiguring and lead to irreversible loss of one or both eyes. Even with surgery, half of those infected won't survive. Most cases develop in the second or third week following a Covid-19 diagnosis, when many patients are no longer in hospital. The partial closure of outpatient clinics and the shortage of specialised doctors have meant that affected patients present to hospital later in the disease, when the odds of survival are lower. The mucormycosis epidemic has been accompanied by a rush for antifungal treatments that have left India's medicine cabinet empty. The nation's supply of amphotericin B, the best antifungal to treat the infection, is nearly depleted and it is difficult to procure. The government has pledged to increase importation and ramp up domestic production of the drug, but this will take several weeks to months.

ominic Cummings's marathon appearance in front of MPs on Britain's coronavirus response was by some distance the most extraordinary Commons event of its kind in a decade. There has been nothing to match it since Rupert Murdoch was finally compelled to give evidence to a select committee on phone hacking, back in 2011. In some ways, though, the two events were important for the same reason. In both cases, here were immensely powerful men dethroned in Cummings's case, throne tottering in Murdoch's - going through the elaborate pretence of public contrition in front of a governmental body that, at heart, they despised. In both, the glimpses into their minds were compelling. But, in both, the apparent penitent submitted to the process for a similar reason - the hope of emerging to resume their respective crusades against the liberal order. To understand what Cummings was doing it is important not just to be riveted by his hypocrisies and his U-turns. It is also

Wednesday, as Cummings offered Martin news story upon news story, that was difficult. The audacity of Cummings's attempt, in Fintan O'Toole's succulent Shakespearean metaphor, to transform himself from the amoral manipulator Iago into the wronged innocent Desdemona is at times breathtaking. But there is method in it too. There is a backbone of consistency in Cummings's political career. For a country that spends as little as 1.2% of its GDP on healthcare and has always struggled with last mile delivery of care and treatment, remote access to specialists or in many care general practitioners can be a game changer.

The concern is aggravated by the fact that underlying disease conditions or co morbidities increase the risk of fatality and serious illness in people who get Covid-19. Soon after the pandemic broke, a study had revealed 61% reduction of people reporting stroke which was not the result of reduction in disease but those seeking treatment as a result of lockdowns. Thousands of cancer cases remain undiagnosed every month, progressing to more serious and untreatable stages. A rapid survey conducted by the World Health Organization across 120 countries showed that essential health services were disrupted in over 80% of the countries, including in India. In the midst of such collapse, tele medicine has emerged as a life saver.

The HWC where Gagandeep's family took her, was set up as a tele medicine site by Punjab Government. The community health officer (CHO) facilitated a remote consultation with the attending doctor at the hub. "Within a few minutes, a doctor appeared on the computer screen. She was calm and guided the CHO to take my pulse, re-check my blood pressure which was very high and counseled me to take medicines regularly, without fail and never ignore even the slightest symptoms." Gagandeep was immediately put on medications. "The tele consultation saved my life. We shudder to think what might have happened if tele-medicine facility was not available at the HWC near my home," she reminisces.

The National Telemedicine Service, set up by the Ministry of Health can be availed of in two ways. The doctor to doctor telemedicine platform called eSanjeevaniAB-HWC (Ayushman Bharat - Health and Wellness Centres) is being implemented at select HWCs in the country at the initiative of the state government. hen Ann Keen gave birth, the midwives re fused to give her anything for the pain. That way, they told her, she would remember it and learn not to be so wicked again. To be treated like an animal in labour, denied the most basic compassion and respect, was simply part of the punishment she had supposedly earned for getting pregnant out of wedlock aged 17. The hospital discharged her without any follow-up care, as if the birth had never happened. But the most grievous part of the story is that she also went home without her baby. For Keen is one of a still unknown number of unmarried British women coerced into

handing over their newborns for adoption between the 1950s

and the late 1970s, who are now seeking an apology from Boris Johnson on behalf of the governments of the day. But perhaps just as importantly, they want it acknowledged that they didn't give their children up willingly. Some were told that if they loved their babies they would want them raised by respectable married couples, not under the shadow of illegitimacy. consented to adoption under this kind of duress, others say forms were simply signed on their behalf by parents or socalled "moral welfare workers" supervising adoptions. The grief for the mothers must have been lifelong, and for many it was handed down a generation when heir children grew old enough to understand and be disturbed by what had happened. Oppres-

The real size of the problem is largely unknown and recent information shows that the current knowledge is only the tip of the iceberg.""The incidences of healthcare violence have increased over the years and have become widespread and the dreaded entity poses to be threat to the medical practice," the IMA wrote. This comes after a doctor was attacked by a group of people in Assam's Hojai district yesterday, following a Covid patient's death. "While the entire medical fraternity stands with you and is working tirelessly during the pandemic, it is also facing a serious threat from healthcare violence. There are many incidences of healthcare violence taking place across the country," the IMA said.

Assam have become the targets

General of Police, Bhaskar Jyoti Mahanta speaking exclusively to Niyomiya Barta revealed that a six-layered network was running an empire of banned drugs in Assam. At the top of this network is an international level production manager who produces opium, the raw material needed for drugs." Opium is mainly produced in Myanmar, but it does not meet the demand. Therefore, the production managers have used the remote hilly areas of Manipur, Arunachal Pradesh, etc. in the northeast for opium cultivation. This work involves the second level of the drugs network. They are responsible for protecting the opium poppy fields and in return collect large sums of money from the production managers", added Mahanta. Various extremist groups in the Northeast provide protection to opium poppy cultivation. Later, this opium is transported to Myanmar. According to the market demand in Myanmar, different types of drugs are manufactured and taken to the third tier of the network i.e. distributors. All of these distributors are responsible for transporting drugs to various locations at a later stage. They send large quantities of drugs to Assam and other places in the North East at regular intervals. After this, a large number of local people became involved in the drug network.Local drug dealers play an important role in the entire business, known as 'receivers'. The last level of the drug network is the local distributor. They sell poisonous drugs in different parts of Assam through agents. Some of the distributors have taken over the responsibility of selling the drugs themselves while others have been selling drugs through their trusted people and addicted youths. In addition, some young people who do not use drugs themselves have recently resorted to selling drugs. This particular trend came to light after the Assam Police started with a massive crackdown and investigation. DGP Mahanta said that many mafias from Bihar-Uttar Pradesh have started cultivating opium or cannabis in Assam. For this purpose, they take over the lands in the interior areas and the lands near the rivers of the state and employ the locals to cultivate the land. The Assam Police has uprooted 69 bighas of opium plantation in 2020 and 15 bighas till May 2021. According to the Assam Police, the crop is mainly grown in Barpeta, South Salmara and Kamrup district areas. Citing statistics on the growing prevalence of drugs in Assam, DGP Mahanta said that there were 455 cases of illicit drug trade in 2018, 826 in 2019, 980 in 2020, and 552 till May 2021. Similarly, 694 people have been arrested in 2018, 1,226 in 2019, 1,652 in 2020 and 838 till May 2021. The quantity of drugs and other banned substances seized during these years is as follows: In 2018, 7 kg of heroin, 10 kg of opium, 1.25 lakh bottles of cough syrup and 4 lakh meth tablets; In 2019, 24 kg of heroin, 26 kg of opium, 55 thousand bottles of cough syrup, 15.37 lakh meth tablets and 6 kg of morphine; In 2020, 28 kg of heroin, opium 17 kg, 87 thousand bottles of cough syrup, 12.7 lakh meth tablets, 24 kg of morphine and cocaine have been seized by the authorities. As of May 2021, 17 kg of heroin, 30 kg of opium, 14,974 bottles of cough syrup, 7.48 lakh meth tablets and 1.5 kg of morphine have been seized. During the current year, the number of drug-related cases reported per month has increased by 105 percent. On an average, 187 criminals are arrested every month.DGP Mahanta informed that in order to stem the tide of social degradation, the police were planning to hit the 'supply chain' of drugs so that emand in the region would decline and supply would be cut off. At the same time, the police are conducting search operations for the main smugglers. There is clear evidence that such smugglers have links to extremist organizations. board examination will most likely be cancelled because "BJP-ruled states will follow the Prime Minister's view". Opposition-ruled states such as Maharashtra and Rajasthan said they would decide the fate of their Class 12 Board examinations in the next few days. Rajasthan will take a call during a State Cabinet meeting Wednesday. Sources said that during Tuesday's meeting, the Prime Minister was briefed about the national consultation held on May 23 and states' feedback about the two options proposed by the CBSE for conducting the school-leaving examination. Under Option A, exams for 19 major subjects were to be held in the "existing format" at designated examination centres, and marks for minor subjects calculated on performance in major subjects. Class 12 is a milestone exam in the life of a student, and the gateway to higher education. Given that different state boards compete with the CBSE and ISC, the challenge for universities will be to evolve a level playing field to screen candidates for admission. Under Option B, exams for major subjects were to be conducted in the students' own schools, instead of designated centres, with each exam having a shorter duration of 90 minutes. On Tuesday, sources said, the Prime Minister was briefed about a third option that wasn't discussed with the states - the possibility of scrapping the examination, given the fluidity of the situation and the health implication of 20 lakh students stepping out to appear for the examination."(The) PM said that the Covid situation is a dynamic situation across the country. While the numbers are coming down in the country and some states are managing the situation through effective micro-containment, some states have still opted for a lockdown," the statement said. "Students, parents and teachers are naturally worried about the health of the students in such a situation. The PM said that students should not be forced to appear for exams in such a stressful situation," it said. On Monday, the Centre told the Supreme Court that it would decide in the next two days whether or not to hold the Class XII board exams amid the pandemic. The decision will have a cascading effect on admissions to higher education institutions. According to the Education Ministry's estimate, about one crore students get admission in colleges and universities based on their performance in Board examinations."There is a substantial risk of inflation of marks by schools. Normalising the differences in results prepared by schools will be a big challenge for CBSE. And it remains to be seen if universities will consider these results for admission," said a ministry official. The higher education department of the Education Ministry will look into the admission process only after CBSE announces the "objective criteria" for evaluating Class 12 students. According to sources, the common entrance test proposed for all central universities in the new National Education Policy may get a fillip now. The marketing folk would probably describe it as a soft launch, with new players being explored and spectators returning in reduced numbers. But the two-match series against New Zealand - one of cricket's friendliest rivalries - still provides plenty of the good stuff that Test cricket lovers feast upon and administrators should keep in mind the next time they talk down the format's future. Granted the series has been laid on as a goodwill gesture for the broadcasters and the grounds and does not form part of the World Test Championship. But neither did the 2,000-plus Tests staged before it began in 2019. We still have two enticing sides on show, while the return to Lord's - scene of a belting Test between the two countries in 2015 - and then Edgbaston offers a much-needed sense of normality returning after a season spent schlepping between the bubbles at the Rose Bowl and Old Trafford and back again. New Zealand are the far more settled team and the global final against India would cap their enviable rise under Kane Williamson. Osaka said she expected to receive fines, as other players have received for skipping press in the past, and she was prepared to pay them and then discuss further solutions after the event. That should have been enough for the time being. Instead, as the tournament finally began and interest in the story waned, the grand slam tournaments escalated the situation by warning that by repeatedly skipping press conferences she could be defaulted or even risk suspension from future grand slam tournaments. By applying such unnecessary pressure, they forced Osaka to choose between defiance and the possibility of unprecedented punishments or the deep discomfort of facing the media. Withdrawing was the option to minimise her stress. With her departure, she explained that she suffers from depression and is struck by anxiety before press encounters. The press conference that the French Tennis Federation president, Gilles Moretton, held on Monday night further underlined just how badly the tennis authorities handled this situation. In a statement uttered from the press room his organisation demanded that Osaka enter, he wished Osaka "the quickest possible recovery", as if depression is an injury that will heal shortly. After he and his colleagues had postured

ences a day earlier, he left without fielding a single question. Ultimately, their behaviour reflected old institutions that are desperate to maintain control, uninterested in the human cost. As the fallout from Osaka's decision to withdraw from Roland Garros continued, her fellow athletes rallied behind her to offer their support. Shortly after her first-round win against Irina Camelia Begu on Monday night, Serena Williams said she empathised with Osaka. "The only thing I feel is that I feel for Naomi," she said. "I feel like I wish I could give her a hug because I know what it's like. Like I said, I've been in those positions. We have different personalities, and people are different. "Others responded directly to Osaka on social media. The NBA guard Kyrie Irving, who himself has been fined a total of \$60,000 for skipping media obligations this season, commented: "We are all with you Queen. Just be you, that will always be enough." Stephen Curry said: "You shouldn't ever have to make a decision like this - but so damn impressive taking the high road when the powers that be don't protect their own. Major respect. "The events have also led to a discussion about the utility of press conferences. Speaking on the BBC Radio 4 Today programme, the British player Laura Robson explained the obstacles that players face during their mandatory post match press conferences: "It can be really difficult and when you've come in after a loss and you're already feeling bad about how you've played on court and then you're reminded it in a question, it's absolutely not easy so I totally understand why Osaka has had to withdraw

'Courageous': Japanese athletes and sponsors voice support for Naomi Osaka struggles."Having to take a step back and say,

London, June 2: Athletes and sponsors in Naomi Osaka's native Japan have joined much of the tennis world in rallying behind the player after she withdrew from the French Open, citing struggles with anxiety and depression. The Japanese world No 2 left the grand slam tournament on Monday, days after she had been fined and threatened with expulsion for refusing to attend press conferences, saying she needed to protect her mental wellbeing. Messages of support flooded in after Osaka, who is of Japanese and Haitian descent, tweeted a statement describing her struggle with her mental health since her first grand slam win, a victory over Serena Williams at the 2018 US Open. "The first thing to be considered is Ms Osaka's health. I wish her the earliest possible recovery," wrote Toshihisa Tsuchihashi, the executive director of the Japan Tennis Association. The Japanese government's top spokesperson, Katsunobu Kato, said that he would "watch over her quietly" when asked to comment by reporters. There was backing, too, from one of the sponsors that have helped take Osaka's earnings to \$55.2m over business website Sportico. Nissin Foods,

'Hey, I need to do this for me', we should support her and applaud her, because a lot of people wouldn't do that," Stephens said at Roland Garros on Tuesday."A lot of people play through being miserable and being upset and not being able to speak out and say those things. We should be more accepting and allow her to take the time she needs to work on herself and better herself so she can be in a better position to play tennis and be happy and enjoy her tennis."But I think there definitely needs to be more open dialogue on what not only her but everyone on tour goes through. I think we don't talk about it enough. "Stephens said she hoped Osaka would take all the time she needed before returning in better shape, a sentiment shared with another American player, Coco Gauff, who said she hoped Osaka can "come out better and stronger"."It's unfortunate that she's going through what she's going through," said Gauff. "I can only lend out a hand for support. The Tour isn't the easiest. I talk to other players and they have gone through similar things in the past."After Serena Williams had exthe past 12 months, according to the sports pressed her sympathy for Osaka, saying she wished she could give her a hug, her sister

The Japanese carmaker Nissan said it stood in solidarity with its brand ambassador. Fellow Japanese players had mixed feelings about Osaka's decision. Misaki Doi said she had been "surprised" by Osaka's withdrawal. "I can't imagine what she's been going through. but I hope she doesn't regret her decision," Doi told reporters after making an early exit in the women's singles. Doi conceded that attending press conferences after a defeat could be "unpleasant", but added that they helped draw a line under a match and that she considered interacting with reporters part of her iob."It's sad to see Naomi-chan withdraw," said Yoshihito Nishioka, who won his opening match in the men's singles. "I wanted to see her compete despite the hardships involved. "Reaction in the wider tennis community has been mixed, but Sloane Stephens, the American former US Open champion plauded for speaking out about her mental health issues.

Venus revealed how she dealt with the pressures of press conferences."For me personally how I deal with it was that I know every single person asking me a question can't play as well as I can and never will," she said. "So no matter what you say or what you write, you'll never light a candle to me. That's how I deal with it. But each person deals with it differently. "Martina Navratilova, an 18-times grand slam champion, said the situation had made her "so sad", but added that the issue media calls."I truly hope she will be OK," Navratilova wrote. "As athletes we are taught to take care of our body, and perhaps the mental and emotional aspect gets short shrift. This is about more than doing or not doing a press conference."People in Japan, where Osaka's phenomenal rise has prompted a discussion on Japanese identity, said the tennis star had revealed the unseen psychological toll competing in sport at the highest level can take on athletes."I think she's under a lot of pressure, more than we can imagine," Tomomi Noguchi, a kimono dresser in Tokyo, said of Osaka, who was 20 when she beat Williams. home and it is logical that it can afabout the importance of press conferinstead of simply accepting the way for her mental wellbeing. Roger Federer eases to comfortable win over Denis Istomin on slam return

London, June 2 : Even at some of the lower points in his career, Roger Federer has rarely entered a grand slam without at least leaving the door slightly ajar for the possibility of a magical outcome. But these are unique times as he continues to return from two knee surgeries not far from his 40th birthday and Roland Garros appeared on the horizon this month, he was unusually frank: "Roland Garros is not the goal," he said. "The goal is the grass."For as long as he is in Paris, though, that does not mean that he cannot have fun. On Monday, Federer returned to grand slam competition for the first time since the 2020 Australian Open 487 days ago and he finally looked like he was enjoying himself on court as he dismantled Denis Istomin 6-2 6-4 6-3 to move into the second round. Even against No. 204 Istomin, a qualifier and the lowest-ranked player Federer has faced in his four matches since his return, every win is positive reinforcement in the midst of a comeback. Thus, the freedom Federer played with over the swift 93-minute win marked a clear step forward. This comeback has already had its obstacles. After a hopeful re-

turn at the Qatar Open in March, losing in his second match to eventual champion Nikoloz Basilashvili, Federer did not resurface until two weeks ago in Geneva where he lost in the first round to No 75 Pablo Andujar after leading by a break in the final set. Afterwards, his frustration was palpable and he felt that his training was not translating to his match.Monday was an entirely dif-

ferent sensation: "I just felt overall much clearer, much better," he said. "Clearly also maybe the type of opponent allowed me to have many different ways to win the point. I knew if I came to the net, that was an option. Hitting a drop shot was always an option. Taking the ball early was an option."With minimal pressure applied by Istomin, Federer was in con-

trol of the majority of exchanges and he demonstrated his confidence from the opening game by executing the first in an array of drop shots throughout the match. Federer looked comfortable in every part of his game he confidently moved to the net when he could and he controlled the match

with his forehand. The enduring question for Federer upon his return was how his two knee surgeries will affect his mobility, but his movement has been solid. Against Istomin, he defended well into both corners and he remained extremely agile in the drop shot exchanges close to the net. Towards the end of the third set, Federer chased down a drop shot and then lob before attempting an exhi-



bition-style tweener. He very nearly went viral in his first grand slam match back. In his press conference in the evening, Federer concluded by noting that one of his obstacles right now is as simple as growing accustomed to the minutiae of competition once more: "I think getting used to tournament and match rhythm again, the whole thing with the towels there, the shot clock there, everything that goes with it," he said. "I don't know, I really felt like I didn't find the rhythm. I think the biggest difference for me was in Geneva, now looking back, is that I feel like you play a lot of points very quickly. I think that's what got me at the end. I rarely took the extra two, three, four, five seconds I usually take by getting the towel or waiting for the crowd."Federer will face former US Open champion Marin Cilic in the second round, a match-up that last took place in the 2018 Australian Open final. Meanwhile, second seed Daniil Medvedev won his first ever match at Roland Garros with a comfortable 6-3 6-3 7-5 victory over Alexander Bublik. Medvedev, who is well known for his intense, vocal dislike of clay, described his prospects in far more positive terms and compared the conditions to hard courts."I feel really hopeful," he said. "As I say, you could see it today in the match, I'm feeling that here, at least this year with this weather, with these balls, I can play like on hard courts.
