Ex national basketball player Mujahid Ahmed Saikia dies of post COVID complications

NAGAON, June 7: Ex national basketball player, senior sports organizer and coach, Mujahid Ahmed Saikia breathed his last at Guwahati Medical College Hospital on Saturday night. He was 62. Saikia along with his wife was tested positive for COVID 19 a couple of weeks back and admitted to Nagaon BP Civil Hospital. But due to rapid deterioration of his health condition, he was later shifted to Guwahati Medical College Hospital (GMCH).

Subsequently, he as well as his wife was tested negative. But on Saturday night, he breathed his last for post COVID complications at GMCH itself when he was undergoing treatment in the college hospital.

He served as general secretary to Assam Basketball Association as well as secretary of basketball branch under Nagaon sports association till his death. Besides, he also served as president of Nagaon basketball club till his death. His earthly remainings was brought to his residence situated at Nagaon MD Road near Saikia Masjid in the town on Sunday last. Flood caused by major rivers inundates many areas in Lakhimpur district

North Lakhimpur, June 7: Incessant rain and release of dam water from NEEPCO has led to an increase in the water level of Ranganadi river in North Lakhimpur since the last two weeks. NEEPCO released the water through several gates which had the river in spate in its downstream areas in Lakhimpur district. Shackled skeleton identified as rare evidence of slavery in Roman Britain

Paris, June 07 : His ankles secured with heavy, locked iron fetters, the enslaved man appears to have been thrown in a ditch - a final act of indignity in death.Now the discovery of the shackled male skeleton by workers in Rutland - thought to have been aged in his late 20s or early 30s - has been identified as rare and important evidence of slavery in Roman Britain and "an internationally significant find".It was also desperately grim, said Chris Chinnock, one of the archaeologists working on the project, but was important because it "forces us to ask questions that we wouldn't ordinarily ask". Builders came across the bones when they were constructing a conservatory at a house in Great Casterton. Police were called and subsequent radiocarbon dating showed the remains were from between AD226 to AD427.Archaeologists from the Museum of London



Archaeology (Mola) were called in and have been researching the skeleton, with their findings published on Monday in the journal Britannia.No one doubts that slavery existed during the Roman occupation of Britain but discovering direct archaeological evidence is another matter. Most of what is known comes from inscriptions. "To have the opportunity to study the body of a person who quite probably was a slave is really important," said Michael Marshall, a finds specialist at Mola. The Great Casterton discovery is the first of its type in Britain, described by researchers as the clearest case of a burial of an enslaved individual found in the UK. "This burial is exceptionally unusual," said Marshall.Precisely who the man was will never be known but a number of informed guesses can be made. "It could be the dead person was somebody who had earned the ire of other people," said Marshall. "Equally it could be that the people who buried him were tyrannical and awful. We can't really understand the moral dimensions."The team have been examining a number of theories including that the shackles might have been added after the man died to demean him or brand him as a criminal in the afterlife. The few skeletons found with shackles in other countries are normally the victims of natural disasters and have not been buried. That is not the case in Great Casterton, say archaeologists. The burial position is an awkward one, said Chinnock, with the skeleton slightly on his right side and his left side and arm elevated on a slope. There is a Roman cemetery just 60 metres away, suggesting a conscious decision not to bury him properly. The likely explanation is that he has been thrown in a ditch and covered over. Chinnock, an expert in ancient bones, said the man appeared to be between 26 and 35 and had led a physically demanding life. A bony spur on an upper leg bone may have been caused by a fall or blow or be the result of a life filled with excessive physical activity. The injury had healed by the time he died and the cause of his death remains unknown. The Mola team say the identity of the man will never be known but "the various pieces of evidence present the most convincing case for the remains of a Roman slave yet to be found in Britain".A number of questions remain around the Great Casterton man but it was clear, Marshall said, that it was "extraordinary" evidence of mistreatment.

Centre vs states, rules vs conventionwho really controls IAS officers

unprecedented nature of the tussle between the Centre and the West Bengal government over the state's former chief secretary, Alapan Bandyopadhyay, has triggered a nationwide debate on the politicisation of the civil services. Both the Centre and the state government have claimed to have more powers over the posting and deputation of the 1987-batch IAS officer. This has led to questions over the separation of powers between the central and the state governments, both of which are served by officers of the three All India Services (AIS). The examination of powers of the state and the central governments across nine parameters - deciding the number of officers to be recruited. recruitment, appointment, cadre allocation, training, transfers and postings,

empanelment and central deputation, extensions, and disciplinary proceedings - reveals that in at least eight, the Centre enjoys a preponderance of power over officers of the Indian Administrative Service (IAS), Indian Police Service (IPS), and the Indian Forest Service (IFS). However, at the same time, experts told ThePrint that while a plain reading of the rules gives the central government overriding powers over the civil services, convention has often ensured a collaborative and consultative approach between the Centre and states in the spirit of federalism, and a significant degree of de facto powers to the states. The IAS and the IPS were created after Independence - the Indian Forest Service joined the two in 1966 under Article 312 of the Constitution in order to create a pool of administrators and law enforcers common to the Union and states. The idea behind having this common pool of officers, all of whom are governed by the All India Services Act, 1951, was that it would strengthen the unitary character of the Indian federation."The Centre enjoys a preponderance of powers when it comes to the AIS officers," said former secretary of the Department of Personnel and Training (DoPT) Satyanand Mishra. "The larger scheme behind having an AIS was that India is a highly competitive Civil Services

New Delhi, June 07 : The highly diverse country, and, therefore, it would be important to bind it together through a common, centrally-recruited pool of officers," he added. "It was believed that it is necessary that key executive functions in any state are performed by members of this centrally recruited pool." It is in this spirit, he added, that a state cadre does not have more than one-third of officers who are originally from that state. "This was done to ensure that people have fewer connections, vested interests and regional affiliations while executing

Examination (CSE). Finally, the liability to serve both under the officers recruited by the UPSC are appointed by the President of India, thereby making the Government of India (GoI) their appointing authority. Several of the powers of the Centre over AIS officers flow from the fact that it is their appointing authority. The selected officers are subsequently assigned their state cadres by the Centre. While the Centre does this by factoring in the states' requirement, the officers' preference, their rank in the exam, etc, the final decision remains with

state and under the Centre." Therefore, once officers are recruited and trained by the Centre, they are sent to their state cadres. While the Modi government has instituted the practice of appointing newly recruited officers as assistant secretaries in different ministries in the Government of India before they go to states, it is at the state level that the career of an AIS officer really starts at the district level. It is here that states have complete authority over who to post in which district, who to elevate to the state

which the Centre can pick officers for vacant posts.To work for the central government at the level of joint secretary and above, it is imperative for an officer to first be empanelled by the Centre. The process, often criticised for its lack of transparency, allows only a minority f IAS officers to be made eligible for senior postings at the Centre. "The Centre empanels an officer after 16 years of service. But by doing so, it basically takes away the incentive of all the nonempanelled officers to work with the national interest in mind," a recently retired IAS officer said. "For all the officers left behind, loyalty to the state government becomes the sole determinant for their career progression."Bandyopadhyay, for example, was not empaneled by the Centre, the officer said. After empanelment comes the actual process of central deputation. According to AIS Rules, 1951, a cadre officer can be made available for central deputation through a consultative process that involves the state, the Centre and the officer concerned. While all three have a say, in case of a dispute between the Centre and the state, the former's will prevails. If states can win the loyalty of officers through the threat of adverse postings and transfers, the central government can do so with the allure of post-retirement postings. The power of extending the services of IAS officers rests exclusively with the Centre. Even if a chief secretary appointed in a state is to get an extension, permission has to be granted by the central government to the state government, as happened in the case of Bandyopadhyay (who got an extension in May). It is for this reason that while the Centre often extends the services of the officers it wishes to retain after their retirement, the states instead end up appointing them in the CM's Office as advisers out of the ambit of the AIS Rules. Again, a case in point is Bandyopadhyay, who was appointed as the Chief Minister's adviser after he retired (he didn't take the extension). Since the political harassment of AIS officers for not toeing the line is widely prevalent, the rules to initiate disciplinary proceedings against them are very carefully crafted.

their administrative duties because India has to fundamentally function as a union of states," he said. Every year, the three cadre-controlling authorities - the DoPT (for the IAS), the home ministry (for the IPS) and the environment ministry (for the IFS) - carry out a "cadre review" of the three services. A cadre review entails an assessment of how many new officers need to be recruited in each service in each state. While the review is done in consultation with the states - each state gives the Centre its requisition for the number of officers needed - the ultimate decision is taken by the central government. It is on the basis of the cadre review done by the Centre that a list of the required number of officers in each service is sent to the Union Public Service Commission (UPSC), a constitutional body that independently recruits the requisitioned number through the

the central government alone. Once their cadres are allocated, officers from the three services proceed for their training, which is given by central training institutions (CTIs) like the Lal Bahadur Shastri National Academy of Administration (LBSNAA), the Sardar Vallabhbhai Patel National Police Academy (SVPNPA), and the Indira Gandhi National Forest Academy (IGNFA). The training given to officers from all state cadres is common, and is imparted through central institutions in order to ensure that all recruits of the AIS are trained uniformly to implement the "national vision" at the ground level from the beginning of service. A short description of the AIS on the government portal "Know India" states: "A common unique feature of the All India Services is that the members of these services are recruited by the Centre, but their services are placed under various state cadres, and they have the

secretariat, who to transfer, who to give plum postings, and who to relegate to unimportant posts. "It is here that states have exclusive powers over an officer. The Centre can never tell the state government where to post which officer at the state level. It is 100 per cent the state's domain," Mishra said.While the transfers and postings of an officer do not affect their salaries, they often act as de facto punishments for officers, disrupting their personal lives and adversely affecting their career growth thereby creating a strong incentive for officers to toe the line of the state government throughout their careers. Any officer who has served in a state government for up to nine years can show their willingness to come to the Centre, through their state governments, at the level of director and above under the Central Staffing Scheme. Their names are then compiled into a consolidated "offer list" through

Xi's aggressive policies

Is it too late to halt the slide towards all-out confrontation between China and the western democracies? An apparently conciliatory speech last week by Xi Jinping led some observers to suggest China's president may want to mend fences. But a change of tone in Beijing will not cut much ice in Washington unless Xi's aggressive policies change, too.Since coming to power in 2012, Xi has overseen a marked shift towards authoritarianism at home and increased "assertiveness" - a polite word for bullying - abroad. He has established the type of personal, almost cultish dominance over the Chinese Communist party not seen since the days of Mao Zedong.So when Xi talks, as he did last week, about the need for arrogant CCP spokespeople and the country's antagonistic "wolf warrior" diplomats to present a more "lovable" and "humble" image of China to the world, he is really critiquing himself and his own management style. Yet Xi has never had to woo ordinary voters. He has purged all serious rivals. He lauds uniformity and exhibits a hatred of "difference", as cruelly manifested in Xinjiang. He rules by fear, political cunning and brute force. Love has nothing to do with it.Looked at another way, Xi's speech would not have been out of place at a Militant tendency meeting circa 1976 or, for that matter, in the old Soviet politburo. Like hard-left politicians and neo-Marxists everywhere, Xi believes it's not his policies that are at fault but a failure to explain and communicate them effectively. China must expand its "circle of friends", he said. "Propaganda organisations" (meaning state media) must make clear to all that the CCP wanted "nothing but the Chinese people's happiness and good fortune". Does he really believe people will swallow such tosh? Coming from a man dedicated to supplanting the US as global hegemon, his words suggest startling naivety about the world beyond China or else a shocking cynicism.Extensive state-directed, under-the-radar schemes to "tell China's story" and expand its influence are in any case already in train, according to the National Endowment for Democracy in Washington. "Over the past decade, the CCP has overseen a dramatic expansion of efforts to shape media content around the world," it said, even as the CCP stifles critical independent coverage. Using propaganda, disinformation and censorship, "Beijing has insinuated its content ... into foreign media markets in many subtle ways, for example, through content-sharing agreements ... Hundreds of millions of news consumers around the world routinely view, read, or listen to information created or influenced by the CCP, often without knowing its origins."Xi's image-massaging and media manipulation went a drastic step further last week as Beijing suppressed coverage of the 1989 Tiananmen Square massacre anniversary. Hong Kong media were told not to mention it. An annual vigil for victims was banned amid yet more arrests. The record of the CCP's historical culpability over Tiananmen was wiped. Yet today's crushing of Hong Kong's freedoms is a very public crime that Xi cannot airbrush away. Lovable it ain't.Blatant and loveless, too, is the siege of Taiwan, where Chinese military forces regularly launch high-profile, provocative territorial incursions. Like a latter-day emperor, Xi sees reunification as the crowning achievement of his reign. The west's shameful failure to defend Hong Kong emboldens him, and fears grow that he may soon resort to force. Taiwan could yet become America's Falklands.All around China's borders, from India and South Korea to Malaysia, the Philippines and Australia, a grim story of intimidation, impunity and aggression is unfolding, as opposed to the confected, made-in-Beijing narrative of neighbourly co-existence. The list of western grievances with Xi's China, often spilling over into undisguised anger, grows longer almost by the day. The problem now - assuming Xi really is having second thoughts - is that it may already be too late. A tipping point has been reached. Tolerance for Chinese boorishness is all but exhausted.Xi may not be able to alter course even if he wants to. For almost a decade, he has unleashed wave after wave of what analyst Sulmaan Wasif Khan calls "belligerent, defensive nationalism" - political, economic and military. China, he wrote, "has poisoned itself through its own rhetoric ... As the US discovered in the Donald Trump years, one cannot stoke nationalistic fires without their eventually blazing beyond control."A reckoning is due. US president Joe Biden has stuck to his predecessor's tough line, and is steadily reinforcing it. This coming weekend's G7 summit will back him up. The Quad - an alliance of the US, Japan, India and Australia - is reviving. Defence spending is rising, on both sides.

Don't reduce the debate to 'Modi is a Fascist' level. India needs better critique of populism

• o understand seven years of the Narendra Modi government and its unique approach to communication, we should begin with a differ-

ent anniversary. A few days from now. it will be two years since a shocking act of vandalism took place in a small island in the Tungabhadra near Hampi: the desecration of Nava Brindavan, the sacred Tulsi-plant bearing shrine of the 15th century Dvaita philosopher Sri Tirtha.Unlike Vyasa many commercialised pilgrimage sites, the Nava Brindavan island is little known outside the Dvaita tradition. For violence to enter a place like this was brutal, a violation not only of cultural sanctity, but of nature too. What makes this site important is not just the monuments, but the fact that the whole valley, with its hills and boulders, still remains as it did for hundreds of years, a sacred geography undisturbed by "development". Greed got here too. The second point of disbelief around this incident, and one that takes us to the issue of communication in the age of Prime Minister Modi, is the way a particular reaction spread on Twitter. Despite the gravity of this desecration, within hours, a cheerful, self-congratulatory tone was on display: Would the rebuilding have happened if "Pappu" been Prime Minister instead of Modi? Could the "new, confident, Hindu" have rebuilt the Brindavan without the inspiration of Modi?Some might say the positive tone averted needless communalism. Yet, a divisive angle was not absent either. Look at us, the tweets went, we don't protest or riot when our sacred sites are violated, unlike... (those people). This sort of boastfulness is now a regular feature of the Hindu response system on social media. Most recently, it was in evidence again when a Charlie Hebdo cartoon mocked Hindu gods over the Covid-19 tragedy in India (We don't behead! We're Hindus!).I share this story because this is one example of what the "on the ground" communication of the movement that has brought Prime Minister Modi to power, and keeps him there, looks like. A few weeks ago, I wrote a sharp criticism in ThePrint of Prime Minister Modi's approach to communication in the face of get how to relate with each other. And a severe national calamity. We are now "always on," seeing and being seen on social media, communicating not for connection, but for image. We write less to share, more to perform. The "gotcha" moment (as it is called in America), or the "befitting reply" (as it is called in India), seems to be the only communication goal of leaders today.We are in a race to extreme isolation and social fragmentation. Every word, every tweet, seems to be oneway, a label or accusation, rather than an invitation to consider. We brand each other as "Right wing" or "Left wing" (and I have to dust off one such awkward label I got last month: how on earth does a columnist for a paper with "Wall Street" in its name get away calling a Hind Swaraj-advocating professor a "Hindu Right" intellectual!). We smear each other as "bhakts" or "antinationals." We call upon friends and family members to perform denunciations. We boast of locking up our elders because they voted wrongly. We are, to put it mildly, being played by the very things we can't stop playing with (the documentary The Social Dilemma is a good, if not perfect, critique for the times). Their books were hardly about Hinduism as we knew it; gods, culture, aesthetics, none of it figured. At best, this was self-help and management for the people, emphasising service and national pride as a method of personal transformation ("man-making"). Their larger political vision, at least in principle, was Deendayal Upadhaya's Integral Humanism, a post-Independence sequel to Gandhi's Hind Swaraj.Unfortunately, we have seen little of Deendayal Upadhyaya besides his name these last few years. The Modi government's attitude to communication instead seems to have, as its guiding aesthetic, a peculiar form of dehumanisation, embodying a cold, objectifying view that reduces human beings to numbers and targets. It does not see people as who they are, but only as either followers, enemies, or future converts. Whether it's called "vikas" or "Hindutva" it still doesn't augur well. India seems to be ruled by a technocracy that supporters think is morality and its opponents think is religion. The BJP has done well so far running with the hares and hunting with the hounds on the question of Hinduism, but eventually, the questions must be answered. What does Hindutva mean to it, an indigenous vision of decolonisation or mere copycat Right-wing nationalism? How does the BJP expect to address the disappointments of Hindus fighting off the State's destructive intrusions into sacred spaces from Kerala to the Himalayas? Does it intend to ever win the trust of opponents when it keeps throwing them to the Twitterhounds?For now, the BJP seems to have settled on presenting itself as "RW" rather than "Hindu" (possibly tiatives, this government seems out of because it mistakenly sees the former world), and its critics still seem stuck on the belief that a criticism of the BJP is best made not for its "RW"-isms but simply for its "Hindu" associations. These are the limits to our political discourse, and to our ability to see across the "befitting reply" divides of social media. Chhattisgarh's Sukma district has become a point of serious clash between the administration and tribal leaders, with the police asserting its right to set up a joint security forces camp in the area even as locals continue to protest it. The battle comes after the Chhattisgarh Police established a joint camp - comprising the Central Reserve Police Force (CRPF), District Reserve Guard and CoBRA personnel - in the village on 11 May. The strength of the camp is estimated at roughly 130. The locals started protesting against it almost immediately, calling it illegal.On 17 May, four protestors were killed in a police firing incident at the site. While tribal leaders said the dead were locals and called for a high court justice-led probe, the police said they were Maoists.Now, officials heading the anti-Naxal operations in Bastar region told ThePrint that the protests are stage-managed by the Maoists as Silger is a strategically crucial location for the administration to take the Maoists head-on, with the village serving as a gateway to barge into

Mumbai, June 07 : Nikhil Kamath, co-founder, Zerodha & True Beacon, asserts nobody can predict market trends, says bias behind low trading participation in India, believes cryptocurrencies will see a fightback from authorities, and says the govt appears to have been surprisingly ill-prepared for the second Covid wave. The session was moderated by Principal Correspondent Aashish Aryan.Would you credit the Internet which brought a large number of small retail investors online for the success of platforms such as

Zerodha?Internet trading existed before we (Zerodha) came about. Back in the day, we used platforms such as Sharekhan and ICICI Direct. So we did not really create Internet trading in India. We kind of made it cheaper and more efficient and transparent. The ecosystem of broking, stock market, equity market has been the flavour of the season and we have been talking about it a lot more in the last one year. But you have to remember that it is a very, very small ecosystem. Only about 1.5% or 2% of the population of our country has direct or indirect access to financial markets. Now, that number in the West, say in America, stands at 60-70%. So even though the ecosystem is growing exponentially, and a lot more people are joining it, the base is extremely small. Even if you were to talk in terms of revenue, and in terms of the total number of brokers and companies which cater to this industry, it is a very nominal number. Majuli may not get Unesco's

requested them to take necessary steps to expedite the matter. The committee has also sent a letter to the government seeking a status report on the initiatives taken to prepare the dossier, which is like a conclusive documentary of the island. "Besides raising our demands before the chief minister and the local MLA, we sent a letter to the government seeking a status report on the matter. But we are yet to receive any response from the government in this regard so far," said Jagat Hazarika, a social worker and convener of the committee on Sunday. Hazarika, a former secretary of Majuli Suraksha Samannaya Mancha, an organisation formed for protection and development of the river island, said: "The Government of India will have to submit the dossier by June 20. Sadly, nothing has been done in case of Majuli so far. Although the demand to make Majuli a world heritage site has been made since 2000 and nomination dossiers were submitted to the Unesco in 2006, 2012 and 2014. Majuli will be deprived of getting the global recognition once again due to lapse on part of the government."Majuli was shortlisted in the world heritage site tentative list at the world heritage committee session at Suzhou in China in 2004. Subsequently, a comprehensive dossier was submitted in 2006 followed by additional information in 2008. In 2011, the Centre proposed the name of Majuli for its inclusion in the 'cultural landscape' category of Unesco world heritage site. The government along with the Archaeological Survey of India had also appointed a conservation architect as the man to prepare the nomination dossier for the proposal which was submitted to Unesco in February 2012. In 2017, the culture ministry decided to send the proposal for Majuli's inclusion to Unesco. Earlier, the government had also formed Majuli cultural landscape management authority in 2006. Majuli is located in the middle of the Brahmaputra river. In 2016 it was declared as a district of Assam and became the first island district in the country. According to official records, Majuli originally spread over an area of 880 square km at the beginning of 20th century. However, over the years, due to severe erosion and deforestation, the island's size shrunk to about 400 square km by 2014. Majuli is the seat of neo-Vaishnaviate culture initiated by reformist saint Srimanta Sankardeva and his disciple Madhavdeva in 16th century who established about 70 Vaishnaviate monasteries. Majuli is the hotspot of flora and fauna and a popular tourist destination.

CM reviews activities of Agriculture department

CM directs to draft guideline for a mission in agriculture sector



Guwahati, June 7: Chief Minister Dr. Himanta Biswa Sarma reviewed the activities of the Agriculture department in a meeting held at his office in Janata Bhawan today and made several directions to rejuvenate the agriculture sector in the State. The Chief Minister instructed the officials to draft a guideline for a mission to be launched in the agriculture sector similar to Sarva Shiksha Mission (SSA) or National Health Mission (NHM) with a view to give a renewed stimulus to the agriculture sector. He also directed to transfer all Agricultural Development Officers who have completed three years of service in a particular place of posting. Further to ensure supply of quality seeds to the farmers of the State, Chief Minister Dr. Sarma asked the department to procure seeds directly from the seeds corporations of the best seeds producing States. The Chief Minister also suggested steps for a comprehensive survey to assess the scenario of agricultural produce in 3000 village panchayats and VCDCs involving the students of Assam Agricultural University, Gauhati University and Dibrugarh University. Moreover, the Chief Minister directed to take needful steps for making the list of beneficiaries of PM Kishan Scheme error-free so that genuine farmers could avail the benefits of the scheme. He also asked the department to initiate stringent action against those involved in the irregularities of fertilizer supply. Underlining the potential of horticulture products of the State, Chief Minister Dr. Sarma instructed the department to take steps for promotion of horticulture products which have rich export potential and market value. Agriculture Minister Atul Bora, Additional Chief Secretary Ravi Shankar Prasad, Principal Secretary to the Chief Minister Samir Kumar Sinha, Secretary cum Director of Agriculture Vinod Seshan, CEO of MMS-CMSGUY Anant Lal Gyani were present in the meeting among others.

Choksi, accused in the Rs 13,500 crore Punjab National Bank scam, got interim relief from immediate repatriation to India by the Dominican court which adjourned the matter of his detention on Thursday. As the next date of hearing is yet to be fixed, the court proceedings are likely to take time. According to local media reports, his team of lawyers connived with the opposition leaders to pressure the judiciary, which rather than questioning Choksi's illegal entry from Antigua to Dominica, believed his lawyers' version that he was abducted.Reports about Choksi's plan to escape to Cuba have also come to the fore. It may be recalled that Choksi and his nephew Nirav Modi are accused in the Rs 13,500 crore Punjab National Bank loan fraud case. Choksi fled the country and was granted citizenship of Antigua and Barbuda in January 2018. He is involved in a legal battle to prevent his extradition to India. Choksi had gone missing from Antigua on May 23 after going out for dinner and was soon caught in Dominica. He was charged with illegal entry by the police in Dominica after he allegedly escaped from Antigua and Barbuda in a possible attempt to evade extradition to India.

Heavy rainfall in upper catchment has resulted in huge inflow in all the rivers of greater Lakhimpur area in recent days. On June 5, 2021, due to flash flood in the upstream reaches of Ranganadi, in a span of one hour, the water inflow at Ranganadi increased from 91 cumecs at 1 pm to 420 cumecs at 2 pm, it said."After utilizing the full handling capacity of the reservoir, the remaining water was released into the river as per the Standard Operating Procedure (SOP) and observing full safety protocols and downstream warnings," NEEPCO claimed."The district administration was alerted instantly. Flood warning and alert system devised through the North East Space Application Station (NESAC), ISRO, Government of India is in use at the plant," NEEPCO official Bharali further said. 204 more fresh COVID cases detected in Nagaon dist

NAGAON, June 7: Total 204 more fresh COVID cases were detected today here at Nagaon, taking the total cumulative active COVID cases to 3774 while 424 people who were undergoing treatment in hospital as well as at home after being affected by the virus, have been recovered from the infection today, sources added. Sources claimed that among those who tested positive today, 96 were immediately admitted to Nagaon COVID hospital as well as other COVID Care Centres set up at various places in the district while the rest were put in home isolation. Rapid Antigen Test was conducted on 5742 people today while RT-PCR test was conducted on 232 swab samples, sources further added.Meanwhile the district administration today scheduled two vaccination camps on June 9 next at Nagaon Dawson HS and Multi purpose School and Haiborgaon High school respectively for those people who took the first dose of Covaxin on or before April 16, 2021 last in the district. Besides, the schedule for the second dose of Covaxin for the people who took the first dose on April 17 or thereafter will be intimated to all later on, a press release issued by district information and public relations office, Nagaon stated. In the release, it was also stated that people who were vaccinated on April 17 or thereafter, were requested not to crowd unnecessarily at those two vaccination camps on June 9 next.

AIIMS Delhi starts screening children from Monday for Covaxin trials

New Delhi, June 07: The All India Medical Institute of Medical Sciences (AIIMS) is expected to start screening of children for clinical trials of India-made Covid-19 vaccine Covaxin from Monday. Last week, AIIMS Patna started a similar trial for Bharat Biotech's children aged between 12 and 18. After getting permission from the Drugs Controller General of India (DCGI), AIIMS Delhi is now starting the screening process before starting the actual trials. The DCGI's approval came after a recommendation on May 12 by a Subject Expert Committee (SEC), it further reported. The paediatric trials for Covaxin started in AIIMS Patna last Tuesday after Bharat Biotech's vaccine received DCGI nod on May 11 to conduct clinical trials on children."After these trials, the age group will be 6-12 years and then 2-6 years but now we have started trials in the age group of 12-18 years," said Dr Prabhat Kumar Singh, Director, AIIMS, Patna.Dr Singh informed that 54 children registered for the trials of which 16 were in the age group of 12-18. Apart from physical examination, RT-PCR tests were also conducted on these children to check for Covid-19 antibodies or any other pre-existing diseases, he added.India started the world's largest vaccination drive on January 16 this year in a phased manner with healthcare workers getting inoculated first. The vaccination of frontline workers started on February 2. The next phase of Covid-19 vaccination commenced from March 1 for those over 60 years of age and for people aged 45 and above with specified co-morbid conditions.

Sifan Hassan smashes women's 10,000m record by 10 seconds in super spikes

London, June 7 : The game-changing effect of super spikes on track and field was again dramatically emphasised in Hengelo on Sunday as Sifan Hassan obliterated the women's 10,000m record by more than 10 seconds.On a day when Britain's Dina Asher-Smith ran a meeting record of 10.92sec in the women's 100m, it was the Dutchwoman who stole the show in front of her home fans. The 28-yearold Hassan, who appeared to be wearing the latest version of the Nike ZoomX Dragonfly spikes, which have been billed as the "fastest shoes ever", ran 29:06.82 to destroy the previous best of 29:17:45

get for a record.Hassan, who was trained by Alberto Salazar until the controversial American coach's four-year doping ban in 2019, has always maintained she was a clean athlete and believed in him. Salazar, meanwhile, is appealing against his ban.Later in the afternoon Asher-Smith also looked impressive as she breezed to victory in the women's 100m at the Continental Tour event. The 26-year-old, a silver medallist at the 2019 world championships, clocked 10.92sec in Holland, not only breaking the meeting record but well inside the Olympic qualification time of 11.15.Britain's Dina Asher-Smith (right)

She now owns world records for the mile, road 5km, one hour run and the 10,000m - as well as 1500m and 10,000m world titles."Wow, to run this world record here today in Hengelo is something I could only dream of," said Hassan, who achieved her latest world record on the same track where Haile Gebrselassie set his final 10,000m world record in 1998 and Kenenisa Bekele set his 5,000m world record in 2004."It's the perfect confirmation of the hard work we've put in getting ready for Tokyo. I am so happy to share this record in front of my Dutch fans. I am so happy."In 2019 World Athletics introduced new rules for track spikes, limiting the use of plates and restricting the sole to no thicker than 30mm. However they have had little effect. All four men's and women's 5,000m and 10,000m world records have been broken over the past 10 months. Athletes have also benefited from pacing lights on the track, which allows them to see whether they are on tarin the Diamond League at Gateshead International Stadium in May 2021. She has just set a 100m meeting record in Hengelo. There was a slight tailwind, but Asher-Smith looked to have plenty left in the tank, finishing ahead of rivals Dafne Schippers and Blessing Okagbare and setting a meeting record. Britain's Daryll Neita was third with a personal best 11.04."It's amazing to be back here in Hengelo," Asher-Smith said. "I remember when I raced Dafne here in 2015. It was my first ever race breaking the British record and I'm really happy to have broken the meeting record. It's so nice to have real people back at a track meet."There were also wins for Britain's Jemma Reekie in the women's 800m and Jake Wightman in the men's 1500m.Reekie took it out from the front to win the 800m in 2:00.77 to hold off her fast-finishing training partner Laura Muir. Meanwhile Wightman looked highly impressive as he broke clear with 200m to go to win in 3:34:67 from Abel Kipsang.Meanwhile the world pole vault record holder Mondo Duplantis cleared 6.10m in a highly impressive display, although he was unable to set a world record after failing three times at 6.19m.
