Guwahati, June 9 : A group of miscreants misbehaved and assaulted officials of the Guwahati Municipal Corporation (GMC) in a city neighbourhood creating hindrance in the lawful discharge of duties by public servants. Body found floating Guwahati, June 9: The

body of a man was found floating in the Darika river at Kukura Pohia in Assam's Sivasagar district on Wednesday morning. Locals spotted the body early in the morning and informed the police. The deceased was identified as 37-year-old Sanjeev Bora by his family members. Soon district magistrate Rantu Baruah along with a team of police officials arrived on the spot. The body was retrieved from the water and sent for autopsy at the Sivasagar Civil Hospital, the report of which is awaited.Bora was a resident of the Habiram Bora Path in Sibasagar town. According to family members, the victim had been missing from about 4 pm on June 5. They also suspected foul play into the incident, claiming that Bora had been murdered. The police have however, started investigations into the incident.

Guwahati, June 9: Indian Institute of Technology Guwahati, one of the premier educational and research institutes across the nation, has broken into the top 50 institutes and secured 41 st rank globally (56 th in 2021) in the 'Research Citations per Faculty' category, of the QS World University rankings 2022 announced today, 8th June 2021. Along with this, the Institute has gained rank 395 in World University Ranking globally. This marks an huge improvement of 75 places by the IIT Guwahati, which was ranked 470 in the 2021 edition of the QS World University rankings. The main reason for this increase is the strong improvement in the 'Citations per Faculty' category where IIT Guwahati has improved from 77.9 in the year 2021 (Global Rank 56) to 94.8 in 2022 (Global Rank 41). 'Bring them home': fresh calls for release of family in Australian detention centre

has spent nearly her entire life in Australian immigration detention facilities has galvanised opposition to the country's offshore detention system. Tharnicaa Murugappan was evacuated to a children's hospital on Monday where she was diagnosed with a blood infection and pneumonia, which she contracted on a remote island detention centre. Tharnicaa was born in Australia but for more than three years the government has held her in detention as it fights deport her and her family. Known by many in Australia as the "Biloela family" - named after the regional Queensland town that welcomed them and campaigned for their release - they have been held in some form of detention for more than 1,000 days. Tharnicaa's parents, Priya and Nades, fled the Sri Lankan civil war and had been living in the Queensland town until 2018, when the Australian government contacted them. For the past three years, the authorities have been attempting to deport Priya, Nades, Tharnicaa and her sister Kopika, who is five. During this period, the two sisters have lived in detention and guards take them to school. The residents of Biloela say they want the family to return, and have called on immigration ministers to release them. Advocates, lawyers and other politicians have repeatedly said the minister for immigration could release the family of four "with the stroke of a pen". None have done so.On Monday, Tharnicaa was airlifted to Perth children's hospital from the detention centre on Christmas Island.Doctors in Perth diagnosed her with a blood infection from suspected untreated pneumonia. She had been sick for 10 days - her symptoms include fever, dizziness and vomiting - without adequate medical care. Her father and sister were not allowed to travel with her. No child's suffering is worth any Prime Minister's ego or stubbornness. The latest development in the family's saga has reignited opposition to their detention. A friend of the family, Angela Fredericks, told the Australian Broadcasting Corporation her "blood was boiling" as she heard how the family pleaded to have Tharnicaa taken to hospital. Politicians from the opposition Labor party and the Australian Greens have repeatedly called for the family to be released. The children have had health issues since they were first housed in the detention three years ago. Tharnicaa and Kopika became vitamin D deficient months after moving there. after being allowed outside for only half an hour a day. When Tharnicaa was two, some of her teeth rotted and she needed surgery to have two removed. Before their detention, Priya and Nades lived in Biloela for three years. Nades worked in an abattoir and volunteered at a local charity. Tharnicaa and Kopika were born in Australia. In 2018, Priya and Nades's claims for refugee status were rejected and the Australian Border Force placed them and their children into detention. In 2019, the family was onboard a plane deporting them to Sri Lanka when a last-minute legal victory found that the

But instead of returning them home, the government placed the family in indefinite detention as they considered the next legal move. Christmas Island formerly housed thousands of refugees and asylum seekers, who were held there after successive Australian governments declared that nobody who arrived by boat, including refugees fleeing persecution, would be allowed to settle in Australia. The detention centre closed in 2018 but it was reopened the following year. For the past 18 months, it has housed only Tharnicaa and her family.

Emmanuel Macron slapped in the face during walkabout

Paris, June 09: Emmanuel Macron was slapped in the face by a man during a walkabout in southern France.The president's security detail immediately pulled the man to the ground and moved Macron away from the crowd, though the president appeared unhurt and determined to continue meeting the public. A video of the incident showed the president, in a white shirt and tie, approach onlookers waiting behind metal barriers

at Tain-l'Hermitage in the Drôme department.Macron, wearing a mask, is seen reaching out to shake hands with a man in a green T-shirt wearing glasses and a mask.Reuters reported the man was heard shouting "à bas la Macronie" (down with Macronism) before he grabbed the president's right arm and delivered a slap to the left side of his face. He was also reported to have shouted "Montjoie Saint Denis", the battle cry of the French armies when the country was a monarchy. Two people have been arrested in connection with the assault, according to reports, and are being held for "deliberate violence against a person of public authority". The French prime minister, Jean Castex, said the incident was an

The Meteorological Department has also issued an orange alert for Mumbai, Thane, Palghar and Raigad on Saturday. In view of this, people have been evacuated from the coastal areas. The fishermen have also been instructed to stay away from the sea. The Meteorological Department says that the first monsoon rains in Mumbai will be very strong. There was heavy rain

in Mumbai and adjoining areas even today. Due to heavy rains, many lowlying areas were flooded.As per the Regional Meteorological Centre (RMC) in Mumbai, up to 30 mm rainfall was recorded in areas like Malvani, Borivali and

Earlier, the India Meteorological Department (IMD) on Saturday confirmed the arrival of the southwest monsoon in Maharahtra, when it had reached up to Harnai port in coastal Ratnagiri district.But, despite favourable conditions, the monsoon has still not progressed to Mumbai. When contacted, Shubhangi Bhute, director at the RMC Mumbai, termed the present rainfall in the city as "convective precipitation". "You can observe that there is thunder, lightning and a constant variation in the intensity of the showers. You can call it pre-monsoon showers, but certainly not the south-west monsoon," she said. There are no indications of the onset of the monsoon here as yet, the official said."There has to be less variation and rains have to be widespread (to be called as monsoon showers). Apart from Mumbai, there should be rains over central Maharashtra also. Then only we can identify it as the southwest (SW) monsoon, she said. warned that US tech companies, including Google, Amazon and Facebook, could pay less tax in the The tax was launched last year as a UK and several other big economies under global reforms agreed at the weekend by the G7.In a key stumbling block emerging days after the landmark deal, research from the TaxWatch campaign group indicates that the UK Treasury accounts of each company for 2019, stands to lose about £230m from the taxes paid each year by the four big US technology firms. The study estimates that Facebook, Google, eBay, and Amazon, contribute about £330m between them to the UK's

So under pillar one, the UK should receive a portion of the tax generated in the country by Apple and Facebook. A mechanism for redistributing the profits of the largest companies is under discussion. A list of 100 companies whose profits could be divvied up in this way was presented at the G7. The list remains confidential, though is understood to include tech companies, but not banks or extractive firms such as mining and oil groups. The redistribution mechanism would apply to companies with "superprofits" - profit margins exceeding 10% of revenues.



'We were deceived': hundreds protest in Venice at return of giant cruise ships

London, June 09: Anti-cruise ship that cruise ships would be campaigners in Venice claim they were "deceived" by the Italian government as hundreds protested against huge vessels docking in the historic city's port on Saturday. Residents were caught by the industrial port of Marghera surprise on Thursday when a cruise liner sailed into the lagoon city for the first time since the pandemic began, despite prime minister Mario Draghi's government declaring that the ships would be banned

"So you would need to dredge the canal in order for that to happen, which would be even more devastating for the equilibrium of the lagoon."Cacciari added: "The aim of this protest is to make the government realise and explain - the whole world reported on this story - and yet here the big ships are again. It's shameful."Elena



Riu, a Venice resident, said: "It doesn't surprise me as we're used to declarations coming to nothing. But more than anything it makes me angry as we've had all this time during the pandemic to reflect and come up with something better. Instead, nothing has changed."Tourists have started to fill the narrow lanes of Venice again after coronavirus travel restrictions were eased in mid-May. Before the pandemic, the city hosted an estimated 28 million visitors a year. Cruise ships have always been a bone of contention in the city, with those against them arguing that they have damaged the lagoon and eroded the foundations of buildings in the Unesco world heritage site. But the travel and cruise industries have also contributed to the local economy - around 5,000 people are usually employed at Venice's cruise terminal.

Surge in hospital cases

Anew coronavirus variant that was first sequenced in India has been doubling about every eight days in England since early April. The Delta variant is now dominant in England, and according to a recent risk assessment from Public HealSth England (PHE), it has a substantially increased rate of transmissibility compared with the previously dominant variant Alpha, which was first sequenced in the UK. Having just a single dose of vaccination is less effective against Delta, and it may lead to a surge in hospital cases. We always knew variants were a risk to England's roadmap out of lockdown. In January, the science advisory group Sage warned that England's red-list border policy of "geographically targeted travel bans" was unlikely to keep new variants out, not least because we didn't know where the next one would come from. England spent the winter trying to keep out the Beta variant, first sequenced in South Africa, and the Gamma variant, first detected in Japan in travellers from Brazil. The effort mostly succeeded, but the government's red-list policy entirely missed the rise of a dangerous new variant in India. India, a country with close travel links to the UK, first reported a concerning new variant on 24 March. Cases had more than doubled in the country over the preceding two weeks. On 9 April, the UK put Pakistan and Bangladesh on its travel red list, but despite mounting cases and a concerning new variant, India wasn't included. It finally added India to the red list on 23 April. Imported cases dropped soon afterwards, but the damage was already done. The new Delta variant has mutations that are associated with vaccine resistance - so why didn't PHE immediately escalate Delta to a variant of concern in March? Part of the reason was a lack of firm evidence showing the new variant was more transmissible, more severe or more vaccine resistant. Yet, as the scientific adage puts it, "the absence of evidence is not evidence of absence". Establishing the evidence takes weeks of careful science. If a variant is spreading rapidly, the answer isn't to wait, but to act decisively and quickly.In a document prepared for Sage on 11 May, researchers highlighted the risk that incontrovertible evidence showing Delta was more transmissible "may come too late". "In the face of uncertain evidence," they warned, "the risk of overreacting seems small compared to the potential benefit of delaying a third wave until more people are vaccinated."Their concerns were justified. In early April, the Delta variant accounted for 0.2% of sequenced cases in England. Two weeks later, this had grown to more than 3%. By 15 May, a mere seven weeks after the variant was first identified in England, it accounted for 38% of sequenced Covid-19 cases. Many explanations for its spread were offered: it was mainly among travellers; there was something unique about the communities where it was spreading; we couldn't infer anything from rapid spread in India because the country's sequencing was poor or its situation did not translate to ours. Moreover the continued decline in the previously dominant Alpha variant masked the rise of Delta: people could point to overall case numbers as proof that there was nothing to be concerned about. In fact, we were living through two epidemics - one declining and one rising. This was obvious to anyone watching the relentless exponential growth of Delta during April.By the middle of May, after PHE eventually escalated Delta to a variant of concern, members of Sage were becoming extremely worried. Modelling from a Sage subgroup showed that a variant that was 40% more transmissible than Alpha could cause a huge surge in hospitalisations - even if vaccines were still effective against it. Delta may be 50% more transmissible than Alpha, according to Sage minutes from 13 May. The scientific group warned that progressing to step 3 of the roadmap on 17 May could result in a January-level surge, and that the principles of "earlier, harder, broader" responses were key. Sage could hardly have been clearer about its serious concerns, but the government went ahead with plans to loosen restrictions. Almost all indoor spaces were opened up on 17 May, indoor mixing of households was allowed and mask mandates dropped in secondary schools. Meanwhile the Delta variant continued its remorseless rise. By the week of 22 May, it comprised nearly 60% of sequenced cases in England, with new hotspots emerging in Bolton, Blackburn and Bedford. Firm evidence of the dangers posed by the Delta variant has now been established, but not in time for us to prevent its dominance. Meanwhile new research from the Francis Crick Institute shows that protection from two doses of the Pfizer vaccine may wane significantly against the Delta variant after a few months and in older people. Our most vulnerable populations are just now reaching the three-month post-second dose milestone. Through its poorly applied border policy, England managed to keep out the Beta variant but let in an equally resistant, more transmissible and more severe distant cousin. The new dominance of Delta is already making itself felt. Cases in England soared in the week prior to 4 June. There have been many headlines warning of the start of a third wave - but in truth, the third wave started eight weeks ago, when Delta began its march to dominance. The lessons are clear. We have a leaky and inefficient border policy. As so many times before, the government did not act on early signs of exponential growth. Every week I've become more alarmed by the growth of the Delta variant. Three questions remain: given the evidence we finally now have, will the government act to curb spread?

ULFA, nsurgency And Prospective Peace Talks

young Assamese nationalists as sembled at Ranghar, the historical monument of Ahom rule in Sibsagar district and formed an organisation named as United Liberation Front of Assam, (in short ULFA) and launched an armed movement with the demand of sovereign Assam for the indigenous Assamese people. The members in the organisational structure of the militant group, to name a few were : Paresh Baruah - Commander in Chief, Raju Baruah - Deputy Commander in Chief, Arabinda Rajkhowa - Chairman, Pradip Gogo - Vice Chairman, Anup Chetia - General Secretary and some others. Throughout the long years till the day many people lost their lives in ULFA's militant activities. In 1990, the Government of India banned the organisation, citing it as a terrorist organisation. The organisation involved in many cases of abduction, extortion, assassination and bombings in Assam. They had reportedly established training camps for their cadre in Kachin of Myanmar and also in Bhutan and Bangladesh. Since 1990 various army operations were launched against ULFA, the Operation Bajrang (Nov.27,1990), Operation Blueprint(June,91), Operation Cloudburst (Sept.,91), & Operation Rhino (Oct,.2001). In Operation Bajrang, reportedly 15 cadres were killed, 1,208 weapons & Rs 5 Crore seized and many arrested. In Operation Rhino (1990). In 1991 in a controversial encounter with Army ULFA's Dy Commander in Chief Hirak Jyoti Mahanta was killed.. In December 2003 & January 2004 there had been military operations against ULFA jointly by Indian army & Royal Bhutan army in southern regions of Bhutan and destroyed ULFA encampments for training to their cadres. Reference may be made of ULFA's seniormost octogenarian leader and political Advisor Bhim Kanta Buragohain @ Mama who was regarded by ULFA as its Godfather, was arrested during an operation and later died on 19 December 2011 in cardiac arrest while on bail granted by court. Another top ranking ULFA cadre Ashanta Baghphukan, organising secretary had gone missing since

2003 army operation in Bhutan. Back in September 8, 2005, ULFA constituted the People's Consultative Group (PCG) comprising of 11 elite members pursuing different professions, believed to be ULFA sympathisers, with the objective to work out the modalities of the peace talks and play the role of a mediator between the ULFA and the Central Government. Some The 11 member PCG included the following members headed by Jnanpith Awardee literateur Mamoni Raisam Goswami as the Chief Interlocutor.

On September 11, 2005 just after three days of its formation, the PCG launched a statewide opinion sharing campaign through letters, SMS, fax and email. It appealed to the then Chief Minister, Tarun Gogoi to expedite the peace process. In September 14, 2005 in an operation of security forces 12 ULFA cadres were killed in upper Assam affecting the peace initiative. On November 5, 2005 the group launched a campaign rally in Nalbari seeking an immediate end to army's counter insurgency operations. The PCG with its genuine sincerity could have initiated a fruitful peace talks between the ULFA and the government. had it not been dissolved by the ULFA Chairman Mr Arabinda Rajkhowa in February, 2011.

However the peace talk process was carried forward by the pro-talk ULFA wing under the leadership of its Chairman after the PCG was dissolved. The pro-talk ULFA cadres, who were Central Committee members. and who had either surrendered or arrested by security forces and are facing criminal charges in the court. They are Mr Arabinda Rajkhowa - Chairman, Pradip Gogoi - Vice Chairman, Anup Chetia -General Secretary, Chitrabon Hazarika - Finance Secretary, Sashadhar Chowdhury - Foreign Secretary, Mithinga Daimary - Central Publicity Secretary, Smt. Pranati Deka - Cultural Secretary and others. The Central government in June 2010 appointed Sri P.C. Haldar IPS as the interlocutor who had served till December 31, 2015. In 2017, Government appointed Dineswar Sharma, the Ex-Chief of the Intelligence Bureau as interlocutor for peace talks with Assam's insurgent groups including ULFA for a tenure of one year. Dineswar Sharma having been transferred as the administrator of Lakshadweep, in January 2018 A.B. Mathur IPS, former Special Secretary of the Research and Analysis Wing (R&AW) was appointed as the Interlocutor for talks with ULFA. There was reportedly split in the organisation in 2011, between the overground faction led by Arabinda Rajkhowa and Paresh Barua's underground faction. Though Rajkhowa faction had been holding talks with the government through interlocutors in fits and starts the talks could not and also would not have merited any result without the participation of ULFA;s Commander in Chief Mr Paresh Barua. In February, 2020, Mr Rajkhowa urged that formal process to initiate peace talks should start without any delay. He expressed his belief that talks over Paresh Baruah's single point agenda would be possible on the negotiation table if the Prime Minister and the Chief Minister take special initiative for taking up his single point agenda for talks. From Rajkhowa's In an answer to a Rajya Sabha question asking the latest position of the peace talks being conducted between the central government and the United Liberation Front of Assam, the Home Ministry stated in March, 2021 that the process of peace talks with the United Liberation Front of Assam is an ongoing process. However, the has said on January 29, that the banned rebel group would join talks with the Centre only if sovereignty is included as the main agenda for talks. While secession from India has been ULFA's declared goal, it has also consistently stood against the issue of illegal migration, which remains a hot button issue in Assam, with AASU and the regional political parties the Asom Gana Parisad and the newly formed Asom Jatiya Parisad. ULFA has also been raising voice against the Armed Forces Special Powers Act, 1958 (AFSPA) that grants special powers to the Indian Armed Forces to maintain public order in disturbed areas in which Assam included. In spite of a series of talks held between government and Arabinda Rajkhowa faction of ULFA by the government appointed interlocutors since 2010 onwards, nothing has been disclosed to the public about the progress of peace talks. We are constrained to belief that no any headway has been made between the Arabinda Rajkhowa faction of ULFA and the Central government till this day. The Government is also to be blamed for its lackadaisical attitude to solve the ULFA problem. When government has been offering hospitality

Raikhowa led Protalk ULFA faction for a decade now, why government failed to pressurise the said faction to persuade Mr Paresh Barua to come to the negotiating table? The attitude of the BJP government for solving the problem for the last five year term was no different with the earlier Congress governments in the State.

While speaking of the main demand of ULFA for a sovereign Assam, reference must be made of some other tribal insurgent groups for creation of either sovereign State or Autonomous State within the Indian federation. In 1966, the Bodo tribe formed the 'Plains Tribal Council of Assam' (PTCA) and demanded a separate Union Territory 'Udayachal'. From Seventies, the All Bodo Students Union (ABSU) had their slogan-divide Assam 50-50, demanding half of Assam's territory for Bodos only. Their agiation was marked by violent activities with crimes like arson, abduction, extortion, mass killing in bomb blasts, damage to public properties etc. In the later period more militant organisations like Bodo Liberation Tigers (BLT) and the National Democratic Front of Bodoland (NDFB) took birth. The militant organisations' main objective was gain independent nation for Bodos. The NDFB which was formed in 1989 carried out a series of bomb blast operations in different parts of Assam including Guwahati city in which many innocent people lost their

The government of India with an endeavour to bring peace signed three accords so far with the Bodos. The first Bodo accord was signed with the All Bodo Students Union (ABSU) in 1993, leading to the creation of a Bodoland Autonomous Council (BAC). The second accord was signed in 2003 with BLT which led to the creation of Bodoland Territorial Council (BTC) in Assam. As for the 3rd Bodo accord, it was on 2nd January 2020. all factions of the NBFB together with ABSU signed a peace accord with the Centre and the State government, following which about 1,615 cadres comprising 836 members of NDFB(P), 579 of NDFB(RD) and 200 of NDFB(S) laid down their arms at an event held at Guwahati. Sequel to the agreement, the Bodoland Territorial Area District (BTAD) has been renamed as Bodoland Territorial Region (BTR). Their long standing demand for a sovereign State remained unmet. As a part of the agreement the Bodos would get more political and economic benefits from the Centre. While addressing a celebratory rally at Kokrajhar, the Hon'ble Prime Minister Narendra Modi announced a Rs 1500 crore package for the Bodo areas. Sri Pramod Boro has been elected the Chief Executive Member of the Bodoland Territorial Council after his party the United People's Party Liberal (UPPL) emerged victorious in the election in BTR.

In Kabi Anglong also there was armed movement by several terrorist groups. In March 1999 with the merger of two terrorist outfits, the Karbi National Volunteers (KNV) and the Karbi People's Front (KPF), the United People's Democratic Solidarity (UPDS) was formed. On May, 23, 2002 the outfit led by Kiri Rongphar signed an agreement with the Union government for one year. This agreement led to a split in the UPDS into pro-talk & anti-talk factions. On 16 May, 2004, the antitalk faction of UPDS renamed itself as the Karbi Longri N.C.Hills Liberation Front (KLNLF). The group was operating its inurgent activities in Karbi Anglong & Dima Hasao districts of Assam. Its declared objective was self rule for the Karbi people. In November 2011 the UPDS gave up arms and signed a tripartite Memorandum of Settlement with the Centre and the Government of Assam, settling for enhanced autonomy and special package for the KAAC. The then General Secretary of the UPDS, Horen Sing Bey has later joined the BJP to become an MLA. As of 14 December, 2014 the UPDS has formally disbanded itself following the mass surrender of all its leaders. On February 23, 2021, 1,040 militants of five militant groups Karbi People's Liberation Tiger (KPLT), People's Democratic Council of Karbi Longri (PDCK), led by its Chief Songbijit Ingti Kathar, Karbi Longri N.C.Hills Liberation Front (KLNLF), Kuki Liberation Front (KLF), and United People's Liberation Army (UPLA), surrendered before the then Chief Minister Sarbananda Sonowal, and ceremonially laid down arms depositing 300 weapons and 11,203 bullets, at an event in Guwahati. These outfits' core demand was for a separate State. After the surrender of the militant groups a Karbi Anglong peace treaty is in the offing.

The insurgent group Dima Halam daogah (DHD) is the break away group of Dimasa National Security Force which ceased operations in January, 1993. The DHD was launched by its Commander in Chief Jewel Garlosa. After the peace agreement between the DHD and the central government in 2003, the group broke out into two factions- the DHD(Jewel), also known as Black Widow & DHD(Nunisa).

n the 7th of April, 1979, a group of Commander in Chief of ULFA Paresh Barua The Black Widows declared objective is to creat Dimaraji for the Dimasa people in Dima Hasao district only, whereas DHD (Nunisa faction)'s objective is to include parts of Karbi Anglong, Cachar, and Nagaon districts in Assam, and also sections of Dimapur district of Nagaland. Its Chairman is Dilip Nunisa. The DHD(J) surrendered en masse in 2009 to police with about 364 cadre strength along and deposited a huge quantities of sophisticated arms like 37 AK seies rifles, 10 M-16 rifles, 11 US Carbines etc. On October 8, 2012 the historic Dimasa Accord was signed between the Central government, State government and the two factions of DHD. Pesently, the Dima Hasao district is being administered by Dima Hasao Autonomous Territorial Council.

Apart from the autonomous councils stated above, the State government in a bid to placate some tribal groups which were supposedly discontented for being deprived of equitable benefits of government's various developmental schemes, constituted six numbers of autonomous councils such as the Rabha Hasong Autonomous Council, Mising Autonomous Council, Tiwa Autonomous Counci, Deori Autonomous Council, Thengal Kachari Autonomous Coun-

To speak the truth the autonomous councils have not been able to do a little for the development of the tribal groups due to malfunctioning of the councils and mismanagement of the government funds made available to the councils. In another move to placate three of the six agitating groups for scheduled tribe status, the State government announced the formation of three autonomous councils for Koch-Rajbangshi, Moran and Matak communities, just before the Assam Legislative Election process was started. It is quite uncertain how much time it would take for the newly announced autonomous councils to be functional. It is feared that it may take another five year Assam Assembly term or more than that as legal complexities may come to surface in constituting the councils for hitherto non tribal communities.

Coming to the initiation of peace talks with ULFA, in response to an appeal made by the Hon'ble Chief Minister of Assam, Dr H.B.Sarma, the ULFA Commander in Chief Paresh Barua has released one Ritul Saikia, an ONGC Engineer, under his captivity. The ULFA Commander has also reportedly announced three months' ceasefire unilaterally. Ritul Saikia's release and the ceasefire announcement have been viewed by the government as a welcoming gesture. The Chief Minister has announced during the three day first session of the newly constituted Assembly that he has urged Mr Paresh Baruah to come to the negotiating table. It is expected that Mr Barua will respond with a positive gesture and sit for talks soon.

Now the moot point is that the government of India neither did accede to the demand of sovereignty made by separatist groups earlier, nor likely to sit for talks with an agenda including Sovereignty as an item. The Chief Minister while addressing a press conference the other day said that there cannot be any negotiation on the Sovereignty issue. Now, it is left to Mr Paresh Barua to come to the negotiation table with an agenda sans sovereignty issue, prepared by him with due deliberation with all his confidants including the Arabinda Rajkhowa faction who are now overground and have already involved in talks with the government appointed interlocutors. In preparing the agenda and for carrying out the talks, Mr Barua might be in need of the help of a group of advisors, well versed in knowledge to be able to guide ULFA during the course of talks with government for a fruitful talks. In this regard Mr Barua may take note of the few lines stated below.

For quite sometime after ULFA's birth, a bulk section of indigenous Assamese people's moral support was earned by it so far as its demand for autonomy was concerned, but the support base gradually faded away from the time ULFA started committing heinous crimes like kidnapping, extortion, and especially killing of innocent people by bombings etc. It has long been distressful for the indigenous people of Assam for having been long deprived from its due share by the Centre and so, there is the need of self rule by the indigenous people. And therefore, there has ever been growing a tendency amongst the people to form regional political entities to gain political power to be able to serve the native to their best. ULFA's objective is more or less similar to the indigenous people's desire. In the given circumstances. ULFA's agenda for talks might find place the following demands.

1. Autonomous State: - Assam to be an Autonomous State with a separate Constitution and a Flag of its own. The State to be administered by a council of ministers to be elected by the indigenous people of Assam. The constitutional head is also to be an elected person. Distribution of subjects may be rearranged between the Centre and the State. The Centre will have to cede to the State all the departments except External Affairs, Defence, Railways, Communications, Shiping, Civil Aviation, Highways Construction, Currency, Custom, Heavy industries etc.

2. Representation in International Bodies:- Assam is the State where people of different ethnic groups live. Their varied problems often require international attention. So, Assam should have the right of representation in all the International bodies along with the Central government's representatives and ad-

3. Population Census :- The population of Assam multiplied manifold in less than two centuries time creating the biggest problem for Assam. A Census for the entire population is needed in the line of NRC and the population be categorised in the following way:

a) The indigenous or the original inhabitants of Assam living at the time of the Yandabu Pact of 1826.

b) People who came after 1826 from other parts of India (barring North East) for some usiness or other purpose and settled in Assam, c) The people whose forefathers were im-

ported by British from outside States to be

engaged as workers in tea gardens, d) The immigrant muslim people who migrated from East Bengal during British era and

also after independence. The original inhabitants together with certain selected classes of people would be eligible to hold the right of citizenship and they would be issued Assam Citizenship Card with mention of category in which he falls. Non citizens thus silted out will be taken care of by the Centre for deportation or rehabilitation as the case may be. Foreigners or Indians from other States seeking entry to the State would require Visa or analogus permission from concerned State authority.

4. Financial autonomy :- Assam would have a complete financial autonomy. Revenue earned by the State from the oil industries and other sources would be at the disposal of the State authority. The Centre's share of revenue would be fixed by the State.

5. Ownership of land and immovable property:- Barring the indigenous people others would be entitled to a limited immovable property right as permitted by the State authority. Excess of permissible property would be liable to be confiscated by the State.

6. Establishment of Heavy Industrial Units :- To facilitate the State to achieve a sound economic status and to generate more employment opportunities to the youths, a minimum of 50 numbers of heavy industrial units with a minimum annual turn over of a billion rupees would have to be established in the State.

7 Introduction of State Administrative Service: - In line of Indian Administrative Service, a State Administrative Service would be introduced or the present State Public Service to be upgraded, and recruitment to the service would be made only by indigenous people of the State. With a team of native bureaucrates seriously concerned for the cause of Assam, the State will progress at a rapid pace.

8. Responsibility of the Centre for the flood & allied problems :- The Centre would have the sole responsibility of the flood problem and allied perennial problems of great magnitude arising out of a natural disaster etc.

9. Outsider official of oil industries to be replaced in :- All the executive grade employees serving in the oil sectors like IOC, ONGC, OIL and other important public sectors hailing from outside Assam may be replaced by native officers in aphased manner to be completed within two years. This time period might be required to train up the technical officials to be able to do their task efficiently. For this training schedule to be arranged outside the State or outside India as per necessity for specialised training. This will solve the unemployment problem to a considerable extent.

10. Establishment of Universities and High Educational Institutions:- There are only few Universities in Assam and very less number of government colleges that too with limited courses of study. Due to to shortage of Universities & Colleges, Assamese students have to go to other states for higher studies. At least five more universities, five Engineering Colleges, five Medical Colleges and fifteen government colleges, having modern courses of study be established to cater to the needs of the students seeking admission for higher

11. Railway services to be increased: - Railway communication services presently being afforded for the people of Assam is far deficient both in case of passenger service and service for transportation of goods due to shortage of trains running from Assam to places of other states. It is difficult to get reservation at short notice to travel to other state capitals. In the same way due to shortage of goods trains, essential commodities imported from outside the state becomes costlier after being unloaded in Assam. As such, more train services for Assam and other North East States are needed.

12. More Surface Transport facilities :-There is not enough Surface transport facilities in Assam for easy trade and commerce activities. There are very limited Highways connecting Assam and the North Eastern states. Moreover, there are only five bridges over river Brahmaputra connecting few northern districts with another few southern districts. The districts on the north of river Brahmaputra shares the border with Arunachal Pradesh which state is strategically located for the defence point of view as the Indian state has its common international border with China and the international border dispute between India and China has long been the cause of concern for India. Against five bridges over Brahmaputra, there are as many as 33 bridges over river Gonga. There is need for more surface transport facilities to extend trade and commerce and cultural exchange beyond the international borders in the east.

13.Government controlled trade and ommerce: - Assam and the North East states have been victims of illegal trade practices by traders who imports various kinds of goods ranging from small items of domestic use to heavy machineries for industrial establishments from outside Assam, and sell or supply here in exhorbitant prices making high profits. This is because of the want of government control over trade and commerce. Every trade and commerce within the state must be under the control of the state government so that people should not be cheated and there should not be wastage of government fund.

14. Special Laws & Judicial infrastructure: - Corruption in public life has eaten to the very vitals of the economy and polluting the society badly. In addition to the existing laws a set of special laws need be enacted to punish the criminals, specially of white-collar crimes. Necessary judicial infrastructure be installed to expeditiously get the criminals booked and justice delivered to the aggrieved.

In conclusion, the people of Assam have had the bitter experience of ULFA's three decade long insurgent activities, and so, would like to appeal Mr Paresh Barua, the Commander in Chief of ULFA and also the respective governments to sit for talks at the earliest to give a logical end to the insurgent group's three decade long armed movement.

the East (under Digboi Division, Tinsukia District) up to the Jeypore RF (under Dibrugarh Division, Dibrugarh District), comprises some pristine forests along the Assam-Arunachal interstate boundary, classified as Assam Valley Tropical Wet Evergreen Forests. Popularly known as Dihing Patkai Rain Forest, it has unique floral and faunal diversity, which was recognized by the Government of Assam in 2004, when 111.19 sq. km. of this area was notified as Dihing Patkai Wildlife Sanctuary. Forest and wildlife conservation have now been strengthened here by adding another 123.07 sq.km. to the original sanctuary area and conferring National Park status to 234.26 sq. km, with the highest level of protection available under the Wildlife (Protection) Act, 1972. Notification of the National Park includes areas falling within the existing Dihing Patkai Wildlife Sanctuary along with all the additional Reserve Forests i.e. Upper Dihing RF (West Block) and Jeypore RF. However, Forest Village area diverted under Forest Conservation Act has been excluded. Short stretches of Dirak and Buri Dihing rivers falling within this contiguous patch of proposed National Park have been included. Preliminary notified on 01.12.2020, proclamations were issued on 01.01.2021 by the Deputy Commissioners of Tinsukia and Dibrugarh, after no claims were received and Dihing Patkai was finally notified as a National Park, following due process as outlined in the Wildlife (Protection) Act, 1972. The newly notified National Park shall be administered by Soraipung Range of Digboi Division and Jeypore Range of Dibrugarh Division, both falling under Conservator, Eastern Assam Circle, who shall be notified as Director of Dihing Patkai National Park. For intensive patrolling and conservation of the new area, additional Anti-Poaching Camps and manpower is being provided by the Govt. of Assam.

The number of COVID-19 patients dying of other causes is 1,347. The current death rate is 0.84 percent. At present, Assam has 49,158 active COVID-19 cases, the bulletin said. The new cases were detected out of 1,33,212 tests conducted on Tuesday with the daily positivity rate at 2.96 percent while the cumulative tests conducted in the state so far are 1,19,41,949. As many as 3,88, 451 people have recovered from the infection, including 3,419 on Tuesday. The COVID-19 recovery rate in the state is 87.75 percent. A total of 35,87,993 persons have received the first dose of vaccine and 8,60,549 persons have got the second dose.

In case of a government servant testing COVID-19 positive and is in home isolation and has also been hospitalised, he or she shall be granted commuted leave/SCL/earned leave (EL) for a period up to 20 days starting from the time having tested positive, it said."In case of hospitalization beyond the 20th day from his testing COVID positive, he shall be granted commuted leave, on the production of documentary proof of hospitalization," said the order issued to all central government ministries. A government servant shall be granted special casual leave of 15 days in case a dependent family member or parents (whether dependent or not, living with him) are COVID-19 positive, it said. In case the government servant comes into direct contact with a COVIDpositive person and remains in home quarantine, "he shall be treated as on-duty/ work from home for a period of seven days", the ministry said in its order dated June 7.It said that the period of quarantine spent by government servant, as a precautionary measure, residing in the containment zone "shall be treated as onduty/work from home till the containment zone is de-notified". These orders shall be applicable with effect from March 25, 2020, until further orders.

No more mandatory negative **COVID-19 RT-PCR report for** train travel? Check what Indian Railways is planning

New Delhi, June 09: If you're planning to travel by train in the near future, then you might not have to carry the mandatory negative COVID-19 RT-PCR report. As per sources, instead of a COVID-19 report, the Indian Railway is mulling to allow train passengers with a COVID-19 vaccination certificate. A person can also show his/her certificate through the Aarogya Setu app. The move will also promote people to get vaccinated. Sources claimed that this has been suggested to the Ministry of Railways by several states and the development can likely be confirmed by June 15. Earlier on June 6, Minister of Civil Aviation (MoCA) Hardeep Singh Puri had also said that a joint team from several ministries and stakeholders, including the Health Department, are in discussion to take a final decision on allowing travelling by air without an RT-PCR test for those who have received both doses of a COVID-19 vaccine. He had also stated that this decision will not be taken alone by the MoCA, nodal agencies, including health experts who are working with the government will also contribute towards making a decision in the interests of passengers. Currently, domestic passengers are mandatorily asked to produce a negative RT-PCR report before travelling to some states, where active COVID-19 cases are still high."Health is a state subject, and to ask passengers for a negative RT-PCR report before they enter a state is solely the right of that particular state," Puri added. Meanwhile, India recorded 92,596 new COVID-19 cases and 2,219 deaths in the last 24 hours, the Union Health Ministry informed on Wednesday (June 9). With this, the country's total coronavirus caseload has increased to 2,90,89,069, of which, 3,53,528 have succumbed to the virus, while 12,31,415 are active cases. The cumulative number of COVID-19 vaccine doses administered across the country has also increased to 23,90.58,360.

Covishield Produced More Antibodies Than Covaxin In Early Study: Report

New Delhi, June 09: The Covishield vaccine produced more antibodies than Covaxin, according to a preliminary study by Coronavirus Vaccine-induced Antibody Titre (COVAT) involving healthcare workers (HCW) who have received both doses of either of the two vaccines. Seropositivity rates to anti-spike antibody were significantly higher in Covishield recipients compared to Covaxin after the first dose, the study claimed. The study is a preprint and has not been peer-reviewed, so should not be used to guide clinical practice. It said that both vaccines - Covishield and Covaxin - elicited a good response after two doses, but seropositivity rate and median anti-spike antibody were significantly higher in Covishield." Amongst the 552 HCW (325 Male, 227 Female), 456 and 96 received the first dose of Covishield and Covaxin respectively. Overall, 79.3 per cent showed seropositivity after the first dose. Responder rate and median (IQR) rise in anti-spike antibody were significantly higher in Covishield vs Covaxin recipient (86.8 vs. 43.8 per cent; 61.5 vs 6 AU/ml; both p<0.001)," the study said. The study involved those healthcare workers who have been administered either of the two vaccines, Covishield and Covaxin, and are with or without past history of SARS-CoV-2 infection."This ongoing, Pan-India, Cross-sectional, Coronavirus Vaccine-induced Antibody Titre (COVAT) study is being conducted amongst HCW, with or without past history of SARS-CoV-2 infection. SARS-CoV-2 anti-spike binding antibody is being assessed quantitatively at four timepoints between 21 days or more after the first dose to 6 months after the second dose," the study said. However, the conclusion of the study said that both the vaccines have elicited good immune response."While both vaccines elicited immune response, seropositivity rates to anti-spike antibody were significantly higher in Covishield recipient compared to Covaxin after the first dose. Ongoing COVAT study will further enlighten the immune response between two vaccines after the second dose," it said.

BJP hits out at Kejriwal over doorstep delivery of ration scheme

New Delhi, June 09: Hitting out at Chief Minister Arvind Kejriwal for attacking the Centre over its move to stop the doorstep delivery of ration scheme, the BJP claimed the union government had forestalled a "big scam" to divert subsidised foodgrains. Speaking at a virtual press conference on Sunday, BJP spokesperson Sambit Patra alleged there is zero Aadhaar card authentication in Delhi, against the national average of 80%, and that the Kejriwal government had earlier stopped operation of POS machines which allow biometric verification."It means there is no way one can find out if food grains are being delivered to the needy or diverted," he alleged."Kejriwal blamed the Centre, but the truth is that over 72.78 lakh people are benefitting from the Food Security Act," Patra said. Under PM Garib Kalyan Yojna, which provides free ration to the poor in May and June, the Delhi government has so far lifted 53,045 MT of grains out of 72,782 MT sent by the Centre and distributed only 68% of what it has lifted, he further said. Patra also alleged the Delhi government's scheme was a scam as people will be charged money to get wheat flour as part of it.Responding to Patra's charge, Deputy Chief Minister Manish Sisodia said: "He said we want to levy an extra charge. Mr Patra should read the Centre's guidelines. It is written clearly that if someone wants wheat to be ground to aata, Rs 3 can be charged for this. Our scheme says we will charge Rs 2 and will deliver aata to their homes. Your problem is not Rs 2, your problem is that ration will reach people's homes, and BJP will not be able to pilfer it."He added: "I had hoped the BJP would understand that giving ration to people at home was a step in the right direction..., but I was mistaken. Sambit Patra abused the Delhi CM many, many times today, but I am not going to stoop to that and respond to it."Sisodia also accused the BJP of wanting the current system to continue, saying they benefit from it: "They want us to shut our eyes to pilferage and theft that goes on...

Hexakosioihexekontahexaphobia - a swine to spell (or say) but it does get you value for money on your word count.In the Nightwatchman, Andy Zaltzman writes that cricketers particularly can feel aggrieved that "human beings irritatingly evolved with 10 digits on their hands and thus developed a decimal system of counting". There is one particular number that teeters between joy and disaster. It induces clammy hands and quickened pulses in players and spectators alike. The twitchiest number of the nervous nineties: 99.Clem Hill has the dubious honour of notching the first 99 in Tests, against England at Melbourne in 1902. Pleasingly for stattos but no doubt vexing to him, he followed up with scores of 98 and 97 in the next game at Adelaide. There have been 95 scores of 99 in Test matches. On 89 of those occasions, when within a sniff of a century, the batter perished. Six were left stranded on it. One of the six is Alex Tudor, whose 99 not out against New Zealand in 1999 still rankles, becoming more of a Miss Havisham innings with each passing year. Tudor was sent in as a nightwatchman and biffed his way majestically to 84. Graham Thorpe arrived at the crease with 34 required to win; he was in no mood for sentimentality. Instead of seeing Tudor through to a remarkable century, Thorpe hit a rapid 21 and Tudor was left one run shy of the milestone. "My mum is still fuming," says Tudor, booming down the phone. Thorpe wrote that he regretted his approach that day. Five years later he shepherded Nasser Hussain to a century in his final innings, Hussain's 14th ton. Tudor never made one."I was 21 at the time, I kept thinking I'd get the opportunity again. As the years go on, it does get more frustrating. It would be

incredible to say 'I've got a Test match hundred'. But I can't."One of the most wretched 99s is Michael Atherton's at Lord's in 1993. "Tragedy. Tragedy." Atherton mimics Tony Lewis's commentary line as he reflects on the incident. He says it was the decision to bat in half-rubbers and half-spikes that proved fatal. Sebastian and Oliver Wheldon's father, Dan, won the Indianapolis 500 twice and an IndyCar Series driving championship, and as Susie says of her boys, now ages 12 and 10 respectively: "They have that blood in their veins."Sebastian and Oliver started racing go-karts at a track near their home in St Petersburg, Florida, before they were even old enough to go to school. They decided they liked racing enough to focus on it, knowing that the sport is competitive. They also know, all too well, that the sport is extremely perilous. Dan Wheldon, the brashyet-charming, silver-shoed British star on the IndyCar Series, was killed at the age of
