

Taiwan slams 'evil neighbour' China after missiles fly over island



Taipei, August 05:

Taiwan condemned its "evil neighbour" on Friday after China fired multiple missiles into its surrounding waters, as many as four of which flew over the island's capital Taipei in an unprecedented escalation during live-fire exercises.China launched its largest ever military drills in the seas and skies around Taiwan on Thursday, a day after U.S. House of Representatives Speaker Nancy Pelosi enraged Beijing by making a solidarity trip to the self-ruled island that China claims as its own.

Japan's defence ministry, which is tracking the exercises, first reported that as many as four of the missiles flew over Taiwan's capital. Japan also said that five of nine missiles fired towards its territory landed in its exclusive economic zone (EEZ), also a first, prompting Tokyo to launch a diploprotest.Later, Taiwan's defence ministry said the missiles were high in the atmosphere and constituted no threat. It did not give details of their flight paths, citing intelligence concerns.Some Taipei residents, including Mayor Ko

Wen-je, criticised the government for not putting out a missile alert, but one security expert said that could have been done to avoid stoking panic and playing into China's hands."It counteracted the effect of the Chinese Communist Party's psychological warfare," said Mei Fu-shin, a U.S.-based analyst. "The shock and fear were not as great as they could have been."There was little reaction to the missile firing in Taiwan on Friday. "It's the same as normal. I don't feel anything different," said Ping Chung, who owns a hostel on Liuqiu Island,

Colombo, August 05: The Sri movement that forced Lankan government has been accused of a draconian crackdown on protesters who were involved in toppling Gotabaya Rajapaksa as president, with activists facing intimidation, surveillance and arbitrary arrest. Dozens of protesters have been detained by the police in recent days as the government, led by the newly appointed president, Ranil Wickremesinghe, tried to crush the mass protest

Rare hummingbird last seen in 2010 rediscovered in Colombia

Colombia, August 05: A rare hummingbird has been rediscovered by a birdwatcher in Colombia after going missing for more than a decade. The Santa Marta sabrewing, a large hummingbird only found in Colombia's Sierra Nevada de Santa Marta mountains, was last seen in 2010 and scientists feared the species might be extinct as the tropical forests it inhabited have largely been cleared for agriculture. But ornithologists are celebrating the rediscovery of Campylopterus phainopeplus after an experienced local birdwatcher captured one on camera. It is only the third time the species has been documented: the first was in 1946 and the second in 2010, when researchers captured the first photos of the species in the wild. Yurgen Vega, who spotted the hummingbird while working with the conservation organisations Selva, ProCAT Colombia and World Parrot Trust to survey endemic birds in Sierra Nevada de Santa Marta, said he felt "overcome with emotion" when he saw the hird "The sighting was a complete surprise," he said. "When I first saw the hummingbird I immediately thought of the Santa Marta sabrewing. I couldn't believe it was waiting there for me to take out my camera and start shooting. I was almost convinced it was the species, but because I felt so overcome by emotion. I preferred to be cautious: it could've been the Lazuline sabrewing, which is often confused with Santa Marta sabrewing. But once we saw the pictures, we knew it was true."The Santa Marta sabrewing is listed as critically endangered on the IUCN red list of threatened species and features in the Top 10 "most wanted" list in the conservation organisation Re:wild's Search for Lost Birds, a worldwide effort to find species that have not been seen for more than 10 years. The bird is so rare and elusive that John C Mittermeier, the director of threatened species outreach at American Bird Conservancy, likened the sighting to "seeing a phantom". The hummingbird Vega saw was a male, identified by its emerald green feathers, bright blue throat and curved black bill. It was perched on a branch, vocalising and singing, behaviour scientists think is associated with courtship and defending territory. The Sierra Nevada de Santa Marta in northern Colombia is home to a wealth of wildlife, including 24 bird species not found anywhere else. But scientists estimate that only 15% of the mountains' forest is intact. It is hoped the surprise sighting of the Santa Marta sabrewing will help to protect their remaining habitat, benefiting many different species found there.

When she asked about the matter the school authorities replied that Ujjwal was missing from the campus and they were searching for him. She also said that the CCTV cameras installed in the school also could not provide any clue. She raised allegations against some senior students for harassing her son. The whole matter was reported to the police but after ten days passed Ujjwal Das is still untraceable. Meanwhile Scheduled Caste Yuva Chatra Parishad Golaghat District committee leaders have expressed their concern in this matter and they submitted memorandum to the Deputy Commissioner as well as the Superintendent of Police, Golaghat and demanded that the missing student should be rescued within next 24 Hrs and also demanded a proper investigation on how a student suddenly went missing from the residential school under mysterious circumstances.

Long way from winning the war

The Russo-Ukrainian war is coming down to a race between the weakening political will of western democracies and the deteriorating military means of Vladimir Putin's dictatorship. But this race will be a marathon, not a sprint. Sustaining that political will requires the kind of farsighted leadership which most democracies are missing. It calls for a recognition that our own countries are also, in some important sense, at war - and a corresponding politics of the long haul. Is this what you hear when you turn on your television in the United States (where I am now), Germany, Italy, Britain or France? Is this a leading topic in the Conservative party contest to decide Britain's next prime minister, or the run-up to the Italian election on 25 September, or the campaign for the US midterm elections on 8 November? No, no and no. "We are at war," I heard someone say recently on the radio; but he was an energy analyst, not a politician. The fact that Ukrainian forces are preparing for a big counter-offensive to recapture the strategically vital city of Kherson shows what a combination of western arms and Ukrainian courage could achieve. US-supplied High Mobility Artillery Rocket System (Himars) - long-range multiple-launch rocket systems - have enabled the Ukrainians to hit artillery depots, bridges and command posts far behind Russian lines. Russian forces have been redeployed from Donbas to defend against the expected offensive, thus further slowing the Russian advance in the east. Richard Moore, the head of Britain's Secret Intelligence Service (MI6), observed recently that Russia might be "about to run out of steam" in Ukraine because of shortages of material and adequately trained troops. So Ukraine has a good chance of winning an important battle this autumn; but it's still a long way from winning the war. In his campaign to defeat not only Ukraine but also the west, Putin is counting on Russia's two traditional wartime allies: Field Marshal Time and General Winter. The Russian leader is weaponising energy, reducing gas flows through the Nordstream 1 pipeline so Germany can't fully replenish its gas storage before the weather turns cold. Then he will have the option of turning off the gas entirely, plunging Germany and other dependent European countries into a desperate winter. High energy prices as a result of the war continue to turbocharge inflation in the west while keeping Putin's own war chest filled with the billions of euros Germany and others are still paying for Russian gas and oil. Although a few grain ships are now leaving Odesa, his blockade of Ukrainian ports has caused a food price crisis across parts of the Middle East and Africa, resulting in much human misery and potentially in refugee flows and political chaos. Those, too, are Putin's friends. Better still: the global south seems to blame this at least as much on the west as on Russia.

Tier II & III cities to become the epicenter of digital revolution in India

the rise of 'New India', propelled by the big aspirations, astonishing skills, and unflinching diligence of millennials which is the largest group of working population in the country. Besides the youth power, the growth story being scripted by India can be attributed to the swift penetration of the internet across the length and breadth of the country, which is stimulating digital revolution at an unimaginable pace. People of the country, irrespective of their location, education, and age, are reaping the benefits of this digital storm which has been gaining immense thrust from tier-II and tier III cities. As tier-1 cities have reached a point of saturation, now it becomes vital to boost the infrastructure of TierII&III cities and equip them with all the required facilities to further augment the growth. A report by IAMAI-Kantar ICUBE 2020 estimates that active internet users will grow by 45% in India over the next five years and reach 900 million users by 2025, up from 622 million in 2020. Tier-II & III cities constitute a larger part of the population that is joining the digital world steadfastly for its day-to-day needs, making digital revolution firm in India. According to reports, rural India will have more internet users than urban India by 2025. As a result, the digital ecosystem would have to adapt to cater to the needs of this new demographic.As per the estimates of the McKinsey Global Institute (MGI) Digital Adoption Index,

he world is witnessing growing digital economy among ous initiatives to attract IT the 17 leading economies of the world. A NASSCOM report titled 'Future of Technology Services-Winning in this Decade' highlights that over 50 digital initiatives in diverse sectors such as finance and banking, healthcare, IT/ITES are fueling India's digital dream and are contributing 8% to the economy. Moreover, the Covid-19 pandemic too has accelerated digitization and tier-II and tier III cities are the strongest force behind this thrust in the digital economy of the country. Earlier, most of the business activities, especially IT/ITes, used to remain centered around

metropolitan cities such as Gurugram, Bengaluru, Hyderabad, etc. With several conducive factors including superior infrastructure and skilled workforce, Tier-II and III cities have emerged as new loci of growth recently. The groundwork laid by the Electronics Commission envisaged the creation of regional computing centers to spur software and intellectual capital development in India. And, the establishment of the National Task Force on Information Technology and Software Development and New Telecommunication Policy provided the roadmap further to catalyze the growth of the IT/ITes sector. Meanwhile, a spate of infrastructure development has also made these cities the most sought-after destinations for IT/ITes investments and other businesses.Likewise, the Digital India and Startup India campaigns, the JAM trinity, and Smart Cities Mission have also accelerated the transformation of these cities. It is estimated that there are more than 61,000 recognized startups in India, across 55 industries, with 45% of them located in Tier II and Tier III cities. The state governments have undertaken varifirms and provide a conducive ecosystem by establishing industrial clusters, SEZ, and various skill development initiatives to stay ahead in the digitization process. Industry bodies such as NASSCOM, ASSOCHAM, TIE have created access to financial assistance, mentorship, incubation, and network opportunities to support path-breaking ideas from the hinterlands. According to an estimate by Zinnov (a leading manage-

ment consultancy), about 976 MNCs have set up 1,257 Global In-house Centres (GICs) in India, out of which 68 GICs are in Tier-II locations. The relaxation in the Department of Telecommunications' compliance guidelines allowing IT firms to work from anywhere amid Covid-19 is also set to provide a fillip to this trend.Moreover, with an aim to foster an IT ecosystem in tier-II and III cities, STPI has launched the India BPO Promotion Scheme (IBPS). This scheme seeks to incentivize the establishment of 48,300 seats in respect of BPO/ITES operations across India. The government provides financial support of up to Rs 1 lakh per seat under two plans-India BPO Promotion Scheme and North East BPO Promotion Scheme. The scheme is distributed among each state in the proportion of state and population with an outlay of Rs. 493 crores. There are special incentives in the scheme to promote employment for

persons, the participation of local entrepreneurs, setting up operations in non-capital cities, etc. Such a combination of the rising middle class, a shift in consumption patterns and technological innovation augurs well for tier-II and tier III cities to emerge as growth engines of the Indian economy. connectivity and put tier-II and tier III cities such as Sonipat, Jaipur, Dehradun, etc. on the infrastructure map. On the technological front, the proposed roll out of 5G technology also augurs well for the IT/ITes industry in these cities. A Datacenter Policy is also in the pipeline that will escalate the digital transformation process in India. Also, the 'work from home' model amid the Covid-19 pandemic has set off a trend of reverse migration. As a result, firms are moving to tap talent in Indian hinterlands instead of workforce migrating to TierI cities for employment. It has led to the emergence of the 'hub and spoke' and 'edge' model wherein tier 1 cities serve as hubs while tier II and tier III towns form the spoke network, and the edge implies the work that can be done remotely. This model allows leading IT firms to diversify their operations at comparatively lower costs in Tier II and Tier III cities while retaining their clientele in tier 1 cities. Another emerging trend firms are looking to diversify their workforce through contract employees who impart flexibility and agility to their operational models. Moreover, leading multinational firms are embracing the idea of expansion in these cities due to multiple advantages including cost-effectiveness, lower land and labor costs, availability of a large talent pool, and low attrition rate of the workforce. Besides serving as a consumer market, the cities such as Jaipur, Indore, Lucknow have emerged as an education hub, thereby generating skilled human capital employed in various firms. Bolstered by these factors, tier II and tier III cities will emerge at the forefront of the digital revolution. This trend will have a multiplier socio-economic impact in the region in terms of employment generation, curbing migration to metropolitan cities, boosting the local economy, improving living standards, and bridging regional disparities in economic development. This will also lessen the burden of mega cities which are facing problems due to limited resources and influx of people from around the corner of the country in the pursuit of quality life.owever, it will be critical for these cities to sustain the digitization wave. Well, the AS is the first to get invited to the Rashtrapati Bhawan for the 'at home' on Independence Day and Republic Day. They also get to witness the Independence Day parade from the ramparts of the Red Fort. To the outsider, the nuances of these fine distinctions may appear frivolous, but these do make a lot of difference to the officers (and their spouses!). The tenure of the AS is not very long, and the current government is trying to empanel officers to the rank of Secretary soon thereafter to ensure that they get a longer tenure in that position. This is also necessitated by the fact that after 1995, the average entry-level age increased from 25 to 28 years. Finally, when an officer becomes a Secretary to the Union government, they move to the apex scale in terms of pay and receive the status and treatment of a 'state guest' on an official visit to a state government, with all the attendant protocols besides an entitlement to use the reserved lounge at the airport. The moot question for consideration is: Does the reduction of two layers of decision-making in the government make a difference? It certainly does, for under the revised norms, each of the three levels will have a specific mandate.In

the first instance, the undersecretary or deputy secretary or director will initiate the note with basic information about the scheme/programme/ issue in question. It will list the budgetary provisions, past precedents, references to related decisions as well as parliamentary assurances, if any, on the subject and recommend a course of action. At the level of the JS and AS inputs from other divisions within the ministry, autonomous bodies. SPVs (Special Purpose Vehicles), PSUs (Public Sector Undertakings) and/or industry chambers will be factored. In case the issue concerns more than one state, inputs from the state government are also taken on board. The file will now be put up to the Secretary who will take a 360-degree view and also look at the implications for the related ministries. Thus, any view on the procurement of cereal by the Food Corporation of India (FCI) or pulses by NAFED (National Agricultural Cooperative Marketing Federation of India) would certainly involve the ministries of agriculture, food, consumer affairs, and commerce. While this is a positive step in reducing hierarchy and making the government more functional, there is a new irritant called 'equivalent', which has been institutionalised over the last few years. At the level of AS and Secretaries, an officer is now being empanelled as AS or AS equivalent, or Secretary and Secretary equivalent. More often than not, after a gap of six months to a year, those in the equivalent category are upgraded to the full status of AS or Secretary. A Secretary equivalent is not supposed to become the Secretary in charge, but in terms of 'frills', they are equal to the Secretary and get to be a state guest on their travel. However, there are multiple instances when officers who have been empanelled as Secretary-equivalents have been made Secretaries and those who are empanelled as Secretaries given positions that are 'Secretary equivalent'.

Once upon a time, king Akbar got so mad at Birbal that he told Birbal to leave the kingdom and go away. Heartbroken, Birbal left the kingdom and took





Since 1937 he had ridden herd on a zany cast of cartoonists of whom he understood little, having, unfortunately for a cartoon producer, no sense of humor to call upon. Common belief on the main lot was that Quimby had won his producer's title due to long years of service as a top



salesman in New York, from whence he came. Indeed, he knew nothing of animation and, as Irv Spence recalls, cartoons "were a strange thing to him." Cast in the role of high school principal

opposite the animators' boyish enthusiasms, he acted as liaisons between them and the front office, usually it seemed, turning down requests for bigger budgets, raises and special dispensations of funds. But under his stewardship, Tom and Jerry sailed along like a flagship on a balmy sea. Not burdened with the need to deal directly with the cantankerous corporate minds in the administration arena, Hanna and Barbera were free to exercise the creativity that made Tom and Jerry the "Gold Dust Twins" of MGM. After 18 years at the helm of the Cartoon Department, Quimby retired, and here was where the storm clouds began to glimmer. Quimby's retirement in no way hampered the creative flow of the Tom and Jerry cartoons, but his leaving signaled the beginning of the end of an era, the Golden Age of Hollywood, in the worlds of both action and animation. And the world was already beginning to change. Television, that great engulfing box with knobs and the convex screen, was already gulping up huge chunks of the theatrical audience, allowing them to be entertained on dark evenings without ever leaving home.

Box office receipts fell, and then plummeted. Movie studios began to worry, and then to panic. New techniques were put into operation, among them CinemaScope, which widened the theater screen to provide a presumably more encompassing view of the world. Cartoons, too, were forced to submit to the CinemaScope rage. Tom and Jerry's first such outing was Pet Peeve, in 1954.





He highlighted the Enforcement Directorate's probe against Rahul Gandhi and Congress president Sonia Gandhi in the National Herald case and said the former Congress president must answer as to how Young Indian, a firm in which the two Gandhis have a 76 per cent stake, allegedly acquired the National Herald's assets worth over Rs 5,000 crore with the investment of only Rs 5 lakh. "You will have to face trial and answer the ED's questions," he added. "Price rise and unemployment are merely an excuse he said of the Congress' protest and added the basic reason is to intimidate the ED and save the family. He hit out at Gandhi for alleging that the opposition was not allowed to raise its issues in Parliament and said Congress members had also spoken during a debate on price rise. Union minister Anurag Thakur echoed the views and said the protests by the Congress from Parliament to the streets cannot turn the truth of corruption charges against its leaders into a lie."They are trying to apply pressure on the government and probe agencies after doing corruption. The BJP came to power in 2014 and promised to give corruption-free governance. This is what Modi has delivered in eight years. Probe agencies are now working against corruption done earlier, he said."Should investigation agencies stop their work? Should some political parties be allowed to do corruption?? he asked. Rahul Gandhi and Priyanka Gandhi Vadra should not obstruct the ED's work, he said, claiming the agency works under no political pressure and functions independently. Both Rahul Gandhi and his sister, a Congress general secretary, were detained by police during their party's protest. Both Prasad and Thakur also noted the allegations of corruption against opposition leaders, including those from the Aam Aadmi Party and the Trinamool Congress. Large amount of cash and other assets allegedly acquired by them have been seized by the ED, they said. Prasad said Rahul Gandhi had levelled all kinds of allegations against Modi during the 2019 polls as well but people elected him with a bigger mandate. The government under Modi has been taking strong measures against corruption, and the Congress and the system around it are rattled because democracy had become synonymous with financial irregularities when the opposition party was in power, he alleged.

Taiwan slams 'evil neighbour'

Asked to comment on the missiles, Taiwan Premier Su Tseng-chang did not directly respond, but referred to China as the "evil neighbour showing off her power at our door."Bonnie Glaser, a Washington-based Asia security specialist at the German Marshall Fund of the United States, described as "unprecedented" reports that ballistic missiles were fired over Taiwan. "In my view, the larger threat is that China is doing a rehearsal for a blockade, demonstrating it can block Taiwan's ports and airports, and prevent shipping," she said. China has said its relations with Taiwan are an internal matter. "The U.S.-Taiwan collusion and provocation will only push Taiwan towards the abyss of disaster, bringing catastrophe to Taiwan compatriots," said a Chinese defence ministry spokesperson. Responding to the Chinese drills, President Tsai Ing-wen said Taiwan would not provoke conflicts but would firmly defend its sovereignty and national security. Taiwan has been self-ruled since 1949, when Mao Zedong's communists took power in Beijing after defeating Chiang Kai-shek's Kuomintang (KMT) nationalists in a civil war, prompting the KMT-led government to retreat to the island. Beijing says it reserves the right to bring Taiwan under China's control, by force if necessary.U.S. Secretary of State Antony Blinken told an Asian meeting of top diplomats on Friday that China's reaction to Pelosi's visit to Taiwan was "flagrantly provocative" and that China had sought to intimidate not only Taiwan but neighbours too, a western official said. Pelosi, who is currently in Japan, told reporters that China could not isolate Taiwan by preventing Western officials from travelling there. "This visit isn't about me, it's about Taiwan," she said. During a news conference in Tokyo, Pelosi addressed the diplomatic storm caused by the congressional visit to Asia, and most specifically Taiwan."We have said from the start that our representation here is not about changing the status quo in Taiwan or the region," she told a news conference after meeting Japanese Prime Minister Fumio Kishida. The congressional delegation led by Pelosi visited Singapore, Malaysia, Taiwan and South Korea earlier this week before arriving in Japan for the last leg of the tour. Pelosi met Kishida at his official residence, where the Japanese prime minister said the two allies would work together to maintain peace and stability in the Taiwan Strait, a key shipping route. China's foreign ministry said it had summoned the Japanese ambassador in Beijing on Thursday over its participation in an "erroneous" Group of Seven (G7) nations statement on Taiwan, and also made complaints to EU envoys. Japan, whose southernmost islands are closer to Taiwan than Tokyo, has warned that Chinese intimidation of Taiwan is an escalating national security threat."I have informed speaker Pelosi that the fact China's ballistic missiles had landed near Japanese water including EEZ threaten our national safety and security and that Japan had strongly condemned such actions," Kishida said.

By Wednesday lunchtime, all available general admission tickets were sold out, with just hospitality options still on sale. The FA announced at 2pm that England, the newly crowned European champions, were in line to host the USA, the World Cup holders, on 7 October. It prompted a surge to buy tickets and supporters able to access the website were given an estimated wait time of more than an hour. The crashes appeared to occur only early in the rush but the long waits continued for hours. It is the latest signal that England's win against Germany in front of

Commons to Commonwealth: Ghana cyclist Symonds builds his own legacy



New Delhi, August 05: Armenia have a narrow lead over the top seeded US at halfway in the 180nation, \$10m Chennai Olympiad, an event which is already unique and in the record books. Its stunning ambiance, eager fans, and opulent playing conditions reflect India's ambition to make August 2022 a landmark moment towards its goal of surpassing the three established chess superpowers, USA, Russia and China. The state of Tamil Nadu and its chief minister, MK Stalin, approved a \$10m budget which dwarfs any other chess event in history, Familiar name? The politician was born in 1953 and when Joseph Stalin died four days later the baby's father decided what to call his son.Besides more than 1700 players, the Olympiad has thousands of support staff, ranging from arbiters and live board technicians to anti-cheating friskers and medical personnel. Hundreds of children from all over India are being provided every day with free food, travel and accommodation to visit the Olympiad and to talk to the former world champion Vishy Anand. Chess is already a major Indian sport and with the stimulus from Chennai it could take off further, as it did in Russia in the 1930s. Every game from both the open and women's Olympiads is relayed to major chess websites. Play begins at 10.30am daily (five hours earlier for next Tuesday's final round) and is free to watch on chess24.com with grandmaster commentaries and an evaluation bar which shows at a glance who is winning. Birmingham, August 05: Eight years ago, Jack Laugher appeared at his first Commonwealth Games as a precocious 19-year-old, exploding on to the world stage with two gold medals at Glasgow 2014. He is 27 now, an accomplished veteran who has faced numerous obstacles. Yet he continues to triumph. After a timid start, Laugher's form exploded in the second half of the men's 1m springboard to help him clinch his third consecutive Commonwealth Games gold medal, his seventh medal overall. As the veteran Li Shixin of Australia finished with silver, England's Jordan Houlden took an excellent bronze in his first Commonwealth Games.It was far from easy. Laugher had struggled in the preliminary round in the afternoon, feeling his nerves as he qualified in fourth place. He arrived in the final under serious pressure from 34-year-old Li, a two-time world champion. Yet when the pressure was at its highest, Laugher soared. Houlden led early on, opting for the tactic of throwing down his most difficult dives first and nail-

ing them to establish an early lead. But in the second half, Laugher distanced himself from the pack. For his fourth dive, he spectacularly executed his inverted two and a half piked somersault, the hardest dive in his arse- a way, I'm seeking the nal, which moved him to first place. Having reached the top, Laugher refused to relinquish his gold medal.He finished spectacularly, slamming down his final two dives and earning an enormous score of 447 points just 10 points higher than the ever-consistent Li. "Today I was pushed," said Laugher."It was a big-scoring competition, probably the best-scoring competition we've ever had at the Commonwealth Games. Some great performances by everybody and I'm really happy to share the podium with Jordan."Laugher's success is even more meaningful given the struggles he has documented in recent vears, with anxiety and other mental health issues leaving him on the verge of quitting
