Sources said the accused was in contact with the banned militant outfit through social media, adding that his role however remains unclear.

The bodies of fatherdaughter duo, who drowned in the Namdang river in Assam's Sivasagar district, was recovered .The bodies were recovered by the State Disaster Response Fund (SDRF) following an intense search operation.Both the father and his minor daughter went missing from Khamun village in Namti on Tuesday night. The deceased have been identified as Prashanta Sharma and Geetashree Sharma. According to reports, the daughter went out in search of her father on the banks of the Namdang River, however, she did not return home.

A wild elephant died due to suspected electrocution in Assam's Golaghat district. Sources said the tusker had strayed into a village in search of food, but unfortunately, it stepped on a live wire and got electrocuted. 



And whereas, Government of India, has identified formulation and implementation of a TOD policy in achieving planned urban development and oilers special assistance to states for capital investment (2022-23) on implementation of this policy.

Child has the right to be protected from neglect

In India, a child has the right to be protected from neglect, exploitation, and abuse at home and elsewhere. Children have the right to be protected from the incidence of abuse, exploitation, violence, neglect, commercial sexual exploitation, trafficking, child labour, and harmful traditional practices to name a few. Yet according to a study conducted by the government in 2007, more than 69% of children aged 5 to 18 years old are victims of abuse. There are many who must face humiliation and violence every day. More than half of the abuses inflicted upon children are committed by a close group of people who have a relationship of confidence and authority with the child. In Indian families, parents have absolute authority over their children. Furthermore, this strict discipline is also found in academic areas, a study found that 65% of school-going children have faced corporal punishment at the hands of academic staff.A contributing factor to the neglect of children is a result of cultural values which does not have high esteem and standing for the words and opinions of children. As such, no Indian legislation specifically mentions this right, and education focuses on the respect children must show to adults. To fully realize children right to protection, it is important to adopt a different attitude towards children and their needs. It is also necessary to invest in educating and training caregivers on children's fundamental right to protection, and prosecuting those who neglect it. Despite the fact that the second article of the UN convention of the right of the child ensures the right not to be discriminated against including sexual orientation. Historically, in India, the LGBTQ+ community has been a target of discrimination. Mainly, as a result of a 157-year old colonial-era law (Section 377) which criminalizes certain sexual acts that are punishable by a 10-year jail term. This law not only deprived LGBTQ+ children of their fundamental rights, but subjects LGBTQ+ children and youth to bullying, harassment, isolation, and violence.

uantum Technology: A new dimension of technology

uantum Technology is one of the most prom ising emerging technologies. It is estimated by the experts and scholars that advent of the Quantum Technology would completely change the scenario in the technology world. A quantum computer of reasonable qubits has the capacity of computing power more than the all together capacity of the entire super computers on the globe. Quantum communication would make the travelling of information at more than the speed of light. Cryptography algorithm based on quantum phenomena would be capable to break the most sophisticated cyber security in few seconds. This unimaginable strength of the quantum power makes the whole world to invest heavily in the research and development of the Quantum Technology. At present, most of the development in the Quantum Technology is at the research level. Much more efforts are required to bring the technology to the market and use for the strategic and commercial purpose. Many research laboratories under the multinational companies or federal governments are working in the various aspect of development of the technology in the different do-



mains of the technology. Quantum technology is a multidisciplinary area of research involving physics, electronics and engineering. Quantum Technology is about creating practical application based on Quantum Mechanics. Many fields such as Quantum Computing, Quantum Communication, Quantum Sensors, Quantum Cryptography, Quantum Metrology and Quantum Imaging are some of the applications based on quantum technologies.

Quantum Technology is based on three concepts of Quantum Mechanics i.e Quantum Superposition, Quantum Entanglement and Quantum Tunnelling which distinguish it from the all the contemporary technology. These concepts

or the properties of the quantum mechanics cannot be imagining in the real world, but it is reality in the subatomic world. Many practical experiments and theories proved the validity of these concepts. These concepts are weird but true and laid the foundation of superiority of Quantum Technology.

Further increment in the computing power can be possible with the advent of Quantum Computing which has the capacity to increase computing power exponentially by using Quantum Gates and Quantum Transistors based on atoms and subatomic particle instead of

classical transistors. The classical communication techniques even though having much advancement in its five generations still prone to many limitations such as the speed of travelling of information, hacking of information through eavesdrop or intercept, limitation of distance and etc. The Quantum Communication removed these limitations through its inherent quantum properties.

Realising the potential and strategic importance of Quantum Technology, Ministry of Electronics and Information Technology has initiated projects in this emerging area of technology. These projects addressthe focus areas of MeitY i.e. Quantum Computing, Quantum Communication, Quantum Cryptographyand Quantum Sensing. These projects have been initiated for promoting research activities, building state-of-the-art infrastructure and to build human resources in this niche area of

Project titled "Centre of Excellence in Quantum Technologies (CoE-QT)" has been initiated in which IISc-Bangalore, RRI-Bangalore and C-DAC-Bangalore are participating. The centre is being equipped with the sophisticated infrastructure required for the development in the area of Quantum Technology. The major objective of CoE-QT includes development of 4-qubit quantum processor, demonstration of quantum communication over 100 Kilometer long fibre link, development of quantum algorithms and development of associated components.

In another major initiative, an indigenous quantum simulator (QSim) has been designed and developed by IISc-Bangalore, C-DAC (Hyderabad & Bangalore) and IIT (Roorkee). QSim is an indigenous toolkit that is serving as an important educational/ research tool being used by students/researchers to the field of Quantum Computing.QSim allows researchers and students to write and debug Quantum Code that is essential for developing Quantum Algorithms. QSim is accessible via web portal https:/ /qctoolkit.in and is currently set up with the PARAM SHAKTI supercomputing machine as the

We can see that the motivation for war is not annexation. In none of his expeditions does Raghu set up a governorship or viceroyalty. Rather, he is motivated by tribute and by symbolism: by displaying his overwhelming military might (and virility) in all four cardinal directions, thus performing a digvijaya or "Conquest of the Directions" he establishes himself as a universal sovereign, a chakravartin. Even if we can dismiss much of the Raghuvamsam's claim as literary exaggeration, it still reveals to us something important: that motivations for war in medieval India were complex, driven by symbolism as well as wealth; and that there was no clear geographical or cultural sense of where the subcontinent "ends". If we wish to establish that Indians were not interested in expanding beyond the subcontinent, we need to find examples of polities that-even when given the option-deliberately decided not to wage war beyond these imaginary modern borders. Such an example could come from medieval Kashmir. In the 8th century CE, with the Gangetic Plains in a state of anarchy, the Kashmiri king Lalitaditya Muktapida found himself in a position where he could raid freely into this fertile region. And yet in the Rajatarangini of Kalhana, a 12th-century text, we are told once again that he em-

barked on a digvijaya, supposedly

raiding Kannauj, Bengal (east), the Deccan (south), and Dwaraka

(west). Details of all of these are

hazy, but those of his conquests

in the north-in present-day

Xinjiang, Tibet, and Afghanistan-

are spectacular. In Book IV, verses 165-168, we are told that "the stables of the Kambojas were emptied of horses... The Tuhkharas [Tocharians]... fled to the moun-Bhauttas [Tibetans] could not be seen on their faces, which are white..." Chinese sources also attest to the last line: Lalitaditya is known to have sent an embassy to the court of the Tang dynasty, offering an alliance against the Tibetans.Kalhana also provides two rather interesting cultural observations (verse 178-180): "This mighty king made the conquered rulers, in order to indicate their defeat, adopt various characteristic marks, which they and their people wear humbly even to the present day. Clearly, it is by his command, to display the mark of their bondage, that the Turushkas [Turks] carry their arms at their back and shave half their head. On the waistcloths of the Dakshinatyas [Deccanis] the king put the tail which sweeps the ground, to mark that they were like beasts." Here Kalhana is only describing existing practices of his time and trying to link them to his hero, Lalitaditya. It is nevertheless striking that to him, Deccanis are as alien as the Turks, and all of them are mentioned to establish that Lalitaditya made conquests in all four directions, thus becoming a chakravartin, a universal emperor. No matter the distances involved, and irrespective of cultural difference or similarity, what the evidence shows us is that medieval Indian polities were always interested in military expansion to the edges of their world, following the cardinal directions to establish a symbolic "universal" rule. It just so happens that their universes were different from ours: because why would their imaginations be constrained by a nation-state that would not exist for another thousand years? Deccan polities such as the Rashtrakutas raided towards the Himalayas, Odisha, Gujarat, and Tamil Nadu; Tamil polities such as the Cholas raided towards Bengal, Karnataka, Sri Lanka, and Indonesia; Kashmiri polities raided towards Punjab, Af-

ghanistan, and Xinjiang.

Each time an opportunistic politician talks about their bogus secular beliefs, they devalue the original idea of India in the eyes of the voters. So no, this is no victory for secularism. It is merely the latest manoeuvre by a

sides so often that he must wake up in the morning and struggle to remember who his allies are Modi is - by a long way - the today.Two: while secularism has very little to do with it, the Bihar realignment reminds us why the BJP is having problems with allies. In just over two decades, the party's fortunes have changed dramatically. In 1996, when it was the single largest party in the Lok Sabha, it was unable to form a stable government because other parties considered it beyond the pale. Vajpayee had never expected to take office in his lifetime (when he was handed the letter by the President asking him to form his first government, he was so overwhelmed that the tears flowed). So he was grateful to the allies who made it possible. Modi's BJP, on the other hand, sees itself as the natural party of government. It believes it needs nobody else to govern with and sees no reason to respect two national mandates in a row and country's most popular politician. All this may be true - at least for now - but Modi and Amit Shah (the former B.JP president and current Union home minister) take it even further. In the BJP's first term in office, Shah spoke of wanting to create a 'Congress-mukt Bharat'. When the Congress obligingly lay down and collapsed, failing at two national elections and losing state after state, Modi and Shah acted as though this should be a lesson to other parties: do as we say or face demolition. Take the case of Maharashtra. The BJP-Shiv

It was a demand that could easily have been conceded. As part of this operation, they gave the chief ministership to rebel Shiv Sena leader, Eknath Shinde, not to their own Devendra Fadnavis. So was it worth it? Shouldn't they just have agreed to Uddhav's terms to begin with?No. Allies must do what the BJP wants. And

Minister is not a sign of weakness. The BJP reckons that now that he is in office, Shinde can turn his rebel faction into the real Shiv Sena and finish off the Thackerays. The punishment of Uddhav continues.As political styles go, this is dramatically different not just from the Vajpayee-Advani style of functioning but from the manner in which every national party has behaved in the history of India. This incarnation of the BJP wants an India where every other party collapses unless it supplicates before the BJP. And even when it does supplicate, as Nitish Kumar's JD(U) did in Bihar, the BJP may try to destroy it, anyway. And finally: the iubilation over Bihar may be short-lived. The BJP will not take this humiliation lying down. It will make life as difficult as it can for the new Bihar alliance. It will need to strengthen its claim that the RJD is corrupt so expect more ED/ CBI raids, and more cases as the investigating agencies are unleashed. My guess is they won't have to look too hard: Bihar is hardly a haven of clean governance.Narendra Modi and Amit Shah cannot afford to allow the message to go out that an ally can defy them and still flourish. It took them nearly three years to punish Uddhav Thackeray but they never gave up. And in the

Prime Minister Narendra Modi has earlier said that "selfish announcements of freebies" will prevent the country from becoming self-reliant, increase the burden on honest taxpayers and prevent investment in new technologies. The PM made these remarks while inaugurating the second generation (2G) ethanol plant in Panipat via video conferencing on World Biofuel Day on Wednesday. He said that the facility will be able to dispose of the stubble without burning it. "Selfish announcements of freebies will prevent the country from becoming self-reliant, increase the burden on honest taxpayers and prevent investment in new technologies," he added. The Prime Minister also said that in the next few years, more than 75 per cent of the households in the country will get piped gas. Assam police have so far arrested at least 31 persons including a Bangladeshi national and busted five modules of AQIS/ABT in the state since March this year. On Wednesday, Nitish Kumar took the oath as the chief minister and RJD leader Tejashwi Yadav was sworn in as the deputy chief minister. The BJP has dismissed the claims of Nitish Kumar that it was trying to break the party and reiterated how the BJP respected Nitish Kumar by allowing him to lead the alliance in Bihar. China places on hold India-U.S.

known as Abdul Rauf Azhar Alvi, the Chinese mission at the U.N. said it required 'more time' to study the proposal, and now has six months to make a decision. "We placed a hold because we need more time to study the case. Placing holds is provided for by the Committee guidelines, and there have been quite a number of similar holds by Committee members on listing requests," a spokesperson for China's mission to the United Nations told Reuters news agency. This is the second time China has blocked an India-U.S. listing proposal at the UNSC in two months, and comes after China placed a similiar hold on the listing of Abdur Rahman Makki, deputy chief of the Lashkar-e-Toiba/Jamaat ud Dawa (LeT/JuD). China's decision is likely to further strain ties between New Delhi and Beijing, which have been in a military standoff at the Line of Actual Control since April 2020, and comes despite some signs of a diplomatic thaw, after External Affairs Minister S. Jaishankar met Chinese Foreign Minister Wang Yi on the sidelines of a G-20 meeting in Bali, and Chinese Special Envoy on Afghan Affairs Yue Xiaoyong travelled to Delhi for talks with his Indian counterpart J. P. Singh last week. Government officials had been hopeful for a shift in Chinese position after 2019, when China withdrew objections to the listing of JeM chief Masood Azhar, who was freed in return for hostages in the IC-814 hijack. The holds on the UNSC terror listings of Makki, followed by Asghar indicates otherwise. The 1267 U.N. listing mandates members to ensure that terrorists and organisations designated must not be allowed to travel and have recourse to funds or weapons. However, a UNSC permanent member can place a hold on any listing for a period of upto 6 months, followed by an extension of 6 months, after which it must either accept or deny the listing. The MEA has not yet confirmed or commented on the Chinese decision to hold Rauf Asghar's listing at the UNSC. Expressing India's frustration with similar decisions by China in the past, U.N. permanent representative Ambassador Ruchira Kamboj had said on Tuesday that "the practice of placing holds and blocks on listing requests without giving any justification must end. It is most regrettable that genuine and evidence-based listing proposals pertaining to some of the most notorious terrorists in the world are being placed on hold." Ms. Kamboj had said that the "double standards and continuing politicisation" of the process had rendered the credibility of the Sanctions Regime at an "all-time low." On August 7, the police arrested a woman identified as Jahura Khatun in Dhubri district for her alleged links with Bangladeshi terror outfit ABT. According to police, her husband, namely Abu Tallah, is also wanted for his alleged connection with the terror outfit. Khatun had been allegedly trying to protect people who are associated with Ansarul Islam, police said. Moreover, two mobile phones were seized from her possession, one of which was burnt.

New Langya virus has

have caused infections in 35 people in China's Shandong and Henan provinces. It's related to Hendra and Nipah viruses, which cause disease in humans. However, there's much we don't know about the new virus known as LayV for short including whether it spreads from human to human. Here's what we know so far:Researchers in China first detected this new virus as part of routine surveillance in people with a fever and recent contact with animals. Once the virus was identified, the researchers looked for the virus in other people. Symptoms reported appeared to be mostly mild fever, fatigue, cough, loss of appetite, muscle aches, nausea and headache. Although the recovery time is still a mystery. A smaller proportion had potentially more serious complications, including pneumonia, and abnormalities in liver and kidney function. However, the severity of these abnormalities, the need for hospitalisation, and whether any cases were fatal were not reported. The authors also investigated whether domestic or wild animals may have been the source of the virus. Although they found a small number of goats and dogs that may have been infected with the virus in the past, there was more direct evidence a significant proportion of wild shrews were harbouring the virus. This suggests humans may have caught the virus from wild shrews. The researchers used a modern technique known as metagenomic analysis to find this new virus. Researchers sequence all genetic material then discard the known sequences (for example, human DNA) to look for unknown sequences that might represent a new virus. This raises the question about how scientists can tell whether a particular virus causes the disease. The authors acknowledge this new virus doesn't yet meet these criteria, and the relevance of these criteria in the modern era has been questioned. However, the authors say they didn't find any other cause of the illness in 26 people, there was evidence 14 people's immune systems had responded to the virus, and people who were more unwell had more virus. This new virus appears to be a close cousin of two other viruses that are significant in humans: Nipah virus and Hendra virus. This family of viruses was the inspiration for the fictional MEV-1 virus in the film Contagion. Hendra virus was first reported in Queensland in 1994, when it caused the deaths of 14 horses and the trainer Vic Rail. Many outbreaks in horses have been reported in Queensland and northern New South Wales since, and are generally thought to be due to ?spillover? infections from flying foxes.In total, seven human cases of Hendra virus have been reported in Australia (mostly veterinarians working with sick horses), including four deaths. Nipah virus is more significant globally, with outbreaks frequently reported in Bangladesh. The severity of infection can range from very mild to fatal encephalitis (inflammation of the brain).he first outbreak in Malaysia and Singapore was reported in people who had close contact with pigs. However, it is thought more recent outbreaks have been due to food contaminated with the urine or saliva of infected bats. Little is known about this new virus, and the currently reported cases are likely to be the tip of the iceberg. At this stage, there is no indication the virus can spread from human to human. Further work is required to determine how severe the infection can be, how it spreads, and how widespread it might be in China and the region.

London, August 11: Maybe Babe Didrikson, with Olympic gold medals in two separate athletics events and 10 major wins on the LPGA tour; perhaps Larisa Latynina, who won 18 medals over three Olympic Games; or Jackie Joyner-Kersee, with her back-to-back titles in the Olympic heptathlon; or Allyson Felix, who has just retired after winning more medals than any other runner in history. From Williams's sport there's Martina Navratilova, with 167 singles titles and another 177 in doubles, or Steffi Graf, who spent 377 weeks at the top of the world rankings.But all comparisons are odorous, and this one smells worse than most. Because if you've watched Williams play, listened and read what she has to say, then you have to wonder why anyone would want to try to put her, or any of them, in that one box. She's won more singles titles than any of them, more Olympic medals too, and did it all, as they used to say about Ginger Rogers, "backwards and in high heels". As Williams wrote in the Vogue article announcing her retirement (sorry, her "evolution") from professional tennis: "I went from a C-section to a second pulmonary embolism to a grand slam final. Vanessa Bryant's lawsuit over photos of Kobe's corpse begins in Los Angeles

Washington, August 11: Kobe Bryant was one of photogenic sports figures in Los Angeles and images of him seen by millions around the world - smiling in victory, grimacing in agony - keep his memory alive.But some photos of him should never be



seen, his widow says, and she's seeking unspecified millions in compensation for snapshots taken of the NBA star's corpse that were circulated after he was killed in a helicopter crash with their daughter and seven others in 2020. Vanessa Bryant's invasion of privacy trial against the Los Angeles county sheriff's and fire departments begins on Wednesday in a US district court just over a mile from where the basketball star played most of his career with the Lakers. A jury was promptly seated in the case, and opening statements were scheduled to start in the afternoon. Vanessa Bryant claims deputies did not take the photos for investigative purposes and shared them with firefighters who responded to the crash scene. The lawsuit said a deputy had showed the photos to bar patrons and a firefighter had showed them to off-duty colleagues."Mrs Bryant feels ill at the thought that sheriff's deputies, firefighters and members of the public have gawked at gratuitous images of her deceased husband and child," according to the lawsuit. "She lives in fear that she or her children will one day confront horrific images of their loved ones online."Kobe Bryant, his 13-year-old daughter, Gianna, and other parents and players were flying to a girls' basketball tournament when their chartered helicopter crashed in the Calabasas hills west of Los Angeles in fog. Federal safety officials blamed pilot error for the wreck. Vanessa Bryant has also sued the helicopter charter company and the deceased pilot's estate. The county has argued that Bryant has suffered emotional distress from the deaths, not the photos, which were ordered deleted by Sheriff Alex Villanueva. Officials have said the photos have never been in the media, on the internet or otherwise publicly disseminated and that the lawsuit is speculative about harm she may suffer. A law prompted by the crash makes it a crime for first responders to take unauthorized photos of deceased people at the scene of an accident or crime. The county already agreed to pay \$2.5m to settle a similar case brought by two families whose relatives died in the 26 January 2020 crash.

Prise, 26, told BBC Scotland: "For me it wasn't a race, it was an individual battle of survival. I never had any expectations of winning. At the mountain top plateau, the temperature was 2C (36.5F) with 30mph winds."You are swimming in a fjord for almost four kilometres (2.5 miles), that was 13C (55.4F). It's just you against the elements. The wind, the rain, everything. It was an incredible race and an incredible day. "The race begins by competitors leaping off the back of a car ferry into Hardangerfjord, before a mountainous bike stage, culminating in a full marathon that concludes atop Mount Gaustatoppen. Despite her success Prise, who has a full-time job, does not know if she will compete again. "I feel like I've done it once, won it once, I don't know if I could ever top that," she said.
