Guwahati, May 21 : Days after a COVID-19 recovered patient died of mucormycosis or black fungus at a hospital here, the Assam Health and Family Welfare Department on Friday released a Standard Operating Procedure (SOP) to contain the possible spread of the disease. The Union Health Ministry has already appealed to all the states and Union Territories to declare black fungus as a notifiable disease under the Epidemic Disease Act, 1897. The or-

der issued by the principal secretary to the Assam governments Health Department said, a large number of similar cases have been reported from other parts of the country, and there is a likelihood of an increase in the number of such cases in the future."In order to screen, diagnose and manage such cases of black fungus in COVID patients, the Standard Operating Procedure is notified with immediate effect," it said. 

RPF/NFR detected 11 cases of smuggling of contraband items during April

744 smuggling cases detected during last three years Guwahati, May 21: Railway Protection Force (RPF) personnel of N.F. Railway have been successfully recovering consignments of contraband items during regular checks and special drives at stations and trains over N.F. Railway. During the month of April 2021, Railway Protection Force successfully detected 11 cases on charges of smuggling along with recovery of contraband items. In one such case on 11.04.2021, at about 05.50 hrs, acting on information, officials of the Crime Investigation Bureau of RPF/Guwahati comprising Inspector/R. K. Bezbaruah, Sub Inspector/D. Kalita, Constable/K. N. Yadav and Constable/Binay Das, jointly with Crime Prevention and Detection Squad team of RPF/Guwahati conducted surprise check of parcel packages at Parcel Gate No. $02\,$ of Guwahati railway station. During surprise check they apprehended one person namely, Krishna Sahu, 30 yrs, s/o Laxmi Sahu, r/o House No. 24, Kharga Choudhury Road, Chatribari, PS-Paltanbazar, Dist. Kamrup (M) Assam with the recovery of 03 packages (without any booking mark) containing total 15 cartons foreign cigarettes (Total 1,50,000 sticks, made in Korea). The apprehended person failed to produce any document for possessing/carrying the recovered cigarettes and disclosed that he had brought those cigarettes for sending to Howrah by train. Later, the apprehended person along with the recovered cigarettes was handed over to Superintendent of Customs (Anti smuggling), Guwahati Division who registered a case vide No. 1/ CL/IMP/AS/GAU/2021-22 dated 11.04.2021. Value of the recovered cigarettes is Rs 7, 50,000/- approx. Government considers BBC shake-up after damning Diana report

London, May 21: Damning findings about Martin Bashir's 1995 Panorama interview with Diana, Princess of Wales, means the governance of the BBC and how it operates will have to be examined, according to a senior government minister. The comments by the justice secretary, Robert Buckland, came as the Metropolitan police said they would "assess" the contents of John Dyson's report "to ensure there is no significant new evidence", after previously deciding not to begin a criminal investigation. The Met said it had determined in March that "it was not appropriate to begin a criminal investigation into allegations of unlawful activity in connection with a documentary broadcast in 1995, but should any significant new evidence emerge it would be assessed". Asked by the BBC's Today programme about potential police involvement, Buckland said it was a matter for the police and the independent prosecutorial authorities, but he added: "I think anybody reading the headlines and the summary of Lord Dyson's findings will be struck by his use of those words, fraud and deception and the like, and clearly those sort of issues, I'm afraid, could and do arise."Dyson's report into how a BBC interview with Diana and the "very striking" reactions of her sons to its findings had raised "some very serious questions" for the broadcaster, Buckland said."The government has to, in the light of these serious findings, consider the matter very carefully and comprehensively indeed," Buckland told Radio 4's Today programme."Because it wasn't just the decision of a reporter or a production team, there were decisions made much further up the chain about the conduct of these individuals that have now proved, according to Lord Dyson, to be unfounded and wrong." And therefore, the government does have a responsibility to look very carefully to see whether the governance of the BBC does need reform in the light of these devastating findings."A former chair of the BBC, Michael Grade, meanwhile described Prince William's criticism of the BBC as "unprecedented" and called for "serious structural change" within the corporation." 'Not a lot of trust': Taiwan wrestles with home working in wake of Covid surge

Taipei, May 21: When Amanda asked a colleague to bring her laptop home from their tech-company office, anticipating that Taipei was about to join the ranks of global cities suddenly working remotely, managers refused to release it. She told him to grab it anyway, and soon enough the Taiwanese capital was placed under restrictions amid a shock coronavirus outbreak. Her company soon sent an officewide email saying that 50% of staff would be staying home."But it still had reminders that working from home means you are working at home and your equipment must be connected at all times, and you're expected to work eight hours and this is not a holiday," she says. Taiwan has recorded more than 1,400 cases of the Kent Covid-19 variant since Friday, the first large outbreak the island has experienced since the pandemic began. On Wednesday the whole island was put on alert level 3 of a four-tier system, which includes people being asked to work remotely where possible. It has caught people unaware, and is forcing businesses to address a deeply entrenched culture of presenteeism, which demands that people must show up to be counted."Taiwanese work culture is incapable of trusting that its employees can work effectively from home," says the Taipei writer Kathy Cheng, who collects anecdotes of various attempts at or refusals to allow working from home. 

Tokyo, May 21: A driver on one of Japan's shinkansen bullet trains is facing disciplinary measures after he abandoned his cab to go to the toilet while the train was carrying passengers and travelling at 150km/h. The 36-yearold driver, who has not been named, reportedly had a stomachache and asked a conductor to take his place while he went to the toilet. The conductor, who was not qualified to drive the Hikari-series train, sat in the driver's seat during his three-minute absence, but did not touch the controls, according to the Kyodo news agency. The incident happened last weekend as the train carried 160 passengers at high speed along the busy Tokaido line, which links Tokyo and Osaka. The driver might have got away with his unscheduled toilet break except for the fact that the train was subsequently one minute late, which prompted an investigation in a country famous for punctuality. Masahiro Hayatsu, a senior official of JR Central, which operates the train, apologised and told reporters the driver's actions had been "extremely inappropriate". Japan's super-efficient shinkansen rail network connects cities along the length and breadth of the country, with trains reaching speeds of up to 320km/h. The recent incident is thought to be the first in which a shinkansen driver left the cab while the passenger train was moving. A similar case in 2001 involved a driver who was operating an out-of-service train. Bullet trains have an enviable punctuality rate and an impressive safety record, with no fatalities due to a derailment or collision since they went into service in 1964, just before Tokyo hosted the summer Olympics.

Increased surveillance across the world

The variant that threatens the British summer has already done far more damage in India. In October last year a sample from the western state of Maharashtra containing what would later be identified as the B.1.617.3 variant was sequenced and uploaded to Gisaid, a global database of Covid-19 samples from across the world. The variant had multiple mutations located on the virus's spike protein that binds it to receptor cells in the human body. Some of these mutations were present in other variants, or seemed capable of evading immunity. All of this should have set off alarm bells in India and led to increased surveillance across the world. Instead, India's genome sequencing project continued to flounder through the rest of 2020. For most of last year, India did virtually no genome sequencing, Dr Gagandeep Kang, one of India's leading virologists, told me. While other countries submitted thousands of sequences to databases such as Gisaid for scientists across the world to study, India submitted only a few hundred. This was partly due to a lack of funding. It was also possibly the result of a lack of interest; last year, India's Covid curve appeared to be falling. At the end of 2020, the Indian government announced it was setting up the Indian Sars-CoV2 Genomics Consortium (Insacog) to increase genomic sequencing through a network of 10 laboratories. Its aim was to sequence 5% of all new detected cases. By Tuesday, India had submitted a little under 13,000 sequences - 0.05% of its total reported cases. Despite reporting about 400,000 new confirmed cases every day through the first half of May, India collected and submitted just 280 sequences over the last 30 days. Again, it's worth putting these numbers in perspective: according to Gisaid data, India has submitted 2,247 sequences of the variant first identified there in October 2020; the UK, where cases of the B.1.617 variant were first detected in February 2021, has submitted 3,706 to date. Epidemiologists across India have suggested the variant is driving the country's virulent Covid curve. This is also supported by data from Gisaid, which shows this variant has become dominant in badly hit states such as Delhi, Maharashtra, Karnataka and Tamil Nadu. The World Health Organization has classified the strain as a "variant of concern" because of its potentially increased transmissibility. But the question of whether this variant is linked to more severe cases of Covid-19 is more complicated. Experiments on hamsters suggest that infections with this variant result in a greater loss of body weight, higher viral load in people's lungs and pronounced lung lesions. The real-world evidence from India is harder to parse, in part because the sheer number of infections has overwhelmed India's health systems, leading to countless deaths from a lack of simple life-saving measures, including oxygen supply. In the western Indian city of Pune during the early days of the second wave, when there weren't shortages of beds and oxygen, there was no apparent increase in the death rate, the leading Indian immunologist Vineeta Bal told me. The question of whether this variant leads to more severe cases of Covid-19 is also closely related to vaccines. Over the last few weeks, at least three Indian states and two cities, including Pune, have shown signs of a vaccine effect - a decline in infections and deaths among elderly people, 40% of whom have now been vaccinated. Although some scientists and the WHO have suggested that antibodies acquired either from vaccines or from past infections might have reduced success in neutralising the new variant, the current consensus appears to be that the two vaccines being administered in India - the Oxford/AstraZeneca vaccine and the Bharat Biotech/Indian Counril for Medical Research's Covaxin - remain largely effective against the new variant as well. This new variant played a significant role in India's overwhelming second wave. But the suffering was also caused by India's costly mistakes. Religious and political mass gatherings such as a month-long election campaign and the Kumbh Mela festival went ahead. Such large gatherings resulted in increased social mixing and reduced adherence to distancing measures. The delays in genomic sequencing were potentially catastrophic, and not just for India. Meanwhile the country's vaccination drive, which already seems to be having a positive effect on the number of Covid cases, has been impeded by a combination of shortages stemming from insufficient planning, and hesitancy stemming from poor communication. There are already signs this wave could be peaking in India. To prepare for the next public health crisis. the country must learn the lessons from its second wave. In particular, the government must stop hiding behind a veil of nationalism. On Tuesday, one of India's most respected virologists, Shahid Jameel, resigned from his position as the chair of the scientific advisory group of the Insacog. Just days earlier, Jameel had written in the New York Times about the "stubborn resistance to evidence-based policymaking" that Indian scientists were facing, warning that "decision-making based on data is yet another casualty, as the pandemic in India has spun out of control".In place of data, there has been patriotic bluster.

ast Sunday saw one of the most dramatic antisemitic incidents in the UK in recent years. A convoy of cars, flying Palestinian flags, drove through Jewish neighbourhoods in north London and their occupants were filmed shouting antisemitic and misogynistic threats (aimed at Jews, not just Israelis). An upsurge in violence in Israel-Palestine is always accompanied by an upsurge in antisemitic incidents in the Jewish diaspora, including in the UK. As well as the convoy incident, we have also seen a number of others, including graffiti on a messianic Jewish synagogue in Norwich. Many activists responded quickly in condemning the convoy and pointing out that such actions don't help the Palestinians themselves (although some dismissed it as trivial or even as a "false flag" operation). But regardless of whether activists condemn it, such incidents will only deepen the suspicion many British Jews have that pro-Palestinian activism is irredeemably antisemitic. Disagreements over whether the Palestinian cause dis-

One way to break out of this impasse is to see the antisemitism issue as the most visible manifestation of a much wider challenge: how to manage the consequences of the popularity of the Palestinian cause.t's not that "everybody" supports the Palestinians, or pays lip service to doing so. In "western" countries, support for Israel is deeply embedded on the right, as well as in the centre and centre-left (albeit the latter is often combined with support for a Palestinian state within the framework of a two-state solution). The current situation of the Palestinian people is proof enough that sympathy towards their plight is not universal enough to have actually led to a change in their circumstances. When I talk about the popularity of the Palestinian cause then, I am referring not to the sum total of its impact, but to the diversity of supporters it attracts. And it is that diversity that leads not just to bitter conflicts over the place of antisemites within this disparate movement, but also to much wider - and rarely addressed challenges in defining what international support for the Palestinians means. Take the large demonstration held in London last Saturday. It was prompted by outrage at Palestinian suffering in Gaza, Sheikh Jarrah and elsewhere. Beyond that, what did it actually mean? Social media quickly identified some of the most outrageous attendees - the far-right antisemite Michèle Renouf and two young men in Saddam Hussein T-shirts - but there was much more to the dem- midst of a demonstration.

onstration than that. Some protesters wielded Turkish flags, others held banners printed by the Socialist Workers party. Muslims played a prominent part in the march and there was also a Jewish contingent, but just pointing to the presence of Jews and Muslims does not do iustice to the diversity present within both broad categories. The demonstration itself was organised by groups in which leftwing activists play an outsized role, such as the Stop the War coalition, as well as Muslim organisations such as Friends of al-Aqsa. This diversity allows both supporters and detractors to derive their own meanings for the march: the presence of neo-Nazis, supporters of authoritarian regimes and Islamists can be seen as proof of the irredeemable corruption of the whole enterprise. Conversely, one could also point to the strong presence of one's own type of activists as proof that they provide the inner meaning of the march: the strong turnout from leftwing activists (Jeremy Corbyn was one of the speakers) could allow supporters to see the wider cause as intrinsically part of the left. All we can say with certainty about the march is that outrage bound it together, without any kind of unanimity of what the vision for Palestine (or Israel) should be. The danger posed by the diversity of this and other marches for Palestine is that those who participate will see themselves as legitimated for everything else they do too. The very visible presence of the Neturei Karta - a strictly orthodox anti-Zionist sect - at pro-Palestinian demonstrations, has often been leveraged as a way of "proving" that one's own pro-Palestinian activism can never be antisemitic. And even if there is no evidence that the participants in Sunday's antisemitic convoy attended Saturday's demonstration, they may well have drawn succour from the protests across the world that they were indemnified for their actions in advance. Effective politics requires collective action and cooperating with others in the pursuit of common goals. This raises complex issues over where that cooperation should stop, and how to prevent being used as a useful idiot by those with antithetical agendas. In the heat of anger and emotion generated by the current violence in Gaza, it is hard to engage with these questions, particularly in the

Rising crude oil prices boost Indian Oil Q4 profit



CHENNAI, May 21: A substantial rise in crude oil prices gave Indian Oil Corporation's net profit a solid boost in the quarter ended March 31, 2021, with the state-run oil refining and marketing major recording inventory gains of Rs 8,622.25 crore during the period. The company's standalone net profit came in at Rs 8,791.9 crore for the quarter, compared to a net loss of Rs 5,185.32 crore during the corresponding period of last year and 49 per cent higher than the Rs 4,916.6 crore recorded in the previous quarter ended December 2020. Inventory gains are made when the value of crude oil stored by the company rises in tandem with market prices, while inventory losses happen when market prices of the stored crude falls. Over the period under review, International Brent crude oil prices rose around 23 per cent. The result was a 52 per cent jump in inventory gains from the Rs 5,622 crore recorded during the previous quarter. The company had recorded an inventory loss of Rs 744.6 crore in the corresponding quarter of the previous year. The company also recorded a robust rise in revenue at Rs 1.63 lakh crore against Rs 1.40 lakh crore in the corresponding quarter of last year and Rs 1.46 crore in the previous quarter ended December 2020. Indian Oil's gross refining margins (GRM), the amount of money the company makes from processing a barrel of crude, saw a jump during both the quarter and the full fiscal year-coming in at \$5.64 a barrel in FY21 against \$0.08 in FY20. In the March quarter, GRM stood at over \$10, said IOC Chairman S M Vaidya. On the impact of the second wave of the pandemic on fuel demand, Vaidya said that it has not been as severe as the first wave. "Demand destruction... is very much there but not to that extent," he added. According to the chairman, the second wave so far has resulted in petrol and diesel demand falling by around 15-20 per cent compared to the 49 per cent plunge in April 2020 after imposition of the nationwide lockdown.

Mumbai, May 21: "Toyota 80th Anniversary Celebration! Through the questionnaire, you will have a chance to get a Toyota corolla." If you come across this message on any of your social media platforms, beware!This message which has a link attached is doing the rounds on social media. It urges readers to click on the link and fill up a form that asks for their personal details. The questionnaire page also prominently displays fake comments seeming to be from people across the world. Some of the comments include: "I thought it was a joke but this morning I received a Toyota Corolla and would like to take more surveys!" and "I thought it was a joke, but it arrived this morning!".The red flags begin as they say right at the very beginning. Toyota was launched

on August 28, 1937. Hence, the company had completed its 80th anniversary on August 28, 2017 - not now. The carmaker had tweeted about its celebration back in 2017 too: It is evident from the link that it is not officially sent by

the company. The link 'http:// freegifts.758-985.cn' does not contain the company's name or its domain. When The New Indian Express crosschecked the IP address on Geotek Datentechink's IP checker, it revealed that '.cn' is a Chinese-registered domain. When readers click on the link, it takes them to another page that claims to give away a Toyota Corolla car if they take up the survey. If we take a close look at the page, we can spot many grammatical errors, which is something a wellestablished company like Toyota would not do. Also, it is said that in the history of Toyota, it has never given away cars for free. So, if you come across such a message or link, refrain from clicking on it and save yourself from falling prey to online fraud.

People were urged to use masks while visiting dusty construction sites, wear shoes, long trousers, long sleeve shirts, and gloves while handling garden soil, moss or manure, maintain personal hygiene and seek immediate medical attention in case they develop the symptoms. The death of a 27-year-old COVID-19 recovered patient due to black fungus in Assam on Wednesday was the first such case reported in the northeastern state.

With this there will pressure on the Arvind Kejriwal government to lift the lockdown in place in Delhi. The number of daily cases recorded in the past 24 hours is also the lowest since April 1. Meanwhile, India's daily positivity rate has declined to 12.59 per cent, the Union health ministry said on Friday. Over 20.61 lakh tests COVID-19 tests were conducted in a span of 24 hours in the country, the highest-ever tests done in a single day.

India prepares for Cyclone Yaas

evacuation, rescue and restoration work in states affected by Cyclone Tauktae on the western coast are being called back, they said. The National Disaster Response Force (NDRF) Director General S N Pradhan tweeted that the force has decided to "airlift" West Bengal and Odisha-based teams of the force in view of Cyclone Yaas and its "possible impact" in the coastal districts of the two states. The exact number of NDRF teams to be earmarked for the latest cyclone will be decided as per inputs received from the India Meteorological Department. The situation is developing, the officials said. The central force had earmarked a total of 101 teams for the extremely severe cyclonic storm Tauktae that developed in the Arabian Sea and mainly affected the coastal areas of Gujarat and states like Maharashtra and Goa, apart from a few others on the western coastline of the country. Tauktae made landfall on Monday night near Una town in Gir Somnath district of Gujarat and wreaked havoc for around 28 hours before it weakened into a depression. Each NDRF team has 47 personnel who are equipped with tree and pole cutters, communication gadgets, inflatable boats and basic medical aid. Due to the COVID-19 spread, these teams have been provided orange-coloured full-bodied personal protection gear that includes a face shield for each rescuer. The NDRF has earlier said that most of its troops deployed for these operations have been vaccinated for coronavirus. Talking about Yaas, the IMD had on Thursday said that a low-pressure area is very likely to form over the north Andaman Sea and adjoining east-central Bay of Bengal around May 22. It is very likely to intensify gradually into a cyclonic storm during the subsequent 72 hours. It is very likely to move northwestwards and reach West Bengal-Odisha coasts around 26th May evening," the Cyclone Warning Division of the IMD had said. The name Yaas has been given to the potential cyclone by Oman, as per a standard protocol of naming such cyclonic storms in rotation by affected countries in the same area. The name Tauktae was given by Myanmar, and it means gecko or a small lizard.

The industry, which has still not recovered from last year's Covid-19 lockdown and paralysis, may now witness a 40% crop deficit in the first five months of this year due to poor rainfall across the state, says a study carried out by the North Eastern Tea Association (NETA), an organisation of tea producers. "The year 2021 has been an unusual year so far for the Assam tea industry as far as production is concerned. A study has been carried out to assess the crop loss due to the impact of a prolonged droughtlike situation. It took into account the rainfall received in the last few days," said Bidyananda Barkakoty, adviser, NETA. "As per our study, the crop deficit from January to May this year will be about 60 million kg compared to the same duration in 2019. We have not compared crop figures with the year 2020 because last year the crop deficit from January to May was 78 million kg due to Covid lockdown. In percentage terms, the crop deficit from January to May this year will be about 40% compared to the same period in 2019."The average rainfall deficit is about 45% from January to April this year compared with the same period last year in the key tea-growing districts of Assam: Golaghat to Tinsukia. Comparative studies also reflect that these days the rainfall distribution is highly localised and there is a vast difference in the quantum of rainfall within a few kilometres. During the Covid-hit 2020, Assam lost around 78 million kilograms of tea compared to January-May 2019. The revenue loss was to the tune of Rs 1,128 crore, according to the study carried out by NETA. "Last year the crop deficit was at least commensurate by price initially even though it faltered towards the end of the season. But this year, we are yet to see the price appreciation which has added to the industry's woes of production loss," said Dipanjal Deka, secretary of the Indian Tea Association. Extreme weather fluctuations, both in terms of temperature and rainfall, have impacted the growth of tea leaves severely. A temperature drop from 34 to 19 degrees Celsius coupled with hardly any sunshine for the past one week, preceded by temperatures above 34 degrees Celsius is catastrophic for the crop in its peak production phase, say industry people."We do not remember facing such a prolonged drought in the last 30 years. Apart from the huge loss of crop due to rainfall deficit, the drought at the very beginning of the tea season has also delayed the application of fertilisers by around two months.

441 fresh cases recorded, three more people die of COVID 19 in Nagaon district

Including these three death cases, a total of 39 people have been died of COVID 19 in the district, sources said. Meanwhile total 288 COVID positive patients have been recovered from the virus today, taking the total recovery cases in the district to 4019, sources further added. Sources claimed that among those who tested positive today, 70 positive patients were immediately admitted to Nagaon COVID hospital as well as to COVID Care Centres set up in the district while the rest were put in home quarantine. Rapid Antigen Test was conducted on 4471 people today while RT-PCR test was conducted on 55 swab samples, sources said adding further that the district administration today declared three villages - Teliagaon, Dolapani under Kaliabor revenue circle, Bogoriguri village under Nagaon Sadar revenue circle and Amsoi tea estate under Raha revenue circle as containment zones today due to rapid spreading of novel corona virus in those areas so far. Meanwhile, one centenarian woman, hailing from Jajari Bogoriguri village in the district, tested positive for COVID 19 today. The woman was immediately admitted to Nagaon Dhekial Phookon College based special women COVID Care Centre today. Talking to this correspondent here this afternoon, Dr Surajit Bhagabati, the principal of Nagaon ADP College said that the college authority in association with the district administration set up a special women COVID Care Centre in the Indoor stadium of the college campus only for asymtomic women COVID positive patients. In this special CCC, there are seventy beds with almost all medical facilities including sufficient physicians as well as nursing assistants. In an instant, Mardle remembered why he had given up the game more than a decade ago. "I can honestly say I was fraught with the pressure, with the tension," he says. "My head was swimming, my arm was tight, my hand was cold, my feet were freezing. I don't want to be that pressurised ever again. And you know what? I absolutely hated it."It is a recollection that may surprise those who remember Mardle as one of the sport's consummate showmen. Back then it was the loud Hawaiian shirts and the dancing on stage; these days it is his strident, surgical punditry for Sky Sports. But over the course of an hour-long interview, and the memoir it is promoting, what becomes clear is that behind the flamboyant character of "Hawaii 501" lies a man defined as much by reflection and regret as by pride and big-time swagger. He was some player in his heyday, emerging out of the pubs of Essex to become one of the sport's superstars. Like his mentor Bobby George, Mardle threw with a street fighter's heart and a conjuror's flourish: playing up to the crowd, grinding out the big moments, milking the spotlight for all he could. He reached five world

US PGA: Corey Conners takes overnight lead with Brooks Koepka in contention

London, May 21: Those taking interest in Brooks Koepka's preview press conference at this US PGA Championship may have sensed an unwitting stumble into an episode of Grey's Anatomy. Some 16 out of 17 questions posed to Koepka related in some way or other to matters of injury. Therein lies the reason it has been easy to forget Koepka's one-time - and recent - specialism on these platforms. Fitness woes, apparently prolonged by knee surgery just weeks before the Masters, have threatened to undermine the Floridian's quest for greatness. Two of the 31 year old's major triumphs to date came in this event. Koepka missed the cut at Augusta National last month. He should have no such problems on Kiawah Island. Koepka's 69 meant early prominence in the second major of 2021. By close of play, he was two adrift of the inspired Corey Conners, who claimed the overnight lead. The Canadian hit six birdies and just one bogey to card a five-under-par 67. Koepka ends the first round in jointsecond with five other players - 2011 winner Keegan Bradley, Viktor Hovland, Aaron Wise, England's Sam Horsfield and Australia's Cam Davis. His showing was all the more admirable given the double bogey he produced at the 10th, his 1st. What seemed like hours later I saw the next marker in the distance. Eighteen miles. The huge number 18s. Again. Not a 19 in sight. My mind had added a mile. It broke me. By the end I was going so slowly I could talk to the crowd. "Don't ever do this. It's not worth it." I finished. But I didn't run it. There's a difference. Never again, I promised myself. And then the following year 16 of my friends decided to tie themselves together to get a world record. I signed up; I wanted the attention. Colin Jackson interviewed us on Tower Bridge on BBC1! Five and a half hours. I made a solemn promise with one of the others. Remember this pain. Never again. Never. Then a few months ago, buoyed up by a competitive WhatsApp group of pretty much those same friends I was tied to 15 years earlier, and the Strava app to continuously tell you when everyone else has gone running something finally clicked.Running has succeeded in helping us in some small way remember the importance of our friendshipsIt turns out the pain of running relatively quickly is identical to the pain of running incredibly slowly - it just takes less time. NBA play-in game to book playoff date with 76ers Washington, May 21: Russell Westbrook and Bradley Beal did what they do a near triple-double for one, 25 points in just 29 minutes for the other and the Washington Wizards reached the NBA playoffs as the Eastern Conference's No 8 seed by overwhelming the Indiana Pacers 142-115 in the play-in round Thursday night. Washington led by as many as 38 points and advanced to face Joel Embiid and the No 1 seed Philadelphia 76ers in the first round, marking quite a turnaround for coach Scott Brooks' crew, who were 17-32 in early April.Indiana's run of five consecutive

playoff appearances ended in coach Nate Bjorkgren's debut season. A little more than a week after breaking Oscar Robertson's career record for most regular-season triple-doubles, Westbrook finished Thursday with 18 points, 15 rebounds and eight assists, and it was Beal second in the NBA in scoring two years in a row whose threepointer opened up a 30-point lead at 98-68 with about four minutes left in the third quarter.Beal skipped the fourth quarter

entirely. Westbrook sat out the last eight

was Beal who has been dealing with a strained left hamstring wind-milling his arms as he and his teammates poured it on, hitting 58.1% of their shot attempts; the visitors only finished above 40% thanks to some fourth-quarter baskets long after the outcome was decided.Malcolm Brogdon led Indiana with 24 points. Pacers All-Star Domantas Sabonis had a triple-double with 19 points, 11 rebounds and 10 assists before fouling out early in the fourth quarter. Philadelphia's Joel Embiid and Golden State's Stephen Curry didn't get listed on a single ballot a year ago. A year later, one of them will walk away with the NBA's highest individual prize. Joki?, Embiid and Curry were revealed Thursday night as the three top votegetters for this year's NBA MVP award, one that will be presented sometime during the playoffs. Curry is a twotime winner, Jokic's best previous finish was fourth in 2019 and Embiid's best MVP showing was seventh in 2019. Joki? would be the first Denver player to win MVP. Embiid would be Philadelphia's first winner since Allen Iverson in 2001 and Curry could become the ninth player in NBA history to win the trophy three times. The 18 top-three vote-getters in six award categories - MVP, coach of the year, most improved player, rookie of the year, defensive player of the year and sixth man of the year - were announced Thursday. The Utah Jazz, who finished with the NBA's best record and homecourt advantage throughout the playoffs, had a league-best four finalists. New York, back in the playoffs for the first time since 2013 as the No. 4 seed in the Eastern Conference, had three award finalists. The Jazz and Knicks swept the top-three spots in the sixth man of the year category, with Jordan Clarkson and Joe Ingles both making the list from Utah and former NBA MVP Derrick Rose from New York getting a finalist nod there as well.

They did not lose their focus when that period brought no reward, the batsmen regrouped and in successive overs both completed half-centuries. After being put in to bat in tough conditions, under leaden skies with the floodlights on and that vicious wind whipping across the ground, Burns survived an uncomfortable opening over from Tim Murtagh but settled from there, and

Stoneman had narrowly beaten him to the milestone, also with a four, and less happily their dismissals also came in successive overs.
