The accident took place in a residential community in the city's Zhangwan district at 6.30 a.m., trapping a large number of people. Leonardo ... then vanish? London, June 13: The National Gallery is facing controversy over its role in the tangled story of how the world's most expensive painting emerged from obscurity before being sold for a staggering £320m, only to vanish again from the public eye. The gallery exhibited the Salvator Mundi in its Leonardo da Vinci exhibition a decade ago when it was an unknown work with doubts about its attribution, restoration and ownership. The criticisms are voiced in a major film documentary that lifts the lid on some of the murkier dealings of the art market. Professor Bernd Lindemann, the then director of the Gemäldegalerie in Berlin, tells the film-makers: "I was surprised to see the painting in the exhibition at the National Gallery. It is a problematic painting, and I think it's not the role of serious museums to present a painting which is so heavily discussed."The Gemäldegalerie, which has one of the world's most important collections of European paintings, was among the owners of public and private collections contacted by the painting's former owners - a consortium of dealers - who were struggling to find a buyer.In the documentary, The Lost Leonardo, Lindemann recalls the approach, and that he was unimpressed that the picture had been so extensively reworked by a restorer. "One day I got a telephone call. It was a dealer and he said he has something which could be interesting for the Gemäldegalerie. That was the painting. Most of the painting is a remake and this was, for me, the argument to say, 'No, this is not a painting for the Gemäldegalerie'."The National Gallery unveiled the painting in its 2011 Leonardo exhibition. Although there is an unwritten rule that public galleries should not display pictures that are available for sale, one of the former owners has insisted that it was not for sale when the show was announced. Hanging an unknown picture in such a prestigious institution would have done wonders for its market value. The painting's whereabouts cannot be traced earlier than 1900, when it was sold as the work of Leonardo's follower Bernardino Luini for £120. When it was purchased in 2005 by dealers Alexander Parrish and Robert Simon for \$1,175, it was seriously damaged and Dianne Modestini began work on a restoration programme that was so extensive that it lasted from 2005 to 2017. It went on to sell at Christie's New York for a record-breaking \$450m (£320m) in 2017, only to disappear without trace. Doubts about it only intensified, with the Louvre in Paris later downgrading it to the work of a lesser contemporary hand. Onlookers extinguish flames after man set alight outside Perth church

London, June 13: Perth detectives are investigating reports a man was set alight outside an inner city church.Police say the 68-year-old suffered significant burns after he was approached by another man on Beaufort Street in Highgate around 5pm on Saturday. Moments later he was on fire while the other man left the scene. Police say a number of people assisted the victim, pouring water over him to extinguish the flames. He was rushed to Fiona Stanley hospital by St

John Ambulance for treatment of burns to his face, upper body and hands. According to 7NEWS, emergency crews arrived at a soup kitchen outside the church after the man was doused in petrol and set alight.A witness in the kitchen at the time told the network bystanders were able to bundle the man into a shower before ambulance officers got there.Detectives say they want to speak to anyone who witnessed or has information regarding the incident.

Millions of Peruvians joined together to deliver a telling blow

Peru's presidential election has been settled by the slimmest of margins, but it signals a momentous change. When all the votes from the second-round run-off on Sunday 6 June were finally counted, the socialist Pedro Castillo, former head of the main teacher's union, held a razor-thin lead of about 60,000 votes - 0.34% - over Keiko Fujimori, candidate of the right and daughter of former Peruvian president Alberto Fujimori. She has now launched accusations of fraud, demanding that as many as 200,000 votes be nullified. It may take several days for her legal challenges to be heard, and she is clearly still hoping to overturn the result though the prospect is unlikely. The fact remains that millions of Peruvians joined together to deliver a telling blow to the political and economic model that has dominated the country for the past three decades. The electoral drama in Peru was in that sense a generational reckoning, comparable to the recent upheavals in Chile and Colombia. But it was also the product of the specific political crises Peru has endured in recent years. Since 2018, the country has had two presidents impeached and removed on charges of corruption and one hounded from office by a surge of protests. The sleaze and dysfunction of the established parties was one of the factors that enabled Castillo's shock breakthrough in the first round of voting in April.Until then he was known mainly for leading a protracted teacher's strike in 2017, and his party, the avowedly Marxist-Leninist Perú Libre, had no seats in Congress. With only 19% of the vote, he finished first in a crowded field of 18 candidates. Combining redistributive economic policies with socially conservative views, for instance on same-sex marriage, Castillo looks, dresses and talks like the population of Peru's longmarginalised interior provinces. Fujimori, by contrast, is the arch-insider, having been one of the most powerful players in Peruvian politics for more than a decade. She has run unsuccessfully for president twice before, in 2011 and 2016, and heads the Fuerza Popular party, which held the majority in Congress from 2016 to 2020. The 13% she scored in April, though a remarkable drop from the 40% she secured in the first round in 2016, was still enough for her to scrape through to the run-off. The second-round campaign at once dramatised and deepened Peru's stark socioeconomic, political and cultural divides. First, it drew attention to the gulf separating the more prosperous coast from poorer highland regions, which have a larger indigenous population. Castillo, who is from the northern mining region of Cajamarca, drew his support overwhelmingly from the highlands, which saw few of the benefits of the boom years of the 2000s and early 2010s. The Lima-based elite's attitude to such disparities is perhaps best captured by a phrase Fujimori let slip during a presidential debate held in rural Cajamarca in early May, when she complained of having "had to come all the way here". (She said afterwards this was a reference to the difficulty of the journey.) A second crucial fault-line separated Keiko Fujimori's supporters from those determined to reject the authoritarian legacy of her family's dynasty. Alberto Fujimori, in power from 1990 to 2000 and currently serving a 25-year sentence for corruption, claims credit for defeating the Maoist Shining Path insurgency and imposing macroeconomic discipline on the country. However, these measures were implemented through harsh anti-democratic means: in 1992, Fujimori susended the constitution, and the following year wrote a new one granting himself even greater powers. His decade in office was marked by abuses that scar the country to this day, including extrajudicial killings, the forced sterilisation of as many as 270,000 women and colossal corruption. Widespread rejection of this legacy proved enough to block Keiko Fujimori's path to the presidency in 2011 and 2016. But in 2021, faced with a candidate from the radical left, she was able to mount a scaremongering campaign. In Peru, leftist candidates and parties are routinely denounced as "terrorists", tarred by association (however fictional) with the Shining Path, or with Cuba or Venezuela. Fujimori conjured these spectres to bring liberals, centrists and the centre-right into the fold. ("Do you want to live in Cuba?" asked a billboard in Lima before the 6 June vote.) Many prominent figures who had previously opposed her - including Nobel prize winner Mario Vargas Llosa, who had run for president against Fujimori's father in 1990 joined the chorus against Castillo, as did most of the Peruvian media. Trailing by several points in early May, Fujimori steadily closed the gap. But not quite enough. While she did well along the coast, Castillo piled up huge margins in the highlands. This included astonishing victories in the regions most deeply affected by the armed conflict of the 1980s and 1990s: he won 83% of the vote in Ayacucho and 89% in Puno, for instance. The suffering and economic dislocation caused by the Covid-19 pandemic was a third crucial factor in the election, turning longstanding structural inequalities into immediate matters of life and death. By May 2021, Covid-19 had taken an estimated 180,000 lives in Peru, giving the country the highest per-capita fatality rate in the world. Not surprisingly, Castillo's election platform begins by declaring health a basic right and denouncing the neoliberal model's abject failure to provide for Peru's citizens. It also contains ambitious plans to hold a referendum on drafting a new constitution, to nationalise key natural resources, and to overhaul the agricultural sector, favouring peasant smallholders over giant agro-exporters. Yet as the closeness of the contest suggests, Castillo faces formidable obstacles to implementing any of his agenda. It will no doubt encounter stiff opposition from entrenched elite interests and coastal middle classes hostile to the left. Then there is the highly fragmented composition of the Congress, in which Castillo's party holds only 37 of 130 seats. The riven geography of the vote also points to a profound political polarisation that will make coherent policymaking difficult.ut for all that, the outcome of the election in itself offers some cause for optimism. After several years in which the right seized hold of the agenda in Latin America, Castillo's win will raise the hopes of the region's left. For Peru, it holds out at least the possibility of a future beyond the demoralising corruption and life-threatening disparities of the neoliberal model.

India can become a leader in sustainable aviation fuel - with feedstock and solar power

he Covid-19 pandemic has brought global systemic chal lenges like climate change to the forefront. If not tackled in a timely manner, it will be the cause of greater disruptions than we have witnessed from the pandemic. Nation-states need to build resilience and continue raising awareness towards sustainable living to protect our ecosystems and our economies. The humbling situation in India due to the pandemic has reinforced the need to critically examine the relationship between resilience and sustainable development in particular in the country's megacities. India's transition towards clean, affordable and renewable energy can better prepare the country to resist global shocks. But the fifth-largest economy in the world has a far way to go. It relies on extensive energy consumption, which stands at 910 MToe which in turn, translates to roughly a rise of 20% every five years since 1990. According to the International Energy Agency, India will experience the largest increase in energy demand through 2040 of any country in the world. Moreover, according to an air quality report by IQAir, 22 of the world's 30 most polluted cities are in India. While India has succeeded in reducing its emissions to GDP growth ratio, it has not yet achieved a full decoupling, thus India needs to significantly accelerate its progress to date in delinking economic growth and environmental degradation. The good news is that today, technology exists to convert garbage, used cooking oil or agriculture residues into valuable inputs that can be used, for instance, to make Sustainable Aviation Fuel (SAF) for airplanes the world over. Aviation emissions and waste are two major issues that will need to be resolved in the coming years, and SAF presents an opportunity to address them both.SAF is a cleaner fuel produced from sustainable feedstocks derived from various types of waste, by-products of agriculture, or power-to-liquid using hydrogen technology. From a similar molecular structure and chemical properties to traditional fossil jet fuel, SAF has the added advantage of being able to be dropped into existing aircraft systems without any technical change or investments. In fact, all aircraft today can handle the current maximum certified blend of 50% SAF - and more than 330 000 flights around the world have been powered by it.SAF is for now two to five times more expensive than fossil fuel, but costs will come down with volume, and the transition to cleaner fuels would

contribute substantially to solving climate change. SAF can be 100% less carbon-intensive over its life cycle compared to conventional fuels. The "Deploying Sustainable Aviation Fuels at Scale in India" Report is a Clean Skies for Tomorrow Publication, a result of The World Economic Forum driving a coalition of private and public organisations in India that have contributed analysis on technology pathways and feedstocks availability and sustainability for the ramp up of SAF production in India. The report demonstrates that SAF is the most achievable and effective pathway to reducing aviation's lifecycle emissions in the immediate future. It also proposes key methods, cost-sharing models, and economic and environmental benefits for accelerating the SAF industry in India, and shows how advancing this industry would have compound effects in the management of waste and prevention of crop burning from farmlands, the latter of which has become a huge contributor to the pollution levels in Indian cities that are far beyond safe limits. First, infrastructure must be created to produce fuel from the raw materials of garbage, used cooking oil or agriculture residues. Secondly, a supply chain must be put in place to purchase residue from farmlands and household waste to provide fodder to various facilities to produce fuel. This will benefit the management of household waste and promote recycling - as well as generate 120 000 jobs and enhance grassroots prosperity. That will accelerate significant macroeconomic opportunity throughout the value chain, unlock market forces and drive green innovation. As a starting point of 10% SAF blend, India can achieve cleaner skies with less-open air crop burning, create 120,000 new jobs and catalyse efficient waste management systems that will have significant societal benefits. It would also represent a leap towards self-reliance that would add \$2.7-2.8 billion to India's GDP by 2030. The aviation industry has been hit hard by COVID-19, but the sector has started to recover - at least domestically. In the coming years, India's aviation sector is expected to grow in double digits, and pandemic aside is still likely to expand to become the third-largest air passenger market by 2030. Given the expected growth in domestic travel, decarbonising the aviation sector is essential for India to remain committed to its Nationally Determined Contributions (NDC). The 2015 Paris Agreement excluded the international aviation sector due to difficulties of attributing emissions from complex international supply chains to individual countries. As a result, the International Civil Aviation Organization member states designed the Carbon Offsetting and Reduction Scheme for International Aviation (CORSIA) with an initial target of achieving carbon-neutral growth for the sector from 2020. While over 88 states have agreed to pilot the CORSIA scheme from 2021 - 2023, India is currently working with its own national targets for the aviation sector to

bal leader in low-carbon aviation fuel, India must develop a robust roadmap to examine low-carbon solutions for aviation. The aviation sector is among the most organised sectors globally, with strong public-private cooperation. Developing countries such as India are expected to gain immensely from strategically deploying sustainable aviation fuel early on. However, if India doesn't take the first-mover advantage in the utilisation of SAF, India's growing domestic aviation volume inevitably will diminish compliance with its climate change commitments. Support from the government by way of aviation-related and climate-conscious policies and incentives would accelerate efforts to make India net-zero in aviation by 2050. The Indian National Policy of Biofuels has been very clear in supporting feedstocks that do not conflict with food supply, ensuring land use concerns are accounted for. Fostering a SAF industry would not only reduce emissions in aviation, but it would also combat air pollution from crop burning, create numerous green jobs, improve farmers' incomes and help solve waste management issues. Turning waste into fuel is critical to combatting climate change. In each case, a critical life cycle analysis (LCA) of feedstock and production pathways should be undertaken. Technologies should be evaluated both on LCA and economic logic to ensure as level a playing field as possible, including factors such as land-use change and biodiversity implications. Second wave has abated and I have lost my wife. It is time I thanked these strangers

coronavirus pandemic is now ebbing but the loss of April and May is irreparable. My wife had tested positive for Covid-19 on 10 April 2021, hospitalised on 15 April, and was put on ventilator support on 27 April, on which she remained till her last breath on 24 May. During this distressing phase, there was helplessness in all corners. As is the case of many citizens who lost their loved ones. Pain amplifies to see your loved ones dying alone, with no one around to hold their hand during their final moments, reduced to a vegetative state, they never got a chance to share their last wish. No one can ascertain if death came as a relief from the suffering or as a final punch of pain. During these difficult times, our faith in humanity never failed, thanks to many strangers who helped like if they were god-sent angels. The trauma faced will never allow many of us to be the same again. While my wife was grappling with the virus, I, to whom she had devoted her life found myself incapacitated. All I could do was to see her die bit by bit. The so-called effort made to arrange money, medicines and praying rather than begging the almighty to spare her life in the end proved futile. On 20 April, doctors asked us to arrange for remdesivir. I called up all chemists, hospitals, drug distributors of various companies, chief medical officer, DM's office among others, but all in vain. After much struggle, I was told that the medicine was available in Delhi but to my horror multiple chemists refused as my wife was admitted in Noida and their orders were to give medicine only to Delhiites. A couple of days later, a similar story played out in Noida where a dealer refused to give remdesivir to a patient admitted in Delhi because of the 'DM's order'. It is difficult to explain the mental state, trauma and pain when you are denied a lifesaving drug because of such unbelievable orders.Frustrated

¬ he second wave of the and desperate, I turned towards black marketeers but as luck would have it, no 'help' came from them either. As a last-ditch effort, I turned to social media. To my surprise, there were enough commoners who came forward to help. In fact, I was able to arrange four vials of the drug from different people and they refused to take a single penny.On 30 April, I was asked to arrange for plasma and yet again it was a commoner who came to our family's rescue and donated. The experience was the same while arranging other medicines such as moi-stir, posaconazole injection, among others. All this support came from people whom I had never met and do not expect to meet in future. They came forward without even an iota of **Sanjeev Choudhary** self-interest.

Despite the pressure, doctors, nurses, and the cleaning staff did a stellar job. I could see a sense of frustration building up in them because of the lack of medicines, oxygen, rest and dealing with patient's relatives. They were fighting a two-front war, one with the virus and the other with anxiety and fatigue, with their hands tied behind. Their contribution is second to none. On 19 April, my wife's oxygen saturation level dropped to 59 [the normal level is supposed to be 95+]. She was sinking and nothing seemed to improve her state. A young doctor struggled for nearly three hours to get her saturation to 88. I was later told that this doctor had come back from rest only because the patient needed undivided attention, which the doctor on duty could not have provided. In another kind gesture, an ICU staff got juice for her, paying from his own pocket. Then there was the nurse who called me at 06:45am on 27 April for me to speak to my wife as her condition deteriorated. This deviation from standard practice could've cost



she chose her patient over the

protocol. That phone call was the last time I spoke with my wife as at around 08:45am the same day, she was put on ventilator support to never recover. Such medical staff make the hospital journey less painful. I thank all these warriors from the bottom of my heart. On 27 April, I reached the hospital at 07:15am but was not allowed to meet her as the protocol mandated, thus denying me the opportunity to talk to her in person for the last time. The pain of it will remain with me for rest of my life. On 24 May, when she died, I was in the ICU near her lifeless body and could hear two nurses giggling. It was excruciating but I remained silent. Later, I realised that the hospital staff was witnessing death on a daily basis and still had to keep their motivation up to deal with the next patient. The high frequency of casualties had made some of them build a wall around them to cope with the situation. Market forces are cruel and the business of healthcare is part of it. Delta Variant Can Infect Despite Covishield, **Covaxin Doses: AIIMS Study**

New Delhi, June 13: The 'delta' variant of COVID-19 - the version first detected in India in October last year - is capable of infecting people even after they have received both doses of the Covaxin or Covishield vaccines, according to separate studies by AIIMS (Delhi) and the National Centre for Disease Control (NCDC).It is important to note that neither study has been peer-reviewed as yet. The AIIMS study suggests the 'delta' variant - which others, including one by British health authorities, say is between 40 and 50 per cent more infectious than the 'alpha' version first reported from the UK - is likely behind the majority of breakthrough infections in India. The AIIMS-IGIB (Institute of Genomics and Integrative Biology) study was based on an analy- studies indicated the 'alpha' variant sis of 63 symptomatic patients who is also proving resistant to Covishield

Of these 63 people, 53 had been given at least one dose of Covaxin and the rest at least one dose of Covishield. Thirtysix had received both doses of one of these vaccines. 76.9 per cent of infections by the 'delta' variant were recorded in people who had received a single dose, and 60 per cent in people who had received both doses.Data from the NCDC-IGIB study indicated that breakthrough infections due to the 'delta' variant seemed to affect people who took Covishield. This study showed 'delta' breakthrough infections in 27 patients who had taken that vaccine, with the infection rate at 70.3 per cent. Data from both

'Flight risk': Dominica High Court denies bail to Mehul Choksi

New Delhi, June 13: The Dominica High Court has denied bail to fugitive diamantaire Mehul Choksi in the case of illegal entry into the island counry after his mysterious disappearance from neighbouring Antigua and Barbuda where he is staying as a citizen since 2018, local Caribbean media reported. The high court on Friday (local time) gave the ruling by concluding that Choksi was a "flight risk", did not have any ties with Dominica and the court could not impose any conditions which will stop him from leaving the country, news outlet AntiguaNewsroom said. The promoter of Geetanjali Gems and other famous diamond brands in India had fled the country weeks before Rs 13,500 crore fraud in Punjab National Bank (PNB) allegedly involving him and his nephew Nirav Modi surfaced. Choksi, 62, who has an Interpol Red Notice against him, had mysteriously gone missing on May 23 from Antigua and Barbuda where he has been staying since 2018 as a citizen after fleeing from India. He was detained in the neighbouring island country of Dominica for illegal entry after a possible romantic escapade with his rumoured girlfriend.

India has reported over 2.9 crore COVID-19 infections so far, of which around 12.31 lakh are active cases and around 3.53 lakh are deaths. Happily, these days are also marked by an abundance of tries, so the various bonus points were duly collected, Bath's in spectacular fashion at the very end of their home match against Northampton, who were already qualified. The virus claimed two matches from the programme, thus messing with the ancient principle that all games in a final round should start concurrently. Gloucester's tie with Worcester had been cancelled earlier in the week, but as the teams in the 11th and 12th, theirs was the most expendable, even if Gloucester retained a mathematical chance of the top eight.But then, on the day, a case of

Covid-19 in the London Irish camp did for their trip to Bristol, which had the doubly unsatisfactory effect of handing Bristol top spot without so much as lacing a boot and nudging Irish into that eighth spot, courtesy of the two points they were awarded as the infected party. Thus they leapfrogged Bath, who now knew they needed a point, rather than just suspecting as much. At the Rec, the hosts never lost contact with that bonus point, even if for stretches of the match it looked as if it might have to be of the losing variety. At various points, they trailed the Saints, for whom Taqele Naiyaravoro contributed two tries and a yellow card at a sensitive moment.Sam Underhill responded with a chargedown try

early on, and then an Anthony Watson break laid on a fine try for Taulupe Faletau, but still Bath went in at the break 15-19 down. Jacques du Toit's try early in the second half regained them the lead, but James Grayson rounded off a lengthy passage for Saints on the hour, despite Naiyaravoro's yellow five minutes earlier. A Rhys Priestland penalty a couple of minutes later earned Bath a lead they would not relinquish, rendering their spectacular bonus-point try at the death superfluous, if richly gratifying. Josh Bayliss, one of Bath's numerous back-row forwards of outrageous athleticism, stepped and galloped home from 60 metres, leaving three Northampton three-quarters trailing in his wake, for a 30-24 win that

took Bath into seventh place, in between Leicester and Wasps. Neither of those were quite assured of their place in the top eight, before the whistle blew in Coventry, so they racked up the tries to make sure they garnered the points needed one way or another. The Tigers' continuing resurgence continued with a 38-31 victory on the road, scoring five of the match's nine tries, one of them claimed in an urgent style by Dan Cole, his third Premiership try in 13 seasons and 191 matches. Naturally, it was from very close range. Wasps' four tries in reply, secured by the hour mark, tended to feature more in the way of derring-do, but the second bonus point they secured with a penalty from the last kick of the game merely under-scored their claim on the eighth and final place.

Zak Crawley's confusion is a symptom of England's top-order batting malaise

close when England's openers got out to the middle, headache weather, heavy and oppressive. The team were already in some trouble, 85 runs behind, and it was about to get a whole lot worse. It turned out that slender lead was just about as much as New Zealand needed. Rory Burns, England's one in-form batsman, went first. Burns has been playing so well that he seemed to forget that he was supposed to start all over. He threw a bold drive at the second ball of the innings and sliced it behind to second slip. That sparked a fire that burned through the evening session, as panic, indecision and poor thinking seemed to leap from one batsman to the next. Forget the Ashes, by stumps, English cricket was already reduced to cinders and dust. The third day of the second Test will go down as one of the sorriest they've had in a home Test match in a long time.Zak Crawley was in next. It's worth stopping on Crawley's innings. Not because he is the problem, but because he is symptomatic of it. Crawley was picked to play Test cricket 18 months ago on the strength of his potential. He had a first-class average of 32, but a game that made wise men nod their heads, and shots that left the rest of us purring. Eighteen months later, he's still living off his promise, that one monumental double century against Pakistan at Southampton last summer all the evidence we have that he might be-



then, he's made it past 20 once in 12 innings. Coming into bat here, he was on a run of 0, 9, 5, 2, 2, 0.Crawley spun his bat in his hand, stooped, settled into his guard. He was muttering to himself, "watch the ball". Matt Henry was bowling. Henry, 29, doesn't get into New Zealand's first team, and has a Test match bowling average in the low 50s. But he's fast, whips the ball off the seam, and he knows how to bowl in England because he's had long, successful spells playing in the county championship for Worcestershire, Derbyshire, and Kent, where he was Crawley's teammate. They have a sense of each other's strengths and weaknesses. Not that Crawley's flaws take much knowing. He'd already got himself out three times in this series chasing the ball outside off stump. So of course the first ball was wide outside off. Crawley left it. come a great Test batsman. Since The second was too, but the third

was straighter, and he stood tall and tapped it away square for a single. Up in the commentary box, Sky's analysts were watching to see whether Crawley was using a trigger movement. When he made that 267 he'd tapped his front foot before every shot, but recently had stopped doing it. Now he seemed to be in two minds. Sometimes he was, sometimes he wasn't. It was a microscopic detail, a sign of the intense scrutiny he's under, but it was a telling detail because it revealed the confusion in his thinking. This is an old problem, one he should have ironed out some place other than in a Test match. His mentor Rob Key has said that it was a problem for Crawley way back when he was 18 and playing for Sevenoaks. Crawley said then that he couldn't tell if he was moving too much or too little. Key told him to for them just to back themselves, go into the nets, try batting both with however unusual or idiosyncratic and without a trigger movement, and

later, he still seems to be trying to make up his mind. In the meantime he's struggling. They say a man ought to know his limitations, it feels like Crawley has become overfamiliar with his in these last few months of Test cricket. You could see the hesitation in his choice of shots, he never seemed sure whether he ought to be playing or not, he hit two sweet straight drives down the ground, played and missed at two similar deliveries, left alone a couple more that weren't so very different. Six balls, all much of a muchness, met in three different ways. He'd made it to 17, his second-best Test score since last August, when he got out, lbw, to a ball that Henry angled back into his pads. Joe Root seemed to urge him to take a gratuitous review, which only confirmed what Crawley and everyone else already knew. It was plumb.Crawley wasn't the only culprit. Like Dan Lawrence, Ollie Pope, and James Bracey he comes across as gifted kid trying to scrape by on talent and instinct. They've played too little first-class cricket to understand how to adjust to the challenges of batting in a Test match, have techniques they can't trust because they're all being pulled in different directions by the competing needs of trying to succeed in three different formats, and are growing up in culture that seems to have told them that despite it all, it's enough

Barbora Krejcikova beats Anastasia Pavlyuchenkova to win French Open

Paris, June 13: Over the past two weeks in Paris, Barbora Krejcikova has competed in just the fifth grand slam singles main draw of her career, her third as a direct entrant. She has not even made it to Wimbledon or the US Open as a singles player, yet when she finally does she will make her debut in those events as a grand slam singles champion. In a wonderful display of toughness and

guile, the unseeded Krejcikova defeated Anastasia Pavlyuchenkova, the 31st seed, 6-1, 2-6, 6-4 to win the French Open. After a run that has included one match point saved, numerous battles and ample beat-downs across matches against five seeded players, Krejcikova has become the second Czech woman to win at Roland Garros, after Hana Mandlikova in 1981.Few grand slam champions have taken a similar path to Krejcikova. Despite reaching No 1 in doubles, winning five women's and mixed doubles grand slam titles and therefore being well known for years, the 25 year-old spent the first nine years of her career outside of the top 100 in singles, including six years stuck in the limbo of the 101-200 ranking spots."It's something I've always dreamed about," she said. "Winning here my first grand slam doubles title [in 2018], then winning the mixed ones. Now, I was just telling myself it would be really nice if I could get a grand slam in all three categories. I cannot believe it, now it's happening."Having triumphed with craftiness, delicate hands and a vast array of shots, she stands as a reminder of all of the talent that exists outside of the top events, so much of which simply needs the right time and circumstances to thrive. After making two double faults in the tense opening game to lose her serve immediately, Krejcikova's game began to flow and she was in full control, weaving her web as she dragged her Russian opponent around the court with her arsenal of angles, sharply redirected backhands and drop shots. From 0-1 down, Krejcikova breezed through six games in a row to take the set 6-1.Pavlyuchenkova had been flattened for a set, but after nailing a brilliant forehand drive volley to save break point in the opening game of the second set, she came alive. Throughout the set, she dictated and demonstrated all of her prodigious ball-



games with wicked backhand winners, she served for the set at 5-1. As she served out the set, Pavlyuchenkova pulled up with an injury in her left leg. She lost her service game and then took a medical timeout, amusingly easing the pain while she received a massage by snacking on some Haribo gold bears. When she emerged, she had no choice but to minimise her movement and attack, nailing a gutsy cross-court backhand winner to take the set.Both had played excellent tennis in parts, but as the third set began it remained to be seen who would snatch the opportunity. Krejcikova did.At the most important intersection of her singles career, the score 3-3, she fearlessly stood on top of the baseline, directing Pavlyuchenkova from side to side. She closed off the game with consecutive winners, backhand and forehand, and soon led 5-3, 15-40 on Pavlyuchenkova's serve. The Russian scuppered both break points and held. This could have been the moment that things fell apart. But throughout this long two-week journey, Krejcikova has continually demonstrated her toughness under furious pressure. She did so again by shaking off her nerves to serve out the title. Afterwards, a battered and bruised Pavlyuchenkova reflected on her own progress as she banished many demons by finally passing the quarter final stage: "I didn't expect that this tournament I'll be in the final," she said." Again I tell you, physically I wasn't feeling super great, like ready 100%. Still, because of fighting and believing, you can still achieve it. "rejcikova is now on a 12-match winning streak after clinching her maiden WTA title the week before the French Open and will be ranked No 15, and the week is still not over. She will play in the doubles final alongside her longtime partner, Katerina Siniakova, as she attempts to become the first player since Mary striking talent as her wondrous backhand Pierce in 2000 to do the double in Paris.

Christian Eriksen given chest compressions after he collapsed

London, June 13: Danish international footballer Christian Eriksen was given chest compressions by medics during the Euro 2020 clash against Finland in Copenhagen on Saturday. Eriksen, 29, collapsed face first into the pitch while running to collect a throw-in with no other player near him. His teammates and Finnish players nearby quickly signalled to English referee Anthony Taylor that Eriksen, a former Tottenham Hotspur favourite, needed urgent medical attention. The doctors ran over to Eriksen and, as it became apparent just how serious the situation was, the 16,000-strong crowd in the stadium fell silent. The Finnish midfielder Joel Pohjanpalo had his head in his hands in distress. Thomas Delaney, the Danish midfielder, used his shirt to wipe tears from his eyes. The Denmark players, stepping back to allow the medics access, formed a shield around Eriksen to allow him and the tending medics privacy. A stadium announcer asked fans to stay in their seats until further information could be provided. Eriksen's partner emerged on the pitch where she was consoled by Denmark captain Simon Kjaer and goalkeeper Kasper Schmeichel. Both teams subsequently left the field with officials holding up sheets to hide the stricken player from view. Eriksen was given treatment for about 10 minutes before being carried off on a stretcher. A Reuters photographer reported seeing Eriksen raise his hand as he was carried away. Experts said the Parken stadium is very close to the Rigshospitalet, one of Denmark's top cardiac units. In a statement Uefa said the player had been "stabilised". The news that Eriksen had been taken to hospital was greeted by the crowd chanting his name - Finnish fans chanted "Christian", while their Danish counterparts replied "Eriksen". The Danish Football Association said later the player was "awake and waiting for more tests". Uefa announced the match had been suspended pending a meeting with



ers and officials. The Football Association released a statement, which read: "Our thoughts this evening are with Christian Eriksen and his family, and all connected with the Danish Football Union." The Welsh FA said their players and staff were "all praying" for Eriksen.Dozens of current and former players posted messages of support for the player, including his Internazionale teammate Achraf Hakimi. "Eriksen Please," tweeted the Moroccan international. Others posting similar tweets for the Denmark midfielder include former Liverpool defender Jamie Carragher and Manchester United's former defender Gary Neville as well as current England and Aston


playVilla forward Jack Grealish.Former Bolton Wanderers midfielder, Fabrice Muamba who collapsed after suffering a heart attack, said poignantly on social media: "Please God." Muamba, whose heart stopped beating for more than an hour, was revived and eventually recovered in hospital after a cardiac specialist in the Spurs crowd ran on to the pitch to assist.David Lammy, the Labour MP for Tottenham and shadow justice secretary, tweeted: "Prayers and thoughts for Danish and Spurs Legend Christian Eriksen. "We are all rooting for you brother.' A spokesperson for the BBC issued an apology after pictures of Eriksen were broadcast while he received treatment.

Mack Horton's Olympic title defence turns to dust after failing to qualify

defend his Olympic 400m freestyle title in Tokyo after failing to make the Australian team for the event. Horton finished third in the final at Australia's selection trials in Adelaide on Saturday night. Only the top two - Elihaj Winnington and Jack McLoughlin - earned selection for next month's Tokyo Olympics. The opening night of the trials featured Australian records to Emma McKeon (100m butterfly) and Brendon Smith (400m individual medley).But Horton was unable to secure selection at the South Australian Aquatic Centre despite coming almost two-and-half-seconds inside the qualifying time. Winnington won in three minutes and 42.65 seconds ahead of McLoughlin (3:43.27). Horton, who clocked 3:43.92, is still a chance to earn selection in the 200m freestyle, to be

London, June 13: Mack Horton won't contested Sunday. Earlier, McKeon broke her own national 100m butterfly record and was on world-record pace until fading in the last five metres. The multi-talented swimmer, who could race as many as eight events in Tokyo, won in 55.93 seconds, bettering her previous Australian record of 56.18.Swede Sarah Sjostrom holds the world record (55.48), and McKeon had no idea she was close to that benchmark. "That gives me confidence," she said. "It's significantly faster than what I have been going for the last four years."McKeon, who won four medals - gold and two silvers in relays and a bronze in the 200m freestyle - at the 2016 Rio Olympics, said she was benefiting from the Tokyo Games being postponed a year because of the coronavirus pandemic."Having that extra year definitely helped.
