

### Moderna Covid vaccine candidate almost 95% effective, trials show

has received another shot in the arm with the US biotech firm Moderna becoming the latest to reveal impressive results from phase 3 trials of its jab. An interim analysis released on Monday, and based on 95 patients with confirmed Covid infections, found the candidate vaccine has an efficacy of 94.5%. The company said it planned to apply to the US regulator, the Food and Drug Administration, for emergencyuse authorisation in the coming weeks. In the analysis, 90 of the patients received the placebo with the remaining five the vaccine. The results are the latest encouraging news to emerge from the breakneck effort to develop a vaccine against coronavirus and follow a similar interim analysis earlier this month from a collaboration between Pfizer and the German firm BioNTech, which suggest its vaccine is 90% effective at preventing illness.The Moderna vaccine, which is being trialled in more than 30,000 volunteers, is not expected to be available outside the US until next year. The biotech company said it would have 20m doses ready to ship in the US before the end of 2020 and hoped to manufacture 500m to 1bn doses globally next year. So far, the UK does not stand to benefit from the vaccine but a government spokesman confirmed it was in "advanced discussions" to procure it. Moderna has agreed to provide the US with 100m doses, with an option to buy 400m more. Japan, Canada, Switzerland, Qatar and Israel have also signed agreements, and the European commission has a "potential purchase agreement" for 80m-160m doses. The UK chose not to participate in the EU vaccine purchase scheme, with the health secretary, Matt Hancock, arguing in July that the government could source a vaccine faster on its own. The Moderna vaccine, which is based on similar mRNA technology as BioNTech's, is expected to be assessed by the FDA on a final the surface of the virus and is one of

He said the inclusion of high-risk and elderly people in the Moderna trial suggested the vaccine would protect those most vulnerable to the disease, while the reported side effects were "what we would expect with a vaccine that is working and inducing a good immune response"."Moderna have also announced that the vaccine can be kept in a conventional freezer at -20C for up to 6 months, and that once thawed the vaccine can be kept for up to 30 days at standard refrigerator temperatures of 2 to 8C. This makes the vaccine much easier to deliver," he said."This announcement adds to the general feeling of optimism about vaccines for Covid-19. ### Dozens of US Secret Service Officers Assigned to Protect Trump Sidelined by COVID-19

Service officers assigned to protect President Donald Trump have been sidelined by COVID-19, the Washington Post and New York Times reported on Friday as the coronavirus outbreak spread

government sources familiar with the situation confirmed to Reuters that Secret Service officers had tested positive for the virus but did not provide a specific number. One of the sources said a larger number of officers who had not tested positive had gone into quarantine as a protective measure. The Post did not say how many officers tested positive for the virus versus those who had to isolate because of close contact with an infected coworker. It said about 10% of the core security team had been sidelined. The New York Times reported that at least 30 uniformed Secret Service officers recently tested positive for the virus, and that around 60 were asked by the agency to quarantine themselves. Secret Service representatives declined to give a tally of officers affected. White House spokesman Judd Deere referred questions to the Secret Service, but told the Post separately that the administration took every case seriously. The outbreak, which the Post said was at least partly linked to a series of Trump rallies before the November 3 election, comes roughly a month after the president himself contracted COVID-19 and was flown to a US military hospital for days of treatment.COVID-19 has also infected a number of other top officials in the White House, top administration officials and cabinet members and Trump campaign aides. None has died. First lady Melania Trump, Trump's youngest son Barron, top aide Hope Hicks, national security adviser Robert O'Brien and White House press secretary Kayleigh McEnany all previously tested positive. 

The programme was launched two years ago to address the issue of suboptimally controlled diabetes in India. According to the report, the average HbA1c level in Guwahati was recorded at 8.42% in September 2020. The average HbA1c level has marginally increased as compared to last year's figures and the prevailing high HbA1c levels is a matter of deep concern especially in the light of the COVID-19 pandemic which puts people with uncontrolled diabetes at a higher risk of a fatal outcome and serious health complications. HbA1cis the best recommended indicator of long-term blood sugar control and gives an average blood sugar control over the preceding three months. 1000 people with an average age of 54 years were part of the analysis in the city, out of which 61% were male and 39% were female. Speaking about the report, Dr. Karuna Kanta Barman, Consultant Diabetologistand Director of

said, "The high level of HbA1c in Guwahatineeds immediate attention as the risk of severe health complications from COVID-19 is up to 50% higher among people with diabetes. #### **Grassroot candidates** and politics of Bihar

Election officials rejected the nominations of many first-time candidates, including those from activist backgrounds or from marginalised communities. Activists told me these rejections were based on very flimsy grounds, and that electoral officers were hostile to grassroot candidates but helpful to those from parties that have been in power. On 26 October, two days before the state went to polls, many first-time candidates I approached told me they had lost hope in the credibility of the election process. The ruling Bharatiya Janata Party and Janata Dal (United), as well as the opposition Rashtriya Janata Dal and Congress, have all previously promised and failed to address unemployment, rural distress. They have also failed to properly implement welfare schemes. As a result, several grassroot leaders, many from activist backgrounds, hoped to contest the election. Many stood as independents, and some had the backing of two newly established political parties, the New Bharat Mission and the Plurals Party. The NBM is a grassroot party founded by Ashok Priyadarshi and Pankaj, both land-reform activists. Two of the party's ten nominees, including Priyadarshi, were rejected over small errors that election help desks could have corrected and rectified themselves. An Election Commission guideline titled, "Checklist for Returning Officers," available on their website says that returning officers need "to be liberal in overlooking minor technical or clerical errors."The Plurals Party was founded this year and fielded several candidates who are local activists from marginalised communities. The Plurals Party has the largest number of rejected nominations in this election. "On the flimsiest grounds, election officers across Bihar rejected the nomination of 38 candidates from the total 184 candidates we fielded," Anupam Suman, the party's general secretary, told me. Among the Plurals candidates whose nominations were rejected are Manikant Yadav and Sushma Hembram. Yadav is an activist who had previously served as the headman of Bahraich panchayat in northern Bihar. The Plurals Party had given Yadav a ticket for the Haya Ghat constituency. "The returning officer had told me a day before the nomination deadline that my nomination form and affidavits were perfectly filled," Yadav told me. "However, on 21 October, the deadline, even before my nomination rejection order was issued to me, I was told my nomination rejection is finalised because one column was not properly filled. My nomination rejection was clearly unfair." When I contacted VN Chaudhry, the Haya Ghat returning officer, to ask about Yadav's nomination rejection, he said, "Don't seek any clarification from me. Seek clarification from ECI."Hembram, an Adivasi activist who used to run self-help groups among her community, got the Plurals Party ticket to stand from the Katoria constituency, which is reserved for Scheduled Tribes. Suman told me that Ranjan K Chaudhry, the Katoria returning officer, had given Hembram a checklist of bank account details she had to file. "She produced the details on time before her nomination deadline, 11 am on 9 October," Suman said. "But she was made to queue up to enter the office and they rejected her nomination saying she missed her deadline by entering the office at 11.01 am." Suman said that the party was being selectively targeted. Chaudhry did not respond to multiple calls."Our spirits have not broken yet only because we trust the public to support us," Suman told me. "The loss of candidates can't be overcome but such things are bound to happen when an evil design created by the nexus between election officers and big parties dominates the election process." Suman told me that the party had challenged the rejection of Yadav's nomination with the Election Commission. Ashok Priyadarshi, one of the founders of the NBM, is an activist who has been fighting for land redistribuion in Bihar's Gava district since the early 1970s in the hevday of the JP movement. The JP movement was a left-wing movement in Bihar in the 1970s, initiated by the political activist Jayaprakash Narayan, which fought against feudal landlords and corruption by leaders of the Congress. "In 1995, while we were lacking a leadership in our fight for land rights in Gaya, Priyadarshi's guidance gave us the leadership we needed and strength to continue our fight," MK Nirala, a rural activist from Dobhi village in Gaya, told me. "Along with many other villages he settled in Gaya district, he settled two villages in Dobhi-Vahini Nagar and Loknayak Jaiprakash Nagar. This was a historic move." During his several decade-long fight for land reform in Bihar, Priyadarshi has constantly butted heads with consecutive governments of both the JD(U) and the RJD, as well as the state's bureaucratic machinery. On 17 October, Shashi Shekhar, the returning officer for Bankipur, rejected Priyadarshi's nomination for the seat. "When Shashi Shekhar rejected Priyadarshi's nomination mere hours before the deadline, we sought clarification from him," Manoj Kumar, Priyadarshi's lawver who had accompanied him for his nomination, told me. "We were told in a column in Form 26"-an additional affidavit that must be filed with the nomination form-"in which he was asked whether he is using a government residence, he failed to provide answer for each of the three sub-questions."Kumar told me that Priyadarshi said he had answered the question by writing 'Not Applicable,' for a sub-question about the payment of rent, electricity, and water bills in a government residence, which he had never stayed in. Priyadarshi had ticked a checkbox that read 'No.' "The returning officer's reply to Priyadarshi's answer was bizarre," Kumar said. "The officer said Priyadarshi should have provided separate answers to the question on rent, water and electricity though only one question was asked. Why didn't they specify anywhere in the form that it had to be answered as three separate answers when the space left under it would accommodate only one word?" Kumar continued, "Help desks are in place to help nominees correct small errors in the 20 page-long form, when there are any mistakes. Why are the help desks not doing their job?" He said that the rejection of Priyadarshi's nomination was a huge blow for the NBM, a party with a very limited budget and fielding candidates from the weaker sections of society. Kumar said that the NBM has challenged Priyadarshi's rejection in front of the ECI and HR Srinivasa, Bihar's chief electoral officer. Baijunath K Singh, the deputy chief electoral officer of Bihar, confirmed that help desks were mandatory and their roles are clearly assigned. "It's the help desks' duty to verify the candidate's filled form and help with the required corrections before he or she finally submits the forms for scrutiny," he said. However, activists I spoke to told me that across the nomination process for Bihar's polls, help desks were either absent or failed to help nominees from activist backgrounds. As in Priyadarshi's case, several nominees told me that local returning officers were often a major stumbling block in allowing them to contest in the election. Returning officers are usually recruited from among the sub-divisional officers or deputy collector for land reform of a state. Several activists and lawyers I spoke to said that elections vested too much power in the hands of bureaucrats.

### For Arvind Kejriwal, governance is a journey from one gimmick to another

have now forgotten all about the gimmick to mislead the citizens of Delhi nationalism. ### Nitish Kumar is defanged but BJP shouldn't start celebrating yet

If you passed by Deen Dayal Upadhyaya Marg in New Delhi last Wednesday evening, you would think India had discovered Covid-19 cure or the Chinese People's Liberation Army, deployed in eastern Ladakh, had surrendered. Such were the frenzied celebrations at the Bharatiya Janata Party headquarters. As it was, the party was celebrating its victory in the Bihar assembly election. The entire BJP top brass, including Prime Minister Narendra Modi and Union Home Minister Amit Shah, among others, was there. BJP president J.P. Nadda came standing in an open jeep, waving at the crowds. He was finally out of Amit Shah's shadow. He reversed the party's losing streak in assembly elections under his predecessor. Defence Minister Rajnath Singh credited Shah's successor for bringing "new energy" in the organisation. The scale of celebrations of an assembly election victory, with an ally - Janata Dal (United) president Nitish Kumar - occupying the chief minister's chair, however, left many wondering. Was it because it came as a public vindication of the Centre's Covid-19 management and thumbs-up to its handling of the economy and national security? Probably not, because these were not the issues in this Bihar election. If economic distress was an issue at all, questions were targeted at Nitish Kumar. So, was it the celebration of PM Modi's continuing popularity? But that was never in doubt, not even in states where the BJP lost elections. The ostensible reason for the frenzy at the BJP headquarters was the party's performance - 74 seats, with 19.46 per cent of the votes. But, in 2010, the last time the BJP and Kumar's JD(U) had contested together in an assembly election, the BJP had won 91 seats, with 16.49 per cent votes. So, the number of seats in the new assembly doesn't really explain the ecstatic response at the BJP headquarters. In fact, the Rashtriya Janata Dal (RJD) tripped the BJP to emerge as the single largest party in the assembly (with 75 seats). The three percentage point increase in the vote share between 2010 and 2020 could also not be the reason for it.In the 2015 assembly election, the BJP had secured 24.4 per cent votes, the largest vote share among all parties. So, what could explain Wednesday's jubilations? Of course,

the victory in Bihar came after the

Delhi poll drubbing and provided the



much-needed morale booster and the momentum for the BJP ahead of crucial assembly elections in West Bengal and Assam four-five months later. The real reason that BJP leaders were all excited but wouldn't talk about it was the fact that they finally got the better of Nitish Kumar and are now in the driving seat in Bihar. The BJP can look forward to establishing its supremacy D.K. SINGH in Bihar, with or without the JD(U).On Thursday, a

day after the celebrations in the BJP camp, Nitish Kumar came out to interact with reporters in Patna and clarified that his remarks about 2020 having been his last election was misinterpreted. Addressing a rally in Purnea on the last day of the Bihar election campaign, Kumar had said, "This is my last election. Ant bhala to sab bhala (all is well that ends well)." On Thursday, he claimed he makes this comment in his last campaign speech in every election. A week before that, an official press release had left nothing to misinterpret, saying how the CM had announced 'sanyas' (retirement). The BJP is set to have more ministers in Kumar's new Council of Ministers and is also likely to demand more say in governance. But one needs to watch out if the BJP insists on having the assembly speaker's post. That would give the first indication of how the BJP plans to move ahead in Bihar. With Nitish Kumar at 69, many JD(U) legislators may not mind shifting their allegiance to a more promising and resourceful party and the speaker would play a crucial role in such cases. Another indicator would be whether BJP's Sushil Kumar Modi retains the deputy CM's post. Kumar and Modi go back a long way - right to their participation in students' movement in the 1970s and are known as Ram-Laxman of the NDA government in Bihar, despite their different political and ideological affiliations. BJP high command's Deputy CM choice would indicate whether the saffron party intends to tighten the noose around the CM's neck right from Day one or bide its time. Indications are that the BJP intends to keep Kumar under leash right from Day One. Nitish Kumar is a tough nut to crack

though. As long as he is in power, he may not mind an ambitious BJP doing a few tricks here and there. But even BJP leaders must know it is Kumar who is keeping all the cards in his hand. If the push comes to a shove, a redo of 2015 is always an option. The RJD may be guarded against Kumar, but the Congress and its allies are capable of inflicting self-injuries just to hurt the BJP.BJP leaders know it and Nitish Kumar must love this situation - the bread that's buttered on both sides. Kumar, a Socialist who swears by Lohia, is known to have strong ideological convictions, except in matters of power. If there is any threat to his chair, Kumar can always remember and invoke his ideological moorings to seek and justify support from other quarters. The BJP may, therefore, not be in a hurry to make its next big move in Bihar - not until the next Uttar Pradesh assembly election, at least. All major politicians in Bihar could claim victory in this election -RJD's Tejashwi Yadav for establishing himself as a doughty politician who is here to stay; Lok Janshakti Party (LJP)'s Chirag Paswan for damaging Nitish Kumar; the CM for getting another term in office; and BJP leaders for undermining Kumar and still sharing power with him. Small players such as Jitan Ram Majhi (Hindustani Awam Morcha) and Mukesh Sahani (Vikassheel Insaan Party) have become

kingmakers, winning four seats each. Either of them pulling out could reduce the Nitish Kumar-led NDA government to a minority. The coming months and years are, therefore, likely to witness unending power-tussle, ego battles, and brinkmanship in Bihar. These factors will likely keep Nitish Kumar busy. Given that he didn't show much urgency in matters of governance in his current term in office, few expect him to do any better in what could be his last term in which survival will be his key agenda. A senior state government functionary who finds Kumar "the sharpest among the available lot" vented out his frustration and helplessness to me: "We are back to the same rut. Distributing freebies, decentralising corruption and no plan or vision for any productive investment for long-term sustainable development.... Buildings banaate rahiye... thekedar khush, party khush, engineer khush. Usme padhai nahi hogi but that is immaterial. Medical college me doctor nahi honge.... doesn't matter... ITI, polytechnic mein instructor nahi hai... par building to har jagah ban gayi na. Yahi is state ki niyati hai....Hamari niyati khet mazdoor, building site worker, taxi driver, security guard, liftman paida karna hai (there are buildings without doctors, engineers, instructors. The intent of this state is to produce manual labourers)."Well, he may sound too pessimistic but he is probably going by Nitish Kumar's track record in the past seven-eight years. Here are a few pointers to his achievements as reported by my colleague Remya Nair:Data from the National Sample Survey showed that Bihar's unemployment rate rose in 2018-19 to 10.2 per cent, as against 7.2 per cent the previous year.Bihar had one of the highest unemployment rates in the age-group of 15-29 years - 30.9 per cent in 2018-19, as against 22.8 per cent the year ago. Care Ratings estimated that the per capita GSDP of Bihar was at Rs 46,664 in 2019-20, only 35 per cent of the national average of Rs 1,34,226. The Care Ratings report also pointed out that Bihar has a low share of India's factories - only 1.5 per cent as of 2017-18.If this was the state of economic affairs in Bihar when Nitish Kumar was in full control, it's too much to expect a turnaround in Bihar's fortune in the next five years, with a weakened CM who must deal with many frenemies to survive the full term.

### January 2021 JEE Mains could be delayed due to Covid situation, but no plans to cancel



**New Delhi, November 17:** The Joint Entrance Exam (Mains) in January 2021 could be delayed if the Covid-19 situation across the country worsens, ThePrint has learnt. Officials in the National Testing Agency (NTA) said they want to keep up with the schedule and hold the exams in January, but are not certain if that will be the case.No official notification has been released so far on the date of the JEE Mains exam, and students have expressed apprehension about whether it will be postponed or cancelled. However, sources in the NTA and the Ministry of Education told ThePrint that though could be delayed because of the pandemic.JEE (Mains). the entrance exam for engineering colleges across India, is held twice a year - in January

and April.An official in NTA, which conducts the exam, said: "We want to conduct the exam in January itself, but we cannot guarantee at this point that we will be able to do that. It will all depend on the Covid-19 situation in the country."It will also depend upon the board exam schedule. If the board exams are delayed because of the Covid situation getting worse, JEE Mains will also have to be delayed a little. There are definitely no plans to cancel."A ministry source who is privy to the developments confirmed: "NTA is working on the schedule for JEE Mains'

the exam will not likely to be made soon. It is possible be cancelled, it that the exam is a little delayed because of the ongoing pandemic but there is no plan to cancel the January exam as of now."ThePrint emailed the Ministry of Education for an official comment on this issue, but received no response till the time of publication of this report. For the January 2020 JEE Mains, the application process had begun in September 2019. However, this year, since the April exam was delayed until September due to the pandemic, engineering aspirants are getting anxious about the next exam in January. Atman Shah, an aspirant from Gujarat, said: "There is no word from NTA about JEE Mains January and this has started to create panic among students. We just want to know whether the exam will be held or not or if it will be delayed."Reema Ahluwalia from Delhi added: "We have been discussing in our coaching groups and other circles whether the January exam will take place this year or not. No one seems to have any January date, and an announcement is official word on this."

The capital's polluted air is on the minds of media persons, policymakers, politicians and judges, which makes it easy for them to be persuaded that banning firecrackers is obviously necessary. They easily miss the fact that India is a vast country and there are many areas where the air is not as polluted, the space not as populated and the preference for firecrackers not as intense as the national capital. Of the 15, only Tarkishore Prasad, a four-time MLA from Katihar, and Renu Devi, a four-term MLA from Bettiah, shared stage with Nitish, sparking speculation that they are the frontrunners for the deputy chief ministerial posts. The BJP's ministers had all the hallmarks of the party's social engineering. So far, there has been no place in the state cabinet for veterans such as Sushil Modi, Nand Kishore Yadav and Prem Kumar. Instead, Prasad and Devi are from the so-called backward communities. Prasad is an OBC and has a strong RSS background. He was picked from the RSS to replace Jagabandhu Adhikari, after the latter passed away, for the November 2005 elections. Since then, he has never lost polarisation of Hindus and which is classified as an extremely backward caste (EBC) in Bihar. given the size of the insurer's books, which will effectively push the listing to the next fiscal year. Lack of investor interest due to the uncertainties caused by the pandemic saw the government extending the deadline for expressions of interest for Air India and BPCL multiple times. is expected to issue a formal order drawing down U.S. troops in Afghanistan and Iraq to 2,500 in each country by Jan. 15, a U.S. defense official said, as the president works to deliver on his longtime pledge to exit from "endless wars."U.S. Central Command has received an informal warning order, according to the official. The expected order, reported earlier Monday by CNN, would reduce troops from about 4,500 in Afghanistan and from about 3,000 in Iraq before Trump leaves office. Trump's deadline would come five days before President-elect Joe Biden takes office. Pentagon officials didn't immediately comment when asked about the drawdown. But the planned drawdowns drew sharp criticism from Senate Majority Leader Mitch McConnell. The Kentucky Republican, usually a staunch Trump ally, said on the Senate floor Monday that there's little support in Congress for "simply walking

Washington, November 17: Donald Trump away" from the conflicts. "The consequences of a premature American exit" from Afghanistan "would likely be even worse than President Obama's withdrawal from Iraq back in 2011, which fueled the rise of ISIS and a new round of global terrorism," McConnell said. "It would be reminiscent of the humiliating American departure from Saigon in 1975."The move comes after Trump fired Defense Secretary Mark Esper and replaced other top officials at the Pentagon with loyalists last week. Esper sent a classified memo to the White House this month expressing concerns about additional troop cuts, the Washington Post has reported, citing two senior officials it didn't identify. The reduced troop level for Afghanistan is consistent with public statements last month by National Security Adviser Robert O'Brien, although it stops short of a tweet by Trump last month expressing an expectation that U.S. troops there would be home by Christmas.

Sales had fallen as much as 60% in the first quarter, before recording a smart recovery in the following three months, boosted by government spending on infrastructure projects. Indian Construction Equipment Manufacturers' Association president Sandeep Singh confirmed there had been an increase in government spending on the purchase of construction equipment for infrastructure development in border areas."There has certainly been an increase in road construction in border states the past few months, leading to a rise in demand for construction equipment," said Singh.Singh — who is also the managing director at construction machinery manufacturer Tata Hitachi — said his firm had supplied 94 excavators to the BRO. While the order was originally placed last year, Tata Hitachi worked through the lockdown to deliver the equipment ahead of deadline due to the increased infrastructure development activities along the border. India has redoubled efforts, after the latest tensions, to develop key infrastructure — roads, tunnels, bridges and airfields — along the unsettled 3,500 km border with China. The tre had identified 73 "strategic roads" (totalling 3,812 km) along the China border, 28 of which were made operational, 33 are under construction and the work on remaining is in initial stages. The BRO has been entrusted with 61 of these roads totalling 3,417.50 km. Defence minister Rajnath Singh had told Parliament in September that the government has doubled the budget for infrastructure development along the border with China.JCB India deputy chief executive Deepak Shetty said: "We work very closely with the BRO. Even during the lockdown, through our digital platform, we were able to connect with and support our customers working in remotest parts of the country ... While we cannot share details on the exact quantum, orders this year have been multipronged for backhoe loaders, excavator and wheeled loaders ... This gives an indication that large projects are underway." Overall, Shetty said, the government's renewed push on infrastructure development had made the company cautiously optimistic. "While we saw green shoots last quarter, we still need to be cautious because of the pandemic. However, the measures that the government has taken to increase investments in infrastructure projects should help sustain the momentum and return the industry on the growth path next fiscal year." Last quarter's recovery in sales was the first in four quarters. Even as total sales volumes are set to decline by 8-10% to 65,000-70,000 units in the ongoing fiscal year, because of the impact in the first quarter, the growth momentum from the second quarter is expected to continue. In 2021-22, the industry expects to regain the peak sales of 95,000 units, registered in FY19.

We all go through it at different stages, where you feel a bit homesick or claustrophobic when you can't get out and about, like you'd usually like to. We just want to make sure everyone is aware of that ."Buttler is one of 11 players in the 23-strong touring party to have gone straight from a similarly restricted English summer to the recent Indian Premier League in the United Arab Emirates. His family could at least join for the latter, while the fact its hotels were not on site at the grounds also helped create some distance."It's just the restrictions on your freedom," said Buttler. "I certainly found it was tougher to escape staying at hotels on the grounds in England. They were high pressure matches and when you've put a lot into the game, it's nice to get away."Looking out the window and still being on the ground makes it tougher to have your differentials between the game and your relaxation and recovery time. I found it easier in the IPL staying at a hotel away from the ground. There was a clear separation between the two which is great."While arrangements for trips to Sri Lanka, Pakistan and India in the new year are yet to be formalised, this tour offers an escape similar to that of the IPL.

"But he lost to a better man tonight."Brook said he thought he was controlling the fight when he got hit with the punch that sent him across the ring. "Never in my career, nobody has ever done that to me, not even in sparring," Brook said. Crawford, who scored his 28th knockout in running his record to 37-0, took his time in the opening rounds to figure out Brook, who used his jab and speed to win early rounds. After switching from an orthodox stance to southpaw he began landing at a better pace before unleashing a right hook early in the fourth round that sent Brook (39-3) staggering across the ring. The British challenger was

held upright by the ropes but when the

That was 50 years ago."Holding turns away from the screen and puts his fingers to the bridge of his nose. "I'm sorry. I'm getting emotional thinking about it now."The 66-year-old Holding says he is "a very private person", but he has laid himself bare this year.In July, he opened Sky's coverage of England's Test series against West Indies with a

powerful monologue about the Black Lives Matter movement. The next day he broke down on Sky News while talking about his own experiences of racism. The clips went viral. They reached an audience who had no interest in cricket, no idea who he was. He has become a patron of the MCC Foundation, but he is not really interested in talking about sport. # Why Formula One star Lewis **Hamilton matters**

**London, November 17:** Lewis Hamilton equalled Michael Schumacher's record of seven titles in Formula One to enter the pantheon of greats on Sunday. Hamilton matches up, and in some cases, even exceeds Schumacher in terms of achievements on the track. But if there is one arena where Hamilton has no competition, it is the work he has done in terms of political engagement in a sport that has rarely to be a part of shifting that, engaged with life outside of its bubble of races, engineers, mechanics, machines and brand building. Formula One is a sport that has historically favoured teams and drivers with the deepest pockets. The economics of the sport allow for only a select few to enter it. Before he began his dominance in the sport, Lewis Hamilton's identity among a larger public audience was that of being the first ever black race car driver in Formula One. Hamilton, who came from a poor British family and whose parents had to truly struggle for his career in racing to become a reality, is the biggest anomaly in the way Formula One has always been run. It is therefore no surprise

## Diego Maradona leaves hospital 8 days after brain surgery



London, November 17: Diego Maradona was released from a Buenos Aires hospital on Wednesday, just over a week after undergoing brain surgery, and will continue his recovery in a private home. Footage broadcast by local TV stations showed the former World Cup winner leaving the Olivos clinic in an ambulance. Maradona's doctor, Leopoldo Luque, told journalists that he had authorized the release. Maradona's lawyer, Matias Morla, said the 60-year-old Argentine will continue to receive treatment for alcohol dependency. He is expected to stay in a house near his older daughters. The 1986 World Cup champion last week had an emergency operation for a subdural hematoma, which us an accumulation of blood between a membrane and his brain. Maradona's personal doctor, neurologist Leopoldo Luque, said Tuesday that even small amounts of alcohol consumption could have negative effects in combination with the medication Maradona needs for his recovery. The former Boca Juniors, Barcelona and Napoli star has had addiction problems in the past. Morla said the surgery may have been Maradona's "toughest moment.""It could have taken his life," the lawyer said. "What he misses now is the union of his family, being surrounded by health professionals." Morla also called on friends and relatives of the former footballer to stop posting negative messages about each other on social media, saying the infighting is affecting the Argentine great."The situation here is clear: being at peace with the relatives," Morla said. "They have to respect each other, coordinate the visits among themselves because in this case Diego has to recover. ... One has to give him peace and give him unity." Maradona was initially admitted to another clinic in La Plata with signs of depression, anemia and dehydration, before being moved to Olivos when the subdural hematoma was discovered.Dr. Luque said an accident likely caused the subdural hematoma but that Maradona did not recall any falls or mishaps. Maradona felt ill Oct. 30 while coaching first-division team Gimnasia y Esgrima. He had left before the end of the first half, raising questions about his health.

### **Daniil Medvedev wins with** underarm serve at ATP Finals



London, November 17 : Daniil Medvedev pulled off an underarm serve as he outlasted Alexander Zverev and joined Novak Djokovic as a winner at the ATP Finals on day two Monday. Medvedev prevailed 6-3, 6-4, while Djokovic cruised past Finals debutant Diego Schwartzman 6-3, 6-2 in an empty O2 Arena.Djokovic and Medvedev meet on Wednesday to secure the group lead.Medvedev led 4-3, 30-30 in the second set when he surprised Zverev with a quick underarm serve. It brought the Ger the net and he lost the point when his backhand block volley flew long."My wide serve was not working as well as I would like and he was returning good," Medvedev said. "I see that he was five meters behind the baseline and I have the ball close to my racket, so I thought, 'Go for it.'"It actually worked. It's also smart. "Two games later, he served a love game to earn his first win at the ATP Finals in his fourth match going back to last year. Medvedev went 0-3 in his first Finals, including a loss to Zverev which he avenged after an attritional opening set.Zverev, the 2018 champion, earned a break in the first game but gave it straight back with three double faults. Another double fault by Zverev in the sixth game gave Medvedev a 4-2 lead, and the Russian finished the set with his first ace. A weak forehand into the net cost Zverev the decisive break at 3-3 in the second. Medvedev held with the underarm serve, and he beat

Zverev again eight days after winning their Paris Masters final."This was one of the most (intense matches) I had in my career," Medvedev said. The top-ranked Djokovic smothered Schwartzman after conceding an early break and, despite no fans inside the 20,000-capacity O2 Arena, he gestured to each section as if to say thanks."Why I celebrated? Because that's my celebration and that's also my gratitude to the court and to this opportunity to be able to compete," the Serb said. "Even though there was no crowd in the stands, I know that there was a lot of people watching it on TV, so that was me sharing that emotion with them."Djokovic hasn't lost an opening ATP Finals match since 2007 against David Ferrer. He also has never lost to Schwartzman in six matches."It felt like a practice session in a way," Djokovic said of playing in the empty stadium. "This has been one of the most exciting arenas to play for a tennis player. The atmosphere was always electric and the crowd was always loud and really into matches."He has won the elite, season-ending event five times - one short of Roger Federer's record. Schwartzman qualified for his first ATP Finals by reaching the French Open semifinals and two finals, including at the Italian Open, where he lost to Djokovic."That start of the match he was not playing his best," Schwartzman said. "I took the chance at the beginning, but then that break back from him ... I did too many mistakes."Schwartzman is the first South American to play singles at the ATP Finals since 2013 and another Argentine, Juan Martin del Potro. The ATP Finals move to Turin, Italy, next year, after 12 years in London. The players' hotel is a short walk away, but health protocols require they are driven to and from the venue. The tournament is using electronic line calling for the first time.

gameplan and stay patient, essentially looking to do to Chelsea what Manchester United did to his team.So Arsenal sat narrow and deep, working their arses off to win the 10-yard sprints to loose balls before springing into attack - usually from a turnover, with Jill Roord and Kim Little suffocating Chelsea before pinging balls out to Vivianne Miedema down the left. Though the approach nearly worked, it's hard not to wonder whether they have the squad-depth to sustain a challenge on all fronts - a recurring theme over the last few years. Chelsea were really good in the first half, Ji So-yun in particular. They too needed to stay patient, unable to play their usual game of drawing teams in then spreading play wide, and sneaking a point after going behind with four minutes left will have left them on a high though they should have stolen all three, except Sam Kerr hooked wide with only the keeper to beat.
