

Prabhas Patan town in Gujarat's Gir-Somnath district, becoming the second PM to hold the post.PM Modi, one of the trustees of the Shree Somnath Trust, was elected to the top post unanimously, an officebearer of the shrine man-

agement body said.After former PM Morarji Desai, Narendra Modi is the second Prime Minister who has been appointed the chairman of the temple trust. As per trust records, PM Modi has become the eighth chairman of the trust. The post of the Somnath Trust's chairman fell vacant after the death of the incumbent, former Gujarat Chief Minister Keshubhai Patel, in October last year. Patel had served as the chairman for

Assam forms panel to identify 'collaborators' of illegal migrants

GUWAHATI, Jan 19: The Assam government has constituted a five-member committee for initiating immediate and proactive steps to identify the intermediaries, facilitators and collaborators of illegal migrants from across the international border into the state and initiate legal action to bring them to justice, officials said here on Wednesday.The Special Director-General of Police (Border) Mukesh Agrawal confirmed the setting up of the panel on Tuesday following a discussion with the state Chief Secretary Jishnu Barua on January 11. Agrawal, a senior IPS officer, in his notification, said : "The committee has been constituted to take immediate and proactive steps to identify the intermediaries, facilitators, collaborators facilitating the infiltrations of illegal migrants from across the international border into Assam and initiate legal action to bring them to justice."According to a senior official of the Border Wing under the Home Department, (BOPs). He said that in the first phase of the panel headed by IPS officer Subhrajyoti Borah, the commandant of the 7th Assam Police Battalion based in western Assam's Kokrajhar district, would strengthen the existing mechanism of dealing with illegal migrations, which is always a key issue in Assam.Agrawal's notification, available with IANS, said that the Deputy Commissioner of Police (Border), the Superintendents of Police (Border) of all districts, Superintendent of Railway Police (Border) and other concerned officials would take legal action in their respective jurisdictions on the recommendation of the five-member team. It said : "They would also render necessary assistance to the committee in performing its task including utilisation of border staff of the districts as and when required by the committee."The Deputy Inspector of Police (Ranges) would supervise the progress of the work of the committee and follow-up action being taken in their respective Organisation was set up in 1962 as a unit of ranges."The Guwahati-based Commissioner the State police's Special Branch.

of Police and the Inspector General of Police for the Bodoland Territorial Region would also oversee the progress of the work of the panel.The constitution of the panel has assumed significance ahead of the Assam Assembly elections as the issue of illegal infiltrations, or "illegal migrants from Bangladesh" have always been a major poll issue for most political parties in the northeastern state. Assam will likely go to polls in April-May along with West Bengal, Tamil Nadu and Kerala.Meanwhile, to strengthen the security related infrastructures along the state borders, the Assam government has recently sanctioned Rs 100 crore and decided to further tighten the vigil along the frontiers. An official said that in line with the MOITRI scheme for the modernisation of police stations, Assam government is all set to launch a scheme for the infrastructural development of the Border Outposts the scheme, 50 BOPs would be upgraded and an amount to the tune of around Rs 100 crore has been earmarked for the purpose. Subsequently, other BOPs of the state would be covered under the scheme."The sealing of the India-Bangladesh border is the topmost priority for making Assam free from illegal migrants from across the international border and for this purpose the border is being fenced by physical and non-physical barriers," the official said. The 263km India-Bangladesh international border along Assam is being guarded by the Border Security Force (BSF) while the 267 km Indo-Bhutan international border is manned by the Sashastra Seema Bal (SSB).A second line of defence is being provided by the Assam Police.Besides, Assam shares 2616.1 km inter-state borders with six northeastern states, excluding Sikkim.The Assam Police Border

New Delhi, January 19: The immunisation drive against the coronavirus that began on 16 January is a mammoth exercise in terms of resources, social mobilisation, communication, logistics and most importantly, data management. While it is visible that governments are thoroughly preparing on most fronts, there is an urgent need to acknowledge and sufficiently stress on the importance of having a robust data management system in place. This must involve designing data systems that enable useful analysis for evidence-based decision making in the future. The chaos and difficulties of data management during the containment of Covid-19 have been visible over the past year. Since it's the government that is primarily driving the vaccination exercise, the responsibility of the system design that collects, manages and analyses data for insights shall fall on the Ministry of Health and Family Welfare as well. However, ensuring that this system is utilised with accurate, clean and authentic data shall be the responsibility of the states.he proposed data system should not be built in silo, without appropriate linkages to the massive data repositories built on Covid-19 infections. Backward and forward linkages of all data captured previously, and new data expected to be captured with the rollout, especially on beneficiaries, need to be thought through and put in. For example, months from now, if the administrators and medical professionals need insights into the effects and efficacy of the vaccine on beneficiaries who had been infected previously versus beneficiaries who had never been infected, or on beneficiaries with certain comorbidities versus none, the system should be able to pull out this analysis and throw conclusions based on vaccination data from across the states. If beneficiaries get infected with Covid-19 months after the vaccine administration, the system should also be able to trace the vaccine and dosage administered, along with other details. This is especially critical since the vaccines have, so far, received only emergency use authorisation, and a lot more research on the immunisation data may help decisions on continued usage and conventional approval for commercial use of these as well as other vaccines.With strict timelines under which the governments are operating, the first versions of data systems cannot be expected to be comprehensive and have all provisions of linkages. However, unless a dialogue on the subject pushes for continuous improvement of the platforms, we

China, WHO acted 'too slowly to contain COVID-19', says independent panel

Beijing, Jan 19: China, WHO acted 'too slowly to contain COVID-19', an independent panel has saidGeneva: An independent panel has slammed China and the World Health Organisation (WHO) for "early shortcomings" in the initial response to the coronavirus pandemic. The Independent Panel for Pandemic Preparedness and Response, established by WHO in May 2020, is co-chaired by former New Zealand Prime Minister Helen Clark and former Liberian President Ellen Johnson Sirleaf, .In a report released on January 18, the panel called for an overhaul of global health alert and response systems, saying the current system is "not fit for purpose.""The Panel also describes additional early shortcomings at each step of the global and national response to COVID-19 which have contributed to the pandemic. These include a failure to measure preparedness in a way that predicted actual performance, and a failure of countries to prepare, despite years of warnings of the inevitability of a health threat with pandemic potential," the report read. China was also slammed by the panel for "lost opportunities to apply basic public health measures at the earliest opportunity." "What is clear to the Panel is that public health measures could have been applied more forcefully by local and national health authorities in China in January," the report said as quoted by CNN. This comes after UK's former Secretary of State for Work and Pensions Ian Duncan Smith labelled Beijing as despicable for covering up vital information pertaining to COVID-19.

Asked if she was approached by any government officials during her detention, Mufti responded: "Not many, but whosoever approached wanted me to reconcile to the scrapping of our special status and normalise things as if nothing had happened."She said her father, the former Union home minister and J&K CM Mufti Sayeed, would have been "shattered" to see Article 370 go."He was an Indian by conviction, not convenience, and was proud of India as a democracy with diversity. His idea of India, which he believed in so much, would have been shattered. How he would have reacted I can't say, but I am sure he wouldn't have given up," she said.On whether her daughter Iltija, who took a vocal stand against the Modi government during her detention, would join the PDP, Mehbooba Mufti said: "I think she has made it abundantly clear that she's not interested in politics, but one doesn't know what the future holds."

It's 2021 and the Indian bureaucracy remains the greatest impediment to progress

New Delhi, January 19: Barack Obama's comments on Rahul Gandhi in his recently released book made headlines. But there's another indictment that should be a cause for discussion in India. Obama writes of the country's bureaucracy as an impediment in its progress: "Despite its genuine economic progress, though, India remained a chaotic and impoverished place: largely divided by religion and caste, captive to the whims of corrupt local officials and power brokers, hamstrung by a parochial bureaucracy that was resistant to change."This assessment of governance in India is shared by others who get to take a peep into our system. A foreign diplomat recently told me he was hassled to see how difficult it was to sell his car in Delhi. Another foreign diplomat told me about the paperwork harassment at the airport due to Covid: "I had to fill forms affirming that I had filled forms, which affirmed that I had an RT-PCR a negative test."Nobody, not even a strongman leader like Narendra Modi, is able to make the Indian bureaucracy reform its ways - reduce the number of needless steps in their perfect SOPs, and make people's lives easier. The bureaucracy seems to exist to make people's lives tougher, because each cog in the wheel is only trying to be faithful to its own desk. Nobody looks at the larger picture and there is little accountability. The Goods and Services Tax (GST) was supposed to make indirect taxation easier and simpler. That is what it has done in many countries. Why wouldn't it achieve the same result in India? Enter Indian bureaucracy. The complaint about GST, especially in its initial roll-out, was that it was too complex. Only the Indian bureaucracy can complicate a measure meant to ease something. The worst of the Indian bureaucracy was brought out in the pandemic. Covid vaccination has begun but across India, swimming pools are still not allowed to function under the orders of the Ministry of Home Affairs. You can take a dip in the Ganga along with millions of people at the Kumbh but you can't swim in a pool. Nobody told the MHA that Covid is not a waterborne disease. Gyms are open - enclosed spaces that are more likely to spread Covid than an open air pool. The excuse for pools has been overcrowding. In which case, how about allowing pools to at least open in the winters in north India? And if overcrowding is an issue, have our bureaucrats considered visiting a market lately? The ban on swimming pools has hurt the careers of professional swimmers. Even when the MHA allowed pools to be used only for athletes, not all states opened them. The high-handed penwielding bureaucrats make these decisions in their silos hurting the lives, livelihoods and health of millions of people. The Indian bureaucracy fought an infectious disease with red tape, as The Economist memorably put it. The confusion in Delhi NCR traffic movement was a good example, with one state opening its borders and the other closing, showing total lack of coordination. Then there have been these night curfews, forcing people to do their socialising in the crowded day time, further increasing the possibility of the spread of the virus. In many cities, the traffic police was fining people for not wearing a mask even while driving solo in a closed car. It took the intervention of the courts to stop this bizarre harassment of citizens to relieve them of their money. There was an app. Aarogya Setu, like similar apps abroad, was supposed to alert users if they had come near anyone who was later found infected with Covid. Nobody was ever alerted.

The issue of Arnab

Arnab Goswami's WhatsApp chats allegedly with former BARC CEO Partho Dasgupta raises an issue to opposition. But outrage is strictly the opposition's territory. If we are expected to outrage on their behalf, then India might as well be a single political party pseudo-democracy. Where are the acerbic questions from the opposition? And where's the holier-than-thou television media, whose anchors were reading out to their viewers leaked chat messages from the phones of Rhea Chakrabarty, Deepika Padukone, Sushant Singh Rajput and others? Of course, now running programmes on Arnab's leaked WhatsApp chats but the coverage seems nothing more than a 'payback' for Arnab Goswami's smug reference to AS (widely alleged to be Home Minister Amit Shah) calling Navika Kumar 'Kachra' (garbage). With the latest revelations from the alleged WhatsApp chats of Arnab Goswami, which the Mumbai Police submitted in court along with its supplementary chargesheet in the TRP scam case, two possibilities emerge. Either the opposition in India is very shady itself, with too many skeletons in politicians' closets. Or, in the prophetic words of Swaraj India president Yogendra Yadav, who said "Congress must die", the Congress has died. The 'prime' 'national' opposition party is evidently resting in peace or resting in pieces - and that's why we don't hear any outrage from anyone with decision-making powers in the party (read the Gandhis). Of course, others in the party like Prithviraj Chavan, P. Chidambaram and Manish Tewari are speaking about "ArnabGate" but then again, how much weight do they carry within the party?In spite of the incriminating evidence against Arnab Goswami that has been exposed in these chats - for example, allegedly having prior information about the Balakot airstrikes - hardly anyone from the opposition parties has so much as even spoken about Arnab Goswami or questioned how he seemingly had military intelligence. This is in stark contrast to the BJP when it was in opposition during the audio leaks of telephone conversations between former corporate lobbyist Niira Radia, politicians and journalists in 2009. The BJP ensured that in every political rally and throughout its campaign in the run-up to 2014 Lok Sabha election, the alleged 2G scam was mentioned. It was the media conversation around the 2G scam allegations as well as the opposition's continuous pressure that led to the arrests of DMK chief Karunanidhi's daughter Kanimozhi and former telecom minister A. Raja in 2011. And Arnab Goswami was at the heart of raising the heat on that story back then. All the accused were acquitted in 2017. Since then, Arnab Goswami has obsessively hounded the Gandhis in his shows on Republic TV and Republic Bharat. He has left nothing to civility in insulting Sonia Gandhi, Rahul Gandhi, Robert Vadra and Priyanka Gandhi. And now, at his most vulnerable, exposed time, he is being allowed by the opposition to lie low, stay quiet and avoid questions on the incriminating chats.While the Gandhis are choosing to take the high road and not 'attack' Arnab Goswami, the latter is not reciprocating the courtesy. A press release issued by the Republic Media Network - in response to a statement put out by Pakistan's Ministry of Foreign Affairs on Arnab's leaked chats - said the company was urging the Congress party "to stop working in tandem with the Government of Pakistan, consciously or unconsciously". Obviously, Arnab is under the false impression that he represents the whole of India, which is why anyone pointing out his irresponsible chatter on military intelligence is, accoridng to him, 'anti-India'. This delusion requires an everoll that lasts for an eternity. In a parallel world, today's Gandhis could be passed off as 'Mahatma' for being so non-vengeful. But it's 2021. There's a Ram Mandir being constructed and one of India's top actors is asking people to donate money for it. We've gone through a pandemic and are rolling out vaccines that have not gone through all phases of clinical trials and we've almost had a war with China. Time to be a Mahatma has long gone. Michelle Obama's 'go high' doesn't quite win elections in Modi's India.But the Congress's Buddhalike silence seems habitual. It is no surprise that the Congress ecosystem is riddled with lethargy. Its leaders always seem to miss striking the iron while it's hot. When the farmer protests began to heat up, the Congress leadership was nowhere in news - and certainly not on the streets. It is only at their own time and leisure that they choose to show up - like Priyanka and Rahul did last week outside Delhi Lieutenant Governor Anil Baijal's official residence, "fighting" for the repeal of farm bills. Where were they for the last 50 days when farmers from various parts of the country were trying to reach Delhi to join other protesters but were stopped by the police at the borders? Those who did come out, such as party leaders in Haryana, received no attention or support. The obvious problem with the Congress is its dependence on the Gandhis to do anything and everything. Many in the Congress work to just move up the ladder within the party organisation and therefore remain politically irrelevant, while those who actually want to be politically relevant are made irrelevant within the party.

t's hard to care about bootprints sunk in soil 238,900 miles away as human ity suffers the combined burden of an unforgiving virus and a political unease. But how humans treat those bootprints and the historic lunar landing sites upon which they are found will speak volumes about who we humans are and who we seek to become. On Dec. 31, the One Small Step to Protect Human Heritage in Space Act became law. As far as laws go, it's pretty benign. It requires companies that are working with the National Aeronautics and Space Administration on lunar missions to agree to be bound by otherwise unenforceable guidelines intended to protect American landing sites on the Moon. That's a pretty small pool of affected entities. However, it is also the first law enacted by any nation that recognizes the existence of human heritage in outer space. That's important because it reaffirms our human commitment to protecting our history - as we do on Earth with sites like the Historic Sanctuary of Machu Picchu, which is protected through instruments like the World Heritage Convention - while also acknowledging that the human species is expanding into space. I am a lawyer who focuses cosmonauts on the Moon in the 2030s.

on space issues that Michelle seek to ensure the peaceful and sustainable exploration and use of space. I believe that people can achieve world peace through space. To do so, we must recognize landing sites on the Moon and other celestial bodies as the universal human achievements they are, built on the research and dreams of scientists and engineers spanning centuries on this globe. I believe that the One Small Step Act, enacted in a divisive political environment, demonstrates that space and preservation truly are nonpartisan, even unifying principles. It is only a matter of decades, perhaps just years, before we see a continuous human presence on the Moon.While it would be nice to think that a human community on the Moon would be a collaborative, multinational utopia albeit located in what Buzz Aldrin famously described as a "magnificent desolation" - the fact is people are once again racing one another to reach our lunar neighbor. The U.S. Artemis project, which includes a goal of sending the first woman to the Moon in 2024, is the most ambitious mission. Russia has reinvigorated its Luna program, setting the stage to put

the Moon this year. China, which in December implemented the first successful lunar return mission since 1976, has announced multiple lunar landings in the coming years, with Chinese media reporting plans for a crewed mission to the Moon within the decade. South Korea and Japan are also building lunar landers and probes. Such private companies as Astrobotic, Masten Space Systems and Intuitive Machines are working to support NASA missions. Other companies, such as ispace, Blue Moon and SpaceX, while also supporting NASA missions, are preparing to offer private missions, in-

Hanlon cluding for tourism. How are all these different entities going to work around one another?Space is not lawless. The 1967 Outer Space Treaty, now ratified by 110 nations, including all of the current spacefaring countries, offers guiding principles supporting the concept of space as the province of all humankind. The treaty explicitly indicates that all countries and, by implication, their nationals have the freedom to explore and free access to all areas of the Moon. That's right. Everyone has the freedom to roam wherever they want - over Neil Armstrong's bootprint, close to sensitive scientific experiments or right up to a mining operation. There is no concept of property on the Moon. The only restriction on this freedom is the remonstration, found in Article IX of the treaty, that all activities on the Moon must be carried out with "due regard to the corresponding interests of" all others and the requirement that you consult with others if you might cause "harmful interference."What does that mean? From a legal standpoint, no one knows.It can reasonably be argued that interfering with an experiment or a lunar mining nance model.

The lunar landing sites - from Luna 2, the first human made object to impact the Moon, to each of the crewed Apollo missions, to Chang-e 4, which deployed the first rover on the far side of the Moon - in particular bear witness to humanity's greatest technological achievement thus far. They symbolize all we have accomplished as a species, and hold such promise for the future. The One Small Step Act is true to its name. It's a small step. It applies only to companies that are working with NASA; it pertains only to U.S. lunar landing sites; it implements outdated and untested recommendations to protect historic lunar sites implemented by NASA in 2011. However, it offers significant breakthroughs. It is the first legislation from any nation to recognize an off-Earth site as having "outstanding universal value" to humanity, language taken from the unanimously ratified World Heritage Convention. The act also encourages the development of best practices to protect human heritage in space by evolving the concepts of due regard and harmful interference - an evolution that will also guide how nations and companies work around one another. As small a step as it may be, recognizing and protecting historic sites is the first step to developing a peaceful, sustainable and successful lunar gover-

espite repeated warnings from the US, the European Union's recent Comprehensive Agreement on Investment with China raised evebrows across the world. And even Donald Trump's parting shot was to revive the trade pact with the Beijing administration. Australia also signed a 15member Regional Comprehensive Economic Partnership with China in November. In a slowing economy, all three have revived some level of trade relationship with China. But as countries scramble to find new partners and new trade pacts in the wake of Covid. India is looking at a future where there is no China because of border tensions, and instead has lined up a few minilaterals whose outcomes are unknown. It seems that China is able to impose itself as a critical business partner even at a time when countries have been grouping up against its increasing belligerence under the Xi Jinping administration. India has been a rare exception in maintaining a consistent stance against China in terms of trade, blocking Chinese investment in April last year and walking out of the RCEP in November 2019. This stance has been bolstered by the Ladakh standoff. O'Farrell told ThePrint in an interview that Canberra has joined the RCEP despite its differences with China because it supports open markets and encourages expanded trade and investment. "We also recognise trade and investment will be key to rebuilding our economies post Covid, and ensuring future sustained economic development," O'Farrell said.In April 2020, shortly before the ongoing tensions in Ladakh first cropped up, the Narendra Modi government took several steps to restrict foreign investments from China. New Delhi completely shut the door for Chinese investors or for any preferential trading arrangement with Beijing. He also made it clear that in order to become a credible manufacturing hub and to become an alternative to China, New Delhi has to undertake some serious measures."As US and other companies find it increasingly difficult to operate in China or seek to diversify away from Chinese-led supply chains, India has a strategic opportunity to become an alternative destination for manufacturing in the Indo-Pacific ... To fully seize the opportunity, the Indian government may well need to take further action," he said.India's top three trading partners - the US, EU and China - slammed New Delhi during a trade policy review at the World Trade Organization (WTO) held from 6-8 January in Geneva. The US, in its feedback to the WTO on India's trade policy, said that if New Delhi continues to raise its tariff structure, it will "not facilitate India's further integration into global supply chains."And so, India is now trying to become part of the post-Covid supply chain network by joining certain small groupings in the form of 'minilaterals' under the Indo-Pacific strategic initiative.

Cradle installed at civil hospital for abandoned babies

Hailakandi, Jan.19: Cradle has been installed at the SK Roy Civil Hospital for abandoned newborns here on Tuesday. The District Child Protection Office (DCPO) has put in place cradle so that parents could leave their newborns safely while keeping their anonymity. The DCPO also plans to expand the scheme in other government-run health centres in the district such as Block Public Health Centres, Ujjwala Homes and Child Care Institutions. Seven cradles have been received from the State Adoption Resource Agency under the Social Welfare Department. Each cradle is accompanied by a mosquito net, fire-proof mattress and a blanket. The objective of the scheme is to save the deserted babies, who are mostly left at spots far from human activities. Launching the scheme, SDO (Sadar) cum Incharge District Social Welfare Officer, Jyotirmoy Daimary said it would provide a new leash of life to the babies who are abandoned by their parents under trying circumstances. "Though we do not want to see newborns being abandoned, circumstances force some to do so and in this situation the scheme will give a new leash of life to them," he quipped. Speaking on the occasion, Incharge, District Child Protection Officer, Gulzar Ahmed Laskar said, "Installing cradles is to ensure babies are not abandoned in dustbins, bushes, and fields where they are exposed to fatal infections and die. The cradles are a remedy to save these lives." Superintendent of SK Roy Civil Hospital, Dr.Sudip Chakraborty, while lauding the initiative, hoped that the cradle scheme would help save precious lives of abandoned newborns. District Information and Public Relations Officer, Sabir Nishat said the cradle initiative would provide a congenial atmosphere for the unwanted babies to grow up in a healthy way under the tender love and care of health functionaries. Appreciating the laudable initiative, Chairperson, Child Welfare Committee, Nilotpol Deb said the scheme would pave the way for abandoned babies to get the much-needed love and care. The cradle for abandoned babies has been conceptualised in accordance with ICPS guidelines 2018 of the Ministry of Women and Child Development within the Juvenile Justice framework. 19 districts of Assam, including the three districts of Barak Valley have been allotted 131 numbers of cradles for abandoned babies. "The ANM and GNM staff have been directed to make periodic rounds of the cradle. If a newborn is spotted, it would be rushed to the neonatal care unit and given medical check-up. Once the medical attention phase is over, the baby will be handed over to the Specialised Adoption Agency in accordance to the provisions of the Juvenile Justice Act, 2015", said Child Protection Officer, Laskar. The scheme will also help bridge the gap between the number of children available for adoption and the burgeoning list of adoptive parents. "The idea behind is to encourage parents to come and surrender their unwanted babies in the cradles so that they don't abandon them. It is a humane and yet anonymous way to give up your child," added Laskar.

And as Athletic Bilbao move it unhurriedly up the field, Messi's arms drop sadly to his sides.Moments later, Messi feels the crunching shoulder of Asier Villalibre smack the side of his head as he plays a pass. Messi sprints towards the area. Villalibre impedes his path. And so Messi swings an arm at the back of his head: the act of a desperate man, a hopeless man. The sheer illogic of it seems to drain Messi entirely. He leans over to see if Villalibre is OK. He accepts his red card without complaint. As he leaves the field, he hands the captain's armband to Jordi Alba.The first thing to say about Messi's first red card in 753 Barcelona first-team games is that it probably shouldn't have been. After all, this is hardly the first time Messi has lost his temper on the pitch. Nor should this be entirely surprising. Messi has been getting kicked, clipped, blocked, barged, tugged, tripped and tag teamed ever since he learned to dribble a football. Indeed, Messi has played a large part of his career against a backdrop of people specifically trying to make him angry.Most of the time, Messi anger is quite amusing. There are the numerous tiffs with Sergio Ramos and Pepe of circumstances: the state of the a shoulder smack the side of his

Calls to shorten Australian Open matches rejected as player quarantine likened to 'prison

Paris, January 19 : Australian Open director, Craig Tiley, has rejected a proposal to shorten the men's tournament matches to best of three sets to offset the disadvantage to players in hard quarantine.Frustration and confusion continues unabated in the build-up to the season's first major, starting on 8 February, with some 72 players and staffers in lockdown in Melbourne following six positive Covid-19 cases among the entourages arriving to Australia on 17 charter flights in recent days.While many players have transformed their hotel rooms into makeshift training centres, the overall sentiment has been one of disquiet and apprehension about potential injury and form ramifications of two weeks with no

court practice. Spain's world No 13 Roberto Bautista Agut was the latest to voice concern on Tuesday, describing quarantine as like being "in a jail"."It's the same, but with wifi," Bautista Agut told Israeli news channel Sport 5. "These people have no idea about tennis and about practice courts, and it's a complete disaster. The control of everything isn't Tennis Australia, it's with the government."The situation has sparked suggestions to consider reducing matches to best of three sets instead of the traditional five. However Tiley, while acknowledging the lockdown meant preparation was "not an even playing field", moved quickly to dismiss any suggestion the match formats would be altered."We are a grand slam at the end of the day," Tiley told the Nine

Network on Tuesday. "Right now, three out of five sets for the men and two out of three sets for the women is the position we plan on sticking to."In order for us to pull this off. we've had to do it with great partnership with quarantine Victoria, with the Victorian government and that is working really well. The two weeks with the players and 72 of them being in a hard lockdown, we are providing them with all sorts of exercise equipment in their rooms."They can be creative on how they use the dressers, the beds for exercise, and we have seen on social media some really interesting ideas. And then they are going to come out after 14 days in their room and we will give them some time to prepare and that is why we had that buffer week, in the event that this was going to

happen."Tiley said tournament organisers were considering other avenues to "to try to even it up as much as possible" but did not elaborate on the nature of those prospective

Messi sent off as Athletic Bilbao sink Barcelona to win Spanish Super Cup



Barcelona, January 19: The moment that ultimately won this match, if it could be reduced to just one among so many, was like the last frame of a comic strip. It's 2-2 in extra time in the Super Cup and the team made up entirely of local boys have twice come from behind against the biggest team of all, somehow making it this far thanks to an improbable last-minute equaliser. The ball then falls at the feet of the striker who joined them as a kid and is playing in his 167th consecutive game. From the edge of the area, an implausible position, he hits an unstoppable shot which flies through the air, and rockets into the net.It was, said Athletic Club's Iñaki Williams at the end of an exhausting, exhilarating 120 minutes, "without doubt the best goal of my career" and he could not have placed it better if he had picked the ball up, leaned a ladder against the post, climbed up and put it there by hand.It wouldn't have drawn it better or chosen a better moment for it either. There was still a way to go, nerves to be shred, minutes to be seen out, and plenty of action - Unai Nuñez somehow missing from three yards; Ander Capa and Frenkie de Jong crashing into each other; Antoine Griezmann smashing a

volley wide, his moment gone; a red card for Lionel Messi - but Athletic, who had defeated Real Madrid in the semi-final, were on course to beat Barcelona.Barcelona were complicit in their own demise yet make no mistake: this was Athletic's night. Jordi Alba was directly involved in four goals but two of those were Athletic's and defensively Barcelona disintegrated while in attack they created little and in the middle they were never in control. Not on the pitch; not on the bench either. Nor did they react when they needed to, the personality required absent. Their collapse, the impotence that engulfed them, the desperation, was expressed best by the late sending off for Messi for hitting out at Asier Villalibre - his first red card for the club. Messi walked head down, and soon was gone. This may be the least of the trophies that Barcelona chase but it was also the most likely for them to win this season and this was a failure, and a painful one. As for Villalibre, the man whose goal had taken this match to extra time before Williams won it, he finished the night out in the middle of the pitch playing the trumpet in celebration. For Athletic, deserved winners, there was joy, even

a trophy raised in an empty stadium by the club that, along with their Basque rivals and scheduled opponents Real Sociedad, refused to play last year's Copa del Rey final without their fans.Still, this remains a huge moment for them and one their supporters will cherish, despite the barge remaining tied up rather than taken down the river in celebration as tradition dictates. For their new manager Marcelino García Toral too: he has been in charge for just three games - against Barcelona, Madrid and Barcelona again - and already he has a winners' medal.When Williams's shot went in, the manager went wild on the touchline here; at the end they all did and rightly so. Twice they had fought back from behind and then, in extra time they had found a goal that Oliver Atom, Hotshot Hamish and Mighty Mouse would have embraced. One that delivered justice. It had been a long night and if it had looked like victory would escape Athletic at times, that would have been cruel. And yet this was not just strength and determination: it was control too and Athletic took the game to Barcelona as they had done to Madrid in the semi-final. Athletic had the first shot, Marc Andre ter Stegen turning over Capa's rising effort, while it wasn't until eight minutes before half-time when Messi struck Barcelona's first effort over from 30 yards. And yet then, just after Raúl García had headed

over Oscar de Marcos's cross at the other end, Barcelona scored. Messi's pass took seven players out and found Alba, running into the area on the left. He looked for Messi's arcing run towards him, seeking to cut it back into his path: that old familiar routine. The rebound came to Griezmann to finish.Barcelona had the lead but lost it again in 92 seconds, not one of their players touching the ball again before Athletic equalised. And if Messi's pass then had been good, Williams's was even better now. Beautifully clipped, it floated and dropped behind Alba, where De Marcos ran in and, first time on the bounce, sidefooted past Ter Stegen.Athletic thought they had added to it only for Raúl García's header to be ruled out by VAR for the tightest of offsides, but they were undeterred, Williams thumping just wide soon after. There was a slowness to Barcelona's play, a lack of conviction and yet they again took the lead when Ousmane Dembélé and Alba suddenly burst into life, accelerating to provide for Griezmann to get his second with 13 minutes to go.It was done, or so it seemed. Fatigue took hold, legs grew heavier. But Athletic weren't finished yet and nor was this story.With Ronald Koeman making changes in an attempt to run down the last few seconds, clinging on to one handle of that trophy, Villalibre appeared and volleyed Munian's free-kick into the net. He had been on the pitch six minutes and now he had ensured he would be there for many more, the night only just beginning. The Spanish Super Cup final was going into extra time and that final frame.

Pierre-Emerick Aubameyang double sends Arsenal soaring past Newcastle

London, January 19 : Baby steps but perhaps, in one sense, a significant stride. Arsenal's return to the top half is hardly a cause for unbridled joy but the manner in which they sailed home dangled the promise of better times. Their struggles over the autumn went hand in hand with a damaging drought on the part of their captain, Pierre-Emerick Aubameyang, but that seemed a distant memory by the time he had scored his second goal of a win with such ultimate ease it felt like something of a novelty.
