
FM Sitharaman tables Economic Survey 2020-21 in Lok Sabha, FY22 GDP growth seen at 11% Budget 2021

New Delhi, January 29 : Finance Minister Nirmala Sitharaman tabled the Economic Survey 2020-21 in the Lok Sabha following which the house was adjourned. Today's Survey holds significance as the economy begins to recover from the pandemic-hit year. According to the survey, real GDP growth for the next financial year (FY2021-22) is seen to be 11% while nominal GDP growth is seen at 15.4%. Growth recovery is likely to be led by government consumption, the survey mentioned adding that combined fiscal deficit to ex-

United Nations chief Antonio Guterres lauds India's COVID vaccine efforts, makes this remark

New Delhi, January 29 : Calling for India to play a major role in global vaccination campaign, United Nations Secretary-General Antonio Guterres on Thursday (January 29) termed the vaccine production capacity of India as the 'best asset' that the world has today. Addressing reporters here, the UN chief said, "I know that in India there is a very high level of production of Indian developed vaccines. We are in contact with Indian institutions for that. We strongly hope that India will have all the instruments that are necessary to play a major role in mak-

ing sure that a global vaccination is campaign is made possible.""I think that the production capacity of India is the best asset that the world has today. I hope the world understands that it must be fully used," he added. On the need to democratize access to medicines, Guterres said, "I would say a very important element on the democratization of access to medicines all over the world. I appealed once again today for the licenses to be made available in order for companies around the world to be able to produce some of the vaccines that already

exist."UN chief's statement comes as India has gifted over 55 lakh doses of coronavirus vaccine to neighbouring countries. Addressing a weekly briefing, External Affairs Ministry (EAM) spokesperson Anurag Srivastava on Thursday said India plans to gift vaccines doses to Oman, CARICOM countries, Nicaragua, Pacific Island states. Srivastava said New Delhi plans to supply 1 crore or 10 million vaccine doses to Africa and 10 lakh to United Nations health workers under GAVI's (Global Alliance for Vaccines Contd...Page 6

DTFI Meets on Covid-19 Vaccine Women's safety : Unlawful procedures by Govt of Assam regarding VLTD in public vehicles and Routine Immunization

Guwahati, January 29: Soon after a third party private backend systhe horrifying Nirbhaya gang rape in the national capital in the year 2012, the Government of India set up a Committee headed by late Hon'ble Justice (Retd.) J.S. Verma to recommend amendments of Criminal Laws to enable address the issue of Crime against Women. Among the several issues looking into by the committee, the Committee also looked into the issue of provision of adequate safety measures and amenities for women. In this regard, the Committee had given several recommendations, one of them being that "all buses should be fitted with tamper proof GPS systems." Taking a step towards implementing the aforementioned recommendation of the Committee, the Central Government on 28.11.2016 issued a Notification numbered GSR 1095(E), amending the Central Motor Vehicle Rules, 1989 by introducing Rule 125-H of those Rules making the fitment of Vehicle Location Tracking Devices with Emergency Panic Button mandatory for Public service vehicles and goods vehicles with national permit in the country. However, it is a matter of deep concern that unlawful procedures are being adopted with respect to the implementation of the said Rule in Assam by the Transport Department, Government of Assam. Addressing a press meet in Guwahati today, Dr. Kamaljeet Singh Soi, an International road safety expert presently a Member at National Road Safety Council - Ministry of Road Transport & Highways, Government of India has pointed out the unlawful practices in this regard by the government of Assam.Dr Soi has also pointed out that Transport Department, Govt. of Assam despite receiving funds under the Nirbhaya framework from MoRTH, has not yet established a command and control centre for monitoring the PSV's in the state of Assam.Furthermore, while the Department has called for registration of VLTD manufacturers, without adopting a common layer backend which should be certified from the testing agencies as specified under Rule 126 of CMV Rules 1989 and should be integrated with VAHAN, it has also encouraged cartelization by a few VLTD manufacturers to undertake the implementation of Rule 125H."The said Department has also flouted the governing standards and laid rules by allowing VLTD manufacturers to use 2018 and SO 5453 (E) dated 25-10-

tem for fitments of VLT devices in the state which is not certified as per the standard of AIS 140 and is not integrated with VAHAN.The manner in which the implementation has been envisaged, suffers from several practical issues, which indeed are detrimental to the interest of the public in the state of Assam"he added.DrSoi has also alleged that the Transport Commissioner, Government of Assam is illegitimately

As far as the notification is concerned the Command and Control Centre has to be authorized by the State Government and it shall be used to provide interface to various stakeholders such as State emergency response centre, the transport department or Regional Transport Offices, VLT device manufacturers and their authorized dealers, testing agencies, permit holders, etc. as per code of practice of AIS 140. The Command and Control

It is noteworthy, that state has called for registrations of VLTD manufacturers in a haste to deliberately flout the laid Rules and governing standards issued in this regard encouraging cartelization of a few VLTD manufacturers who intend to use a non-certified backend either directly or through their dealers in the state which shall indeed perpetuate dummy VLT fitments OR fitment of non-compliant VLT devices in the state defying the main objective behind Rule 125H for women safety and security. Moreover, the procedures adopted by the Transport Department are to camouflage with the Ministry of Road Transport & Highways, Govt. of India with respect to implementation of the said Rule as the way in which Transport Department, Govt. of Assam intends to implement it is a clear case of defiance of the notifications and guidelines issued by the Ministry of Road Transport & Highways, Government of India vide GSR 1095(E) dated 28-11-2016, SO 1663 (E) dated 18-04-

The State is duty-bound to comply with the laid rules and governing standard in a legitimate manner and therefore Dr Soi has asked the state government to revoke call of empanelment/registration of VLTD manufacturers immediately, till the time they adopt a common layer backend system for implementation of Rule 125H of the CMV Rules 1989 pertaining to mandatory fitment of Vehicle Location Tracking Devices and emergency button in PSV's and Goods Vehicles with NP plying across the State of Assam. The negligence on part of the transport department shall clearly result in sabotaging the main objective of this regime as frivolous/fake/dummy installations of VLT Devices in the state shall be carried out by a cartel of few unscrupulous companies using the referred uncertified private backend in the state. Dr Soi has alleged that the Transport Department is glaringly acting with disregard of duty by flouting the mandate of Rule 125(H) of CMVR and intends to commit an unlawful act of granting approval to a cartel of VLTD manufacturers in collusion with an intent to unlawfully profiteer and cause loss to public ex-chequer thus not only abusing the public trust but also the laid down Policy with respect to the safety and security of women. In such a collusion, the manufacturers, if approved arbitrarily by the transport department shall mint huge amount of money from the permit holders for their self vested interests which indeed is a clear threat to the public interest at large. Therefore, Dr Soi has strongly opposed the tyrannical methodology adopted by the state of Assam, and the favorism being served to a few manufacturers encouraging cartelization in the state which shall indeed keeping the other deserving manufacturers deprived. Through the Fourth Pillar of democracy Dr Soi has condemned the illegitimate steps taken by Transport Department, Government of Assam and also he has requested the said Department to halt the issuance of any approvals/permissions to VLT Device manufacturers and/or any third party private backend as any such approvals, if granted shall be in complete negation to the laid down rules.He is of the opinion that the Transport Department should revoke the call of empanelment/registration of VLTD manufacturers, till the time they adopt a common layer backend system for implementation of Rule 125H of the CMV Rules 1989 pertaining to mandatory fitment of Vehicle Location Tracking Devices and emergency button in PSV's and Goods Vehicles with NP plying across the State of Assam.He also said that the Transport Department, Government of Assam should refrain from creating any monopolistic situation as it seems to be currently.

The UK has record death tolls, yet still the government has no clear Covid strategy

Back in April 2020, I wrote of my despair that so many people were desperately ill and dying because politicians had "refused to listen and act on advice". It is barely believable that I find myself with similar feelings a full nine months later. Once again, the central government has delayed decisions and not followed the advice of scientists. It failed to follow Sage advice on an England-wide "circuitbreaker" in early autumn, and went on to relax controls in December, despite

<u>Helen</u> high case numbers. Predictions of an inevitable rise in cases did not deter ministers from trying, unsuccessfully, to "save Christmas". The utterly predictable result is now happening, with pressure on hospitals and more than a thousand deaths most days, a toll even worse than the first wave. The emergence of the new, more transmissible variant has doubtless made control even more difficult, but we still seem to have been on the back foot at every stage. There is a stark contrast between the poor control measures and the outstanding scientific progress. We know so much more than we did back in April. We have a better understanding of transmission and the natural history of the infection, the immunology, and the variation in risks within the population. These advances have led to a

growing number of tools that can be used to tackle the epidemic, adding to the basic early interventions of social distancing, hygiene, protective equipment, testing and isolation. We can now add to them rapid tests, contacttracing apps, vaccines and better treatment. So why are we not in a better place? The answer is that these innovations are simply tools, and tools have to be used skilfully as part of a clear strategy in order to be effective. Underpinning this has to be engage-Ward

ment with ordinary people to make sure that the proposed interventions are understood, feasible and acceptable. Take the chaotic interventions in education in England, where the government has imposed decisions on exams, masks, mass testing and closures without sufficiently engaging teachers, schools and parents, thereby losing credibility. The response in the UK has been particularly centralised and top-down, with little attention paid to working at local level and with different groups. We can learn here from other public health strategies. Most of my research and public health practice has been in the prevention and control of HIV. Since the early days of that pandemic in the 1980s, we have learned a lot and now have a wide range of effective tools, from home-testing programmes to antiviral drugs.



Measures that directly put money into the accounts of the poor can help lift consumer demand and provide relief to households who have been suffering for one year.Similarly, tax cuts, whether in income tax or in indirect taxes, can put money in the pockets of households. Not only can this provide relief to those in the middle classes whose family businesses and sources of income have suffered, it can also help push consumer demand, and directly feeds into the mechanisms through which the economy can be put back on the path of recovery. The second theme expected in the Budget is an emphasis on investment in infrastructure. This is one way for the government to push growth, both in the short run and the long run. Houston, January 29: A43-year-old Indian-American pediatrician diagnosed with terminal cancer shot dead a lady doctor and then killed himself after taking hostages at a medical office in Austin, according to police in the capital city of the US state of Texas. The armed man was identified as Dr Bharat Narumanchi, who was recently diagnosed with terminal cancer, police said, adding that he had recently been turned down for a volunteer position at the medical facility.Police received a call on Tuesday saying a man walked into the offices of Children's Medical Group (CMG) with a gun

and was holding hostages inside the building, the CNN reported, citing Austin to Police Department press release.Initially several hostages were being held, police said, but several escaped and others were allowed to leave, except a pediatrician named Katherine Dodson. The hostages who escaped the office told officers on the scene that the man was armed with a pistol and what appeared to be a shotgun, police said. He also had two duffel bags. Dr Narumanchi had visited the CMG office a week prior to the shooting and applied for a volunteer position. The suspect had terminal cancer and had only been given weeks to live, Austin police Lt. Jeff Greenwalt told reporters on Wednesday. "So we feel like his terminal cancer probably played a large part in whatever it was that occurred in his life and what was happening yesterday," he was quoted as saying by US media reports.But for now, Greenwalt said, investigators are still trying to unravel what could have led to the



hostage situation. He called for any of the doctor's family and friends who might have knowledge about Narumanchi to contact the homicide department. Earlier, police said hostage negotiators tried to make contact with Narumanchi, but were unsuccessful. After repeated attempts, SWAT (special weapons and tactic) officers entered the building where they found Dodson and Narumanchi dead from apparent gunshot wounds."It appeared that Dr Narumanchi shot himself after shooting Dr Dodson," according to the police department's news release. The incident is still under investigation."There were five people inside the building when the suspect arrived," Greenwalt said, adding that they were all employees and no children or patients were present when the incident happened. It wasn't until the SWAT team was able to send a robot fitted with a camera inside the doctor's office that police got a full sense of the situation."We were able to see that both subjects were deceased," Greenwalt said, referring to Dodson and Narumanchi. The Travis County Medical Examiner will be conducting an autopsy to determine the official cause and manner of death.

Covid travel quarantine

If you can cut off the source, you can devote your resources and efforts to suppressing its spread, and coping with the health and social problems it has created. The approach of imposing isolation on arrivals, known as quarantine, is centuries old. At a time when an understanding of the nature of infectious diseases was virtually nonexistent, it was one of the few control methods that worked. In times of plague and pestilence, cities and states often applied it with enormous rigour. Almost a year after the World Health Organization declared that Covid-19 was a "public health emergency of international concern", the UK government is imposing a regulated quarantine regime on some international arrivals. This extraordinary delay illustrates perfectly how far the country has distanced itself from its previous position as one of the leading exponents of public health in the world. It also demonstrates a pattern in the government's handling of much of the pandemic response - taking action far too late and, even then, doing it halfheartedly. It was not until 8 June that the government introduced a requirement for people arriving from most foreign countries to self-isolate for 14 days, later reduced to 10 days. The regulations were accompanied by the possibility of fines being issued for non-compliance. There is, however, little evidence of compliance with this system and a vanishingly small number of penalties appear to have been imposed. Covid-19's ability to mutate and produce variants that may have decidedly different characteristics from their predecessors has forced the government's hand. Priti Patel announced compulsory quarantine arrangements, involving hotel stays for passengers who cannot be refused entry, such as British residents and nationals returning to the UK, who are travelling from a limited number of countries, including known variant "hotspots". These modest and disappointing proposals will undoubtedly run into several severe problems that could and should be avoided.Importantly, these new regulations do not replace the failed system of what amounts to voluntary self-isolation for the inadequate period of 10 days. The compulsory quarantine only applies to people travelling from the 22 high-risk countries. Everyone else arriving in the UK will continue to have to self-isolate according to the existing regulations. There can be no such thing as a partial quarantine. Either it is comprehensive and effective, or it will fail. A differential approach based on country of origin is undermined by the difficulty of accurately ascertaining where arrivals have come from. Global travellers may move across many countries during their journey and use various means of transport. During their travels, they may well have passed through multiple travel hubs and departure lounges, encountering and spending time close to many other travellers along the way. Determining who will be subject to self-isolation and who will be subject to mandatory quarantine will probably be a valueless task.Experience from elsewhere shows that operating an effective managed isolation facility is no easy undertaking. Preventing people who are isolating from mixing with others in the same position, in the same facility, such as a hotel, is difficult. In Australia, serious problems arose because of very close contact between people isolating and those working at the facilities. Whatever system of quarantine is adopted, the government needs to break with its insular habits and learn quick lessons from the successes and failures of other countries. An imporint rule for a quarantine system is that few, if any, exception should be permitted. Limited observance and the extensive list of groups that do not have to observe the rules will limit their effectiveness. There are up to 60 occupations or groups potentially exempt from isolation requirements, including everyone from bus drivers to workers in data system maintenance. One exempt group we should be concerned about are those commuting internationally at least weekly. Anyone can bring the virus with them, and everyone should have to go into managed isolation - especially if they travel often and have a greater chance of catching a new strain of the virus. After reaching a disgraceful toll of 100,000 deaths, it is time to focus on some key public health objectives. The government's mantra on Covid-19 should be: "Get it down, keep it down, and keep it out". That is how to maximise the benefit of the mass vaccination campaign and avoid it being undermined by variants.As recently as July and August, the UK and Australia had very similar daily new Covid-19 cases per capita, with Australia at times higher than the UK. Since then, Australia has succeeded in eliminating the virus. Successful quarantine and rapid response to flare-ups have created that success.

he formal response of the Indian and Chinese governments to the "discovery" of a newly constructed Chinese village 4.5 km inside Indian territory on Tsari Chu river, Upper Subansiri district, reflects on the current power equation in the high Himalayas. Even our media, barring a few who ran sensational headlines, soberly analysed the historical background, and resigned to the fact that the area had been under Chinese occupation for nearly 62 years since the 25 August 1959 Longju incident - the first physical confrontation between the People's Liberation Army or the PLA and Indian forces. Our post at Longju was attacked and four Assam Rifles personnel were taken prisoners of war. What followed was an exchange of protest notes, temporary withdrawal by the PLA and reoccupation soon thereafter. I analyse the implications of contrasting approaches of India and China towards border management and development, and the way forward.On 21 November 2020, Ji Rong, spokesperson of the Chinese embassy in India, tweeted the statement of Chinese Ministry of Foreign Affairs in Beijing: "China's position on Zangnan (southern part of China's Tibet) is consistent & clear. We have never recognised so-called 'Arunachal' Pradesh' illegally established on Chinese territory. China's normal construction on its own territory is entirely a matter of sovereignty." No ifs and buts, not even lip service to the 80-year-old dispute and absolute clarity with respect the right to do what it wants to on disputed "claimed sovereign territory".Global Times, the Chinese mouthpiece, analysed Indian media reports quoting experts. Qian Feng, director of the research department at the National Strategy Institute at Tsinghua University, said that "China and India haven't demarcated the border line of this area yet. So they cannot accuse China of building a village on the Indian side." The report also quoted Zhang Yongpan, a research fellow at the Institute of Chinese Borderland Studies of the Chinese Academy of Social Sciences (CASS), as saying that "It's absurd for the Indian government to use this line (McMahon Line) to determine the territory administered by China and India. Indian media should not bring about the issue when the country is still plagued by the serious situation of a COVID-19 pandemic." This, in my view, also reflects the official line that until the boundary is demarcated, it is China's right to do whatever it wants in the disputed territory. And it is also clear that since even the maps

been exchanged, the demarcation is unlikely in the foreseeable future.In fact, Chinese actions are part of its policy all along its borders. Professor M Taylor Fravel, eminent China scholar at MIT, explained that the village's construction was part of a Chinese plan of rural revitalisation, put in place in 2017 with a budget of \$4.6 billion, and is due for completion in 2020. A total of 624 model Xiaokang (which literally means 'well-off') villages have been constructed in Tibet on/near the borders. As per China scholar Claude Arpi, 965 such villages have been constructed since 2015. The Chinese aim is clear - to ensure border control/consolidation while promoting economic development and tourism. As per Jayadeva Ranade, former RAW additional secretary, the Xiaokang "border defence villages" are also intended to create a buffer along the border (inhabited by people loyal to the Chinese Communist Party and the nation). President Xi Jinping has himself spelt out the theory for defence of border areas: "Governing border areas is the key for governing a country, and stabilising Tibet". These modern villages are easy to be kept under surveillance via WiFienabled devices. And they will provide a secure base for military operations in areas where Tibetan population may turn hostile. In this context, the newly constructed village is significant because it lies, according to Arpi, on the route of the "12-yearly circumambulation of Tibetan Buddhist pilgrims around the mountain known as the Rongkor Chenmo." This pilgrimage had the character of a State ritual for the erstwhile Tibetan government.In sharp contrast to China's assertive advocation of the legitimacy of its actions, India's response ary, Line of Actual Control (LAC) and ist footfall will certainly help safeguard

Canara Bank Q3 net down 9% to Rs 696 cr due to higher provisioning



Mumbai, January 29: Public sector Canara Bank on Wednesday reported a 9 per cent drop in its third quarter net profit to Rs 696 crore, taken together with financials of Syndicate Bank that merged last April, mainly due to rise in provisioning.Gross non-performing assets (NPA) on a consolidated basis dropped 236 basis points to stand at 7.46 per cent at the end of December 31 2020. Net NPA fell 298 basis points to 2.64 per cent. One basis point is 0.01

per cent.Provisioning jumped 61.25 per cent to Rs 4,686 crore for the merged entity even as most of the provisions were for the 'others' category. Provisioning for bad debts increased from Rs 2,488 crore in the year ago third quarter to Rs 2,657 crore in the latest third quarter, the bank's presentation filed with the exchanges showed. The provision coverage ratio was as high as 84.9 per cent at the end of the third quarter.Operating profit rose 46.65 per cent year on vear to Rs 5,382 crore. Net interest income, excluding Rs s Rs 413 crore in interest reversal of deemed NPA, stood at Rs 6081 crore, rising 14.58 per cent on a year on year basis. Mr Anand is also a recipient of the "Green Hotelier" award instituted by International Hotel & Restaurant Association (IH&RA) - an United Nations recognized industry body. "In the service industry we have something called the moment of truth every time you interact with a guest. These moments of truth have become moments of trust, and trust is the new currency. What gives this trust is cleanliness, hygiene, safety, sanitisation. So what we have to do now is what I call create cleanli-

ness theatres. What used to be done at night can now be done during the day in the presence of guests so that they can see the manner in which food is to be served. We had to give them visible cues to win their trust and reinvent service like we had never done before. So I think after hoteliering was discovered this is the first time such creativity and service designs have been done," said Anand who joined ITC in 1978 - the second generation in his family to do so.Nakul Anand, who says "If you don't see green, you'll see red", has initiated various sustainable initiatives like `Responsible Luxury' and `Food Sherpa' programme under which ITC chefs scour their destinations for street or local food and serve them in fivestar ambiance as part of their Local Love menu. Mr Anand believes sustainable practices must be embedded in our business philosophy. Farmers draw hard line, reject Centre's offer to stay farm laws

New Delhi, Jan 29 : Drawing the hard line to press for the repeal of the new agriculture laws, farmer unions Thursday rejected the Centre's offer to keep the laws in abeyance for 18 months and form a joint committee to address grievances. The unions, scheduled to return to the talks table Friday, were virtually split down the middle at a meeting to discuss the Centre's offer. Sources told The Indian Express that of the 32 unions from Punjab, more than a dozen were in favour of accepting the offer, but the majority vote carried the resolution to reject the offer.A statement on behalf of the Samyukt Kisan Morcha, the umbrella body of organisations spearheading the protest, released by Darshan Pal of Krantikari Kisan Union, stated: "In a full general body meeting of the Samyukt Kisan Morcha today, the proposal put forth by the Government yesterday was rejected. A full repeal of three central farm acts and enacting a legislation for remunerative MSP for all farmers were reiterated as the pending demands of the movement."The Morcha, the statement said, "pays homage to the 143 farmers who have been martyred in this movement so far... Their sacrifice will not go in vain and we will not go back without the repealing of these farm laws". It referred to a meeting with Delhi Police officers earlier in the day and said while police had requested the farmers not to conduct a tractor parade in Delhi on Republic Day, they had reiterated that they intend to go ahead with their plan of a parade on the Outer Ring Road of Delhi.Maintaining that their protest was becoming a "people's movement... nationwide", the Morcha said farmers were uniting in Karnataka, many parts of Kerala, Chhattisgarh, Bilaspur and Rampur in Uttarakhand. "Farmers, labourers and common people under the leadership of Mazdoor Kisan Shakti Sangathan are reaching Shahjahanpur border. Protests against neo-liberal policies are being conducted through puppets shows and songs," it said. Ahead of the meeting of the Morcha, the Kisan Ekta Morcha, in a Twitter post, had said "jis kaam ke liye aaye thhe, usko poora kiye bina wapas nahi jayenge (we will not go back till we complete the work for which we had come)".Rakesh Tikait, president of BKU (Tikait) and one of the spokespersons for the Morcha, said: "We came here to get the laws repealed. After long deliberations, we came to this conclusion that we will not return till the laws are repealed. We can stay here for six more months, it hardly matters to us. People have trust issues with the government. What if they implement these laws again after a stay for a short period? We, therefore, decided to reject the proposals of the government.""On MSP, we will tell them to make an Act to assure minimum support price for the produce of farmers. Regarding the Republic Day tractor parade, we will be meeting Delhi Police again on Friday, though they have denied us permission for the parade on Outer Ring Road," he said.Jagmohan Singh Patiala, general secretary of BKU (Dakaunda), said: "We had a meeting of 32 farmer unions of Punjab in which we decided to reject the government proposal to stay these laws for one-and-a-half years. A similar consensus was reached at the meeting of the SKM as well in the evening. We came for the repeal of the farm laws and will not settle for anything less."Buta Singh Burjgill, president of BKU (Dakaunda), said: "We discussed many aspects. What if the government is asked to increase the duration of the stay on these laws from one-and-a-half years to a minimum 4 years, so that they cannot implement them during this term? What if this government returns to power again? These laws will be hanging like a sword... It will not be so easy to start another farmer movement such as this soon, so nothing less than repeal of these laws is acceptable to us." Moreover, several BJP party leaders have said that there could have been more deliberations on the farm Bills or these could have been sent to a House panel once objections were raised since that would have weakened the opposition to the laws. The Supreme Court's stand that Delhi Police should decide on the entry of protesting farmers into Delhi on Republic Day was also a factor that prompted a rethink.But there are others in the party who think that a climbdown is a bad precedent. "Once you take a U-turn on a major reform, there will always be pressure against every move. If you give up once, you will be forced to do so on other issues as well," a party leader said.

Scrappage policy approved, to come into effect from April 2022

New Delhi, Jan 29: Union Road Transport and Highways Minister Nitin Gadkari had, in September last year, said the scrappage policy was one of the top priorities. The Ministry of Road Transport and Highways (MoRTH), in its vehicle scrappage policy approved on January 25, confirmed the scrapping of government vehicles older than 15 years, reported CNBC TV18. The policy will come into effect from April 1, 2022. From the aforementioned date, vehicles used by the government departments would be put off service if they are older than 15 years. Union Road Transport and Highways Minister Nitin Gadkari had, in September last year, said the scrappage policy was one of the top priorities. The move is expected to reduce air pollution while simultaneously spurring demand in the automobile sector. Sources to CNBC-TV18 #ScrappingPolicy would apply to central and state govt vehicles & green tax proposal to apply to all vehicles pic.twitter.com/1AWayL7liNFinance Minister Nirmala Sitharaman had in August 2019 said a scrappage policy is in the works, when the slowdown began in the auto industry in the aftermath of the COVID-19 pandemic. On July 26, 2019, the government had proposed amendments to motor vehicle rules to allow the scrapping of vehicles older than 15 years in a bid to spur the adoption of electrical vehicles. In July last year, the National Green Tribunal rapped the MoRTH for the delay in issuing guidelines on the scrapping of vehicles. A bench headed by NGT Chairperson Justice Adarsh Kumar Goel had said a proper mechanism to set up authorised recycling centres compliant with environmental norms was an urgent need in view of a large number of 'End of Life Vehicles' (ELV). The draft scrappage policy, whose details were yet to be shared in public domain by MoRTH, was also expected to offer incentive to motorists who decide to scrap their old vehicles. The incentives were expected to be a waiver of the registration fee and a discount on the road tax. The old vehicles would be used in recycling clusters - thereby, cutting the cost of raw materials. The scrappage policy is expected to boost demand for new vehicles in a COVID-hit economy. It is considered as crucial for the revival of India's auto sector, which was struggling since a year before the onset of pandemic. Apart from the above incentives, a number of disincentives for those retaining old vehicles were also reportedly discussed. The latter, which includes higher fee for fitness certificates of 15-year-old personal vehicles, was announced through the Green Tax policy.

As of January 27, 57 United Kingdom (UK) returnees tested positive for Covid-19, however, it is yet to be confirmed if any of them carry the new, more transmissible strain of COVID-19. The state government is yet to allow schools and colleges to reopen, while the ban on social, religious and political congregations continues with the extension.

This season may be serial-winner Tom **Brady's most remarkable achievement**

Tom Brady, January 29: Moments after triumphing in his 14th conference championship game last Sunday, Tom Brady jogged over to the Lambeau Field stands and waved down a security guard. "Can I say hi to my son?" he asked.And though the kid's body was covered from head to toe against the cold and his face shrouded against Covid, there

eventually caught up with him, to the tune of three second-half interceptions, it was nonetheless striking in comparison to the baffling passivity of Green Bay's Aaron Rodgers.Here, after all, was the presumptive league MVP, the quarterback who is unquestionably more physically gifted than Brady, who plays the most difficult team game



was no doubt that this was Brady's oldest, Jack. The scene, captured by NFL Films, stood out as much for the boy's size as its sentimentality. It is hard to believe that kid, not even a glint in his old man's eye when Brady made his first Super Bowl start in 2002, is 13-years-old now. Such is the undeniable staying power of Brady, who will extend his unprecedented streak of 10 NFL championship appearances into an unfathomable third decade when the Super Bowl kicks off in his home stadium in Tampa on 7 February. That he managed to pull this off barely a year since leaving New England, with a Tampa Bay Buccaneers team that hadn't so much as sniffed the postseason since 2007, is all the more stunning. On top of that, Brady is 43 - a fact that was not immediately obvious from his performance in Tampa's 31-26 road victory over the NFC-leading Green Bay Packers last week. To watch that game was to witness a pocket-dwelling throwback who not only still had plenty of zip left on his fastball, but also did not hesitate to chuck it deep. Of his 36 attempts, none was cheekier than the 39-yard touchdown pass he made to Scotty Miller just before the

half. And while Brady's aggression

And yet when the Packers found themselves eight points behind and eight yards from the Bucs' end zone with less than three minutes left in the game, Rodgers - despite all the moxie he showed a week earlier on a short scoring run against the Rams couldn't find the temerity to exploit a similar opportunity against the Bucs. Rather than seize the moment and run to daylight, Rodgers winged a tweak third-down ball at the knees of a double-covered Davante Adams. It's no wonder Packers coach Matt LaFleur settled for a field goal instead of going for it on fourth down, all but guaranteeing that Brady would never return the ball. Somehow, Brady continues to draw rocket fuel-grade motivation from a Florida-sized inferiority complex that dates to his time sharing snaps at Michigan and that fateful day the Patriots selected him 199th overall in the 2000 NFL draft behind the Browns' Spergon Wvnn, the 49ers' Giovanni Carmazzi and other throwaways. Ever since the Jets Mo Lewis knocked out Patriots franchise passer Drew Bledsoe the very next year, Brady has essentially fulfilled his destiny as football's Lou Gehrig - who was six years younger than

Brady's more like the Serena Williams of football, a stubborn legend who has endured long enough to see too many rivals come and go. That Touchdown Breesus had to spend his probable last moments on the Superdome field watching Brady play catch with his own begotten son before sauntering off to throw another day, on some level, had to smart. Football has always been a marathon sport for Brady. And in the process of breaking with the tradition of Joe Namath, Kenny Stabler and other declining Hall of Famers put to pasture away from their original teams, Brady now stands on the precipice of defying an even deeper entrenched convention: the idea that a player-built super team cannot win in Year One. Consider: Brady just divorced longtime coconspirator Bill Belichick at the New England Patriots. And after signing with the Bucs, he soon found himself being chased out of public parks and otherwise robbed of time to mesh with his new receivers and coach Bruce Arians' chancy vertical pass attack because of Covid restrictions. And then: putting on a brave public face as his parents waged a private battle with the virus.But in little more than 10 months in Tampa, Brady set every single-season franchise mark imaginable - in passing yards (4,633), in touchdowns (40), and that's just during the regular season - while transforming a mistake-prone offense into a league juggernaut. Well, besides making LeBron James insanely jealous, it would redefine what it means for a pro to be past his prime. Of course the task ahead of Brady isn't easy. The Chiefs quarterback he faces, 25vear-old Patrick Mahomes, is a wizard who gutted the second-seeded Buffalo Bills on a bad foot a week after suffering a concussion - and also pipped Brady's Tampa team in Week 12 to draw even with his elder in their four head-to-head matchups.What's more, Mahomes not only has an array of weapons at his disposal, but a cunning play designer in offensive coordinator Eric Bieniemy, a masterful play caller in coach Andy Reid and an ace in the hole in defensive coordinator Steve Spagnuolo - the architect of the pressure-packed schemes that tripped up Brady in those Super Bowls against Eli's Giants. Finally: this will be Mahomes's second time playing in a Super Bowl in the past three seasons. Not since Michael faced Magic in the 1991 NBA finals has there been a torch-passing ceremony with potential this rich.Much as the odds favor Mahomes, a surefire Hall of Famer if he were to quit right now, there's something to be said for Brady's singular experience. In a game where players are chewed up and spat out like the rubber that sods so much of the field underfoot, the fact that Brady is still topping himself in overtime may be the most remarkable of his myriad achievements. (Imagine, a seventh championship ring at this stage...) And now that the daddy of them all, the Super Bowl, is on the horizon again? 
