

### A total of 699 minor to big road accidents occurred between January and December last year in Guwahati

Guwahati, January 31 : A total of 699 minor to big road accidents occurred between January and December last year in Guwahati city. A total of 215 people were killed in these road accidents.To prevent road accidents, Assam State Transport Department has been implementing various awareness programs, including the National Road Safety Month but the number of road accidents in Guwahati has not decreased as expected. The number of road accidents is on the rise due to the

violation of traffic laws by vehicle drivers on the highways and on the city roads. The number of road accidents in the city has not declined after the lockdown due to the corona-centric situation. According to the Assam Police's Traffic Branch, the number of road accidents on the city's national highways has been the highest in the last one year.A total of 103 road accidents in January killed at least 30 people and injured 72 others. ### The problem is poverty, however we label it

How ingenious are the British! Like the legendary Inuit people who coined 57 words for snow, we have devised a long list of clever aliases for the stuff that dominates everyday life. Know the ones I mean? Try food poverty. Fuel poverty. Child poverty. Clothing poverty. Transport poverty. Period poverty. These are phrases mouthed in Westminster and plastered across newspapers (which, this week, are discussing "digital poverty"). They help shape the UK in the 21st century. But this ever-growing jungle of subcategories obscures the one true problem they have in common. It is poverty: the condition of not having enough money to live your life. If your only choice of an evening is between skipping dinner or going to sleep in the cold before waking up in the cold, then you are not carefully selecting between food poverty and fuel poverty, like some expense-account diner havering over the French reds on a wine list. You are simply impoverished. If you are using a sock as a sanitary towel, the problem lies not in the time of the month but in your lack of income which doubtless means you're also not getting enough food or heating. Gas bills might jump or petrol prices soar, but if those things tip you into all-out crisis, that's because you were already poor.Poverty cannot be shelved tidily under different classifications, like books in a library. It jabs its tentacles into all parts of your life, distorting and defining everything from how you feel about yourself to whether you live or die in this pandemic."Want" was how William Beveridge referred to poverty in his landmark report of 1942. For him it was the first of five "giant evils" that had to be slain in order to rebuild a bombed-out Britain. Today, however, it is the evil that dare not speak its name. It must instead be broken down into discrete categories, all the better to tuck into Whitehall documents or charity campaign strategies. In that fake neatness lies both great political hypocrisy and huge social

words as simple and shaming as poverty. It's why the welfare secretary, Thérèse Coffey, brightly refers to those forced to live on donated tins as food bank "customers". No, far more congenial to qualify and to narrow. Oh, it's about "cashflow problems", as the foreign secretary, Dominic Raab, so delightfully put it. Or schoolkids not having an internet dongle. Smaller messes take less time and money to tidy away. Whereas,

money and power to people who have none. Because who knows what the poor might do if they were to - whisper it - choose for themselves? This is why Coffey's predecessor, Iain Duncan Smith, blamed the problem of child poverty not on his colleagues slashing benefits - so as to teach mums and dad that "children cost money" but on the parents themselves being drunks and smack addicts.In

But just weeks before launch: "'Child Poverty Action Group' was adopted as the name ... as likely to win more public sympathy than 'family pov-

In my years of reporting on poverty and inequality, one reliable rule of thumb is that the kids are last to go without. First to starve are the mums. They're the ones who live on hot water and toast to keep the family in meals. But the terminally prejudiced cannot bear too much reality, and it is they who set the tone of the debate.In his recent book The New Poverty, the journalist Stephen Armstrong recounts how the Archbishop of Canterbury, Justin Welby, travelled in 2015 to Folkestone in Kent, where he met Graham and Lisa Sopp. The couple had moved there after Graham had lost his job as a security guard and Lisa was promised cleaning work. Then their new flat fell through, Lisa's employer was taken over, and one of IDS's benefits offices kept messing them about. Suddenly, they were sleeping in a tent on the cliffs, and Graham got very ill. They took to walking the clifftops, identifying the perfect spot from which to jump.On meeting them, Welby observed: "There is no system in the world that will stop people having problems, but we must have a structure of support for people that meets not merely their financial needs but also their need to be treated as distinct human beings of

Assam joins the World NTD Daymovement to reiterateits commitmenttowardselimination of NTDs

Guwahati, January, 2021: World Neglected sis in all endemic blocks achieving the tar-Tropical Diseases (NTD) Day, which is being observed today across India, is a key moment in the fight against NTDs, a group of preventable diseases include Lymphatic Filariasis (Haathipaon), Visceral Leishmahave only a very ment benefits and prevent eviction, could not sign into law two niasis (Kala-Azar), leprosy (Kusht-Rog), challenge due to its rapid geographical etc.that are responsible for killing and disabling millions of people in India every year. Now, as India takes a stand against NTDs in alignment with the WHO NTD Roadmap 2021-2030, Assamhas reiterated its commitment to ensuring that India's NTD elimination goals are met. Speaking about the state's determination to address the challenge of NTDs, Dr Harpal Singh Suri, Joint Director cum State Programme Officer, Government of Assamsaid"we remain committed to ensuring India meets its NTD elimination target much before 2030". Out of 27 districts in the state, 10 districts are endemic for lymphatic filariasis and another 17 districts are non-endemic. Out of 10 filaria endemic districts, we are targeting 9 districts for LF elimination in 2021. Prevention and control of endemic NTDs is being prioritised through national disease control programmes for Lymphatic Filariasis, Visceral Leishmaniasis, Leprosy, Rabies, Soil transmitted Helminthiasis and Dengue which have globally aligned strategies and dedicated annual financial outlay. Significant progress has been made towards achieving the elimination targets for Visceral Leishmaniasis (Kala-azar) and Lymphatic Filariasis (LF) in Assam. Assam has

get of elimination (Zero indigenous cases). Of the LF endemic districts, 98 out of 272 have been validated for interruption of transmission (TAS-1) and have successfully stopped MDA. Dengue remains a dengue, chikungunya, snakebite, rabies spread, but Assam is sustaining the case fatality rate at 0 since 2018. Service delivery for all diseases including NTDs is through the agency of public health systems. Platforms are being created for Filaria, Visceral Leishmaniasis, Soil transmitted helminthiasis and leprosy to harmonize elimination efforts in case finding, vector control, mass drug administration etc. wherever possible. Intersectoral coordination for vector control are being strengthened such that gains made for dengue, filaria and VL individually. In Assam, NTDs like Lymphatic Filariasis, pose a significant public health challenge. However, the state has been taking concrete steps against these diseases. While COVID-19diverted resources and attention away from other critical health issues like NTDs, Assamwas quick in resumingNTD related activities in alignment with the WHO's guidance. Speaking about the state's efforts against NTDs,Dr. Surisaid"Out of 10 filaria endemic districts, 9 districts have already successfully completed/passed 1st& 2ndTAS.We will conduct 3rd TAS in February 2021.After successful passing of 3rd TAS the state may be able to apply for ELF certification. We are confident that our efforts will pave the way for building an NTD-free generasuccessfully reduced Visceral Leishmania- tion in India. We will eliminate LF by 2021".

The alliance was formed with the aim to promote solar energy in 121 member countries and to mobilise over \$1

trillion of investment for the to the alliance will be open to all deployment of solar energy at affordable costs. It is the first intergovernment organisation headquartered in India, in Gurugram.In the wake of Covid-19, ISA has been working towards providing 24×7 electricity to some member countries to power cold storages that will store vaccine. The ISA is a coalition of solar resource-rich countries that lie either completely or partly between the Tropic of Cancer and the Tropic of Capricorn. Eightynine countries have signed the ISA's Framework Agreement and of these 72 have deposited their instruments of ratification. Two weeks ago, India said membership

ndia's booming stand-up comedy space took quite the hit due to Covid-. 19, with offline gigs no longer a viable option. But what the pandemic failed to disrupt was the dominance of Hindu, upper-caste men, understood to be the 'whole' of the comedy scene. The names in the 'top five' list of comedians in India stand witness to this. Women comedians end up in a different category altogether - that of 'women comedians', and not simply comedians. But the rise of Muslim women comedians in India and across the world is a silver lining. Their rise is not coming out of thin air, nor does the themes and punch lines in their performances. India's current sociopolitical climate has a major contribution in ensuring that their jokes land well, even when they are inside jokes. Because it is all about having a voice. The value of a spectrum band depends upon various factors, like ecosystem but the most important factor is its propagation characteristics. The lower frequency spectrum is more valuable compared to the higher frequency as the radio waves riding on the former travels further, thereby requiring fewer base stations, which means less operational costs. The value of E and V band spectrum is low because they have very poor propagation characteristics as they fall between 71-76 Ghz and 81-86 Ghz (E band) and between 57-64 Ghz (V Band). These bands are like fibre and can be used for broadband services but not for direct mobile connectivity. According to some analysts, the telecom operators are opposed to the move to delicense the E and V bands as they fear that technology companies may enter into the broadband market and use the delicensed spectrum, which would come free of cost, to provide services to consumers. This may lead to a non-level playing field as telecom operators have spent billions of rupees in acquiring access spectrum to offer the same kind of services. Healthcare workers will be visiting as many as 2 crore households to ensure that no child is left without the protection of the polio vaccine, it added.Dr. Harsh Vardhan said, "Before the start of the program, India had 60 per cent caseload of Polio worldwide. With the last case of Polio reported in Howrah on January 13, 2011, the country has been free of Polio for a decade now". The drive was earlier scheduled from January 17, however was postponed due to the nationwide rollout of the COVID-19 vaccination drive. An estimated 17 crore children in the country were on Sunday given polio vaccines as part of the government's ambitious National Polio Immunisation campaign."We are hoping that during this campaign we have covered around 17 crore children between the age group of 0-5 years," a official of the National Polio Programme said in New Delhi.President APJ Abdul Kalam had launched the campaign in New Delhi on Saturday. The country has reported 641 polio cases in 2006, as compared to 66 in 2005. The entire state machinery was activated to make the campaign a success. It was launched to control the virus from circulating during its peak season of September-November, he said. Out of the total 641 cases reported so far, 90 per cent of the cases are in Uttar Pradesh, where senior officials monitored the campaign, the official added. The state has reported 519 polio cases, followed by Bihar where 57 children have been afflicted with the paralytic disease. Delhi has reported six cases. The other cases were reported from Haryana (18), Uttaranchal (13), Punjab (8), Maharashtra (5), Gujarat (4), Madhya Pradesh (3), Assam (2), and one each reported from Chandigarh, Himachal Pradesh, West Bengal, Jammu and Kashmir, Rajasthan and Jharkhand.

### China may trigger fresh crisis along LAC

New Delhi, Jan 31 : Even as soldiers battle the winter conditions, the greater challenge for the Indian Army lies in anticipating events and preparing for contingencies in the coming summer months. The PLA military strategy appears to be focused on two objectives - strengthening control over the disputed areas along the LAC and overcoming their war-fighting weaknesses in Tibet.Former Northern Army Commander The standoff at the Line of Actual Control (LAC) in Ladakh is set to continue through the winter. There is minimal possibility of any significant military moves during the winter months, and it has been reported that the People's Liberation Army (PLA) has already moved 10,000 soldiers from depth areas back to their permanent garrisons in Xinjiang and Tibet military regions. The Indian Army, even if it wishes to, will find it more difficult to pull out soldiers. With the roads to Ladakh closed, both the moving out of troops and their re-induction in an emergency, is extremely difficult. Even as soldiers battle the winter conditions, the greater challenge for the Indian Army lies in anticipating events and preparing for contingencies in the coming summer months. The overall political intent of the Chinese leadership in precipitating the crisis along the border is still open to differing interpretations, but eight months into the standoff, there is greater clarity to their military aims. The PLA military strategy appears to be focused on two objectives --- strengthening control over the disputed areas along the LAC and overcoming their war-fighting weaknesses in Tibet.It is becoming increasingly evident that the primary element of the PLA's military strategy is to change the nature of disputed areas to give permanence to their claims. In Ladakh, this is being attempted by physically occupying the disputed areas on the north bank of Pangong Tso or physically preventing the Indian patrols from going up to their claim lines at Depsang. Despite nine rounds of military-level talks, there has been no movement forward on disengagement from these two areas. The construction of a village in the disputed Longju sector of Arunachal Pradesh is another ploy to firm up China's claims. While this area has been under Chinese control since 1959, the fact that India also has a claim to this area is well known to both sides. It had been an accepted norm that both countries should avoid any provocative move in the disputed areas. In 2014 and 2016, the PLA had objected to the construction of small irrigation projects at Demchok, claiming this was a disputed area. However, all protocols and norms have now lost their sanctity. In 2005, both countries signed an agreement on the 'Political Parameters and Guiding Principles for the Settlement of the India-China Boundary Question'. Article VII of the agreement states, "In reaching a boundary settlement, the two sides shall safeguard due interests of their settled populations in the border areas." By building villages and settling civilians in disputed areas, India could be presented with a fait accompli during the border negotiations. The second element of the PLA's strategy is to overcome its war-fighting weaknesses in Tibet, and many of the steps undertaken by the PLA in this regard precede the Ladakh standoff. The most obvious disadvantage is faced by the PLA Air Force due to the rudimentary support facilities at the airfields and the problems in operating from high-altitude facilities, which limit the fuel and weapon payloads that can be carried by an aircraft. Some of these weaknesses are now being attempted to be overcome through the development of new military facilities. A September 2020 Stratfor report by Sim Tack pointed out that after the Dokalam incident of 2017, China "started constructing at least 13 entirely new military positions near its borders with India."The new constructions include three air bases, five permanent air defence positions, and five heliports. Four air defence positions are coming up within the existing airbases, along with other facilities such as additional runways and blast pens. The report states that the recent Chinese infrastructure developments are aimed at "strengthening its ability to project air power along the entire Indian border."Another area where the PLA has a deficiency is its training standards and the ability to fight a high-altitude war. Here again, some attempts to improve standards are visible. In the last few years, the Chinese Army has attempted to introduce realism in training by setting up "blue forces" in the combined-arms training centres that act as an enemy to PLA units.Coming specifically to Tibet, the PLA Army and Air Force training exercises have steadily increased over the years. These details have been comprehensively covered in an Observer Research Foundation paper, "PLA joint exercises in Tibet: Implications for India." What is noteworthy is that in 2018, 2019 and 2020, major PLA exercises were held in January and February, the coldest months of the year.

### 5G Demonstration Goes Live in Hyderabad Ahead of Commercial Rollout

New Delhi, Jan 31: Airtel on Thursday announced that it had become the first telco to successfully demonstrate live 5G service over a commercial network in Hyderabad. Taking on Reliance Jio, the New Delhi-based telco stated that it operated 5G and 4G concurrently over the existing liberalised spectrum in the 1800MHz band through the Non-Standalone (NSA) network technology. Airtel 5G is touted to deliver 10 times the speed of existing network technologies - allowing users to download a full-length movie in a matter of seconds on a 5G phone. Airtel worked with its equipment partner Ericsson to enable the new experience. The operator claimed that it had the capability to operate its 5G network over existing technology-neutral spectrum in mid-bands that are at 1800MHz, 2100MHz, and 2300MHz frequency alongside the sub-GHz bands available at 800MHz and 900MHz. The transition to 5G is available through software upgrades over the existing network infrastructure, the operator said. If permitted by the Department of Telecom (DoT), Airtel stated that it could operate its 5G and 4G networks dynamically within the same spectrum block and is ready to deploy 5G in a matter of months. However, the operator didn't provide any specific timeline on the commercial rollout of its 5G network in the country."The moment we receive government approvals, and we have the right spectrum bands and in adequate quantities, we'll be able to roll this [5G] out immediately," said Gopal Vittal, MD and CEO, Bharti Airtel, during a virtual media briefing.For the early demonstration, Airtel used Oppo Reno 5 Pro and Oppo Find X2 Pro smartphones. The operator, however, said that over 20 commercially available 5G phones in the country would be ready for Airtel 5G. Existing users will also not be required to upgrade their existing SIM cards to get the next-generation network experience on their compatible handsets. In December, Airtel archrival and India's biggest telecom network Jio announced that it would start rolling out its 5G service in the country in the second half of 2021. The operator also promised to test its 5G network at scale, though it is yet to demonstrate its offering to the public. Airtel's 5G demonstration is live at select stores in Hyderabad. The operator is claiming to maintain social distancing norms to curb coronavirus spread while showcasing the new experience.



#### Australian Open tennis players Wales defender Keith Pontin's death leave quarantine as those may be linked to heading ball remaining express frustration

London, January 31 : The death of the former Wales and Cardiff defender Keith Pontin may have been linked to heading the ball during his football career, an inquest has heard.Pontin played for Cardiff between 1976 and 1983, winning two caps for Wales, but was diagnosed with dementia in 2015, at the age of 59. His family later said they believed his condition was linked to years of heading the football and multiple concussions during his career. Pontypridd coroner's court heard Pontin died at the Royal Glamorgan hospital on 2 August last year, aged 64.Graeme Hughes, the senior coroner for South Wales Central, opened and adjourned an inquest into Pontin's death. "I am content to hold an inquest touching on the death of the late Keith Pontin," Hughes said. "I do so because of the evidence I have received from my officers and from preliminary postmortem investigations."There is reason to suspect that Mr Pontin's death may have been unnatural in that his death may have been caused or contributed to by his work in that during his earlier life, he was a professional footballer."There is some evidence within the medical investigations that have been undertaken so far Heading study at the London

Melbourn, January 31 : Australian Open tennis players have started to leave hotel quarantine after two weeks of isolation, but those still confined to their rooms are expressing frustration on social media.All players will be released between Thursday and Sunday as the clock runs down on each flight's 14-day quarantine period. But those players in "hard quarantine" have been told they will have to wait an extra day to leave their rooms.Players were notionally to be allowed out of their hotel rooms to practise and train for five hours a day, but the 72 players that arrived on three charter flights with positive Covid-19 cases on board have been forced to stay in their rooms for the full 14 days, making preparing for the championship extremely difficult.US world No 49 Sandgren Tennys expressed displeasure that his hard quarantine would



be extended until midnight Friday."I just found out we're not going to be able to leave the room until midnight tomorrow," Sandgren said on Instagram."That will put us at close to 15 days in this room. It's also another day we can't practice. We play Saturday, Sunday, Monday, play a match on Tuesday. A competitive tennis match ... [Including travel] 16 days off, three days hitting. Tennis match."My name's Tennis Australia and I'm sooooo cool."Sandgren went on to say he had been told that the first day players spent in hard quarantine counted as "day zero" rather than "day one"."So they started the count from zero?" he said. The charter flights have so far been connected to eight Covid-19 cases, including Spanish player Paula Badosa. Sandgren has already faced criticism after Australian authorities decided to allow him to board a plane to from the US to Melbourne despite testing positive to Covid-19. This was due to viral shedding after the player was infected in November, and he has since recovered. Thursday's Instagram video renewed online condemnation with many labelling Sandgren a "sook". The player criticised those who referenced the stark difference in Australian and US Covid-19 death rates."Comparing country's death rates as a diss is truly disgusting. Just call me a piece of shit like a normal person," he wrote on Twitter.Georgia's Oksana Kalashnikova has also expressed her displeasure at the delay.French player Richard Gasquet was one of the first players to leave the Pullman Hotel in Melbourne. The 34year-old told the Age newspaper that his two week "soft quarantine" wasn't too gruelling."You know we could practise five hours a day, so it was no problem," he said. 'Two hours of tennis was enough, [plus] I could go to gym, I could see the physio. Everything was perfect."Gasquet said that, along with training, fine dining was on the top of his priority list."In France, there are no restaurants [open] at all, so very happy to be in Australia."A number of players in including grand slam champions Serena Williams and Rafael Nadal have been released in Adelaide where they will play an exhibition match before travelling to Melbourne ahead of the first day of the Open on 8 February.

#### **Manchester United** will lack fireworks of old, says Mikel Arteta

Manchester, January 31 : Mikel Arteta accepts that meetings between Arsenal and Manchester United lack the fire of days past, with VAR contributing to a broader cooling of tempers in high-profile fixtures.Flashpoints were the norm when the two sides faced each other, as they will at the Emirates on Saturday evening, during the 1990s and 2000s. Both have fallen from grace since the days of dominating together at the top and the match-up has lost much of its old sting. Arteta sees it as part of a wider trend in which the intense scrutiny upon players encourages them to behave."I think it has calmed down, but not only with Arsenal and Man United fixtures," he said. "In general you see the way the derbies used to get played and it's not the same right now. The game is evolving, we are educating the players in a different way and for sure they are not allowed to do some of the things they used to. With VAR that's even less. So it's a different game to that time." A game at Old Trafford in 1990 saw a 21-man brawl that led to points deductions for both sides. There was further controversy in 2003 when Arsenal players' reactions to a late Ruud van Nistelrooy penalty miss landed the club a £175,000 fine. The infamous "pizzagate" followed a year later but Arteta thinks the chances of a repeat in the VAR era are slim."You are much more controlled and policed so you know you're not going to get away with certain things that you were used to before," he said. "It's the way the game is evolving. It's a natural thing."This time Arsenal, in ninth, will host second-placed United.

#### **Thomas Tuchel vows** 'not to be too stubborn' as Chelsea manager

Berlin, January 31 : Thomas Tuchel has dismissed concerns about Chelsea's history of sacking managers and said he has worked on improving his stubborn streak after falling out with hierarchies at his former clubs.Tuchel was in an open mood as he was unveiled as Chelsea's manager on Thursday, revealing that he has received a supportive message from Frank Lampard, and he did not shy away from discussing his abrasive reputation. The German left Borussia Dortmund under a cloud in 2017 and was fired by Paris Saint-Germain last month after falling out with the sporting director, Leonardo. There have been suggestions that Tuchel could struggle with the politics at Chelsea, who appointed him on an 18-month deal after firing Lampard. Dortmund's chief executive, Hans-Joachim Watzke, has called the 47-year-old "a difficult guy". Yet Tuchel, who vowed to use Chelsea's academy players, defended himself and insisted he was not worried about working for Roman Abramovich."It's pure passion," Tuchel said. "Also some principles. Your word is your word and I trust the word of a man. There's always two sides to a story and I'm not here to blame anybody. I do also see this in myself. What I like now, why I am very positive, is that I am absolutely selfaware that this is a thing to improve and to be also more relaxed and maybe not to be too stubborn in my beliefs."The other thing is the structure that I find here is very clear and very easy. There are not many people who make the decisions and I can live with that. When things are clear, it is on me as the head coach to on one hand adapt and on the other hand make my opinion clear and give analysis of where I think we can improve. I hope this comes along in the right way."Tuchel had one training session before his first game, a 0-0 home draw with Wolves on Wednesday. Chelsea, who host Burnley on Sunday, lie eighth in the Premier League despite spending £220m last summer. Tuchel knows he must qualify for the Champions League this season and challenge for trophies as soon as possible."Maybe nobody expects me to be here long, maybe because of the history of coaches and Chelsea," Tuchel said. "Maybe I stay long. If I don't stay long, I don't stay long. I cannot lose my focus right now."Tuchel has not spoken to Abramovich. His discussions were with Marina Granovskaia, the influential director, and Petr Cech, the technical and performance adviser. "This was first of all confidential and then very trustful," Tuchel said. "Very honest and very clear. There was no moment of hesitation."Although Chelsea were drab against Wolves, Tuchel's favoured style is attacking, aggressive football. "I want to feel a certain level of energy," he said. "I want to feel a special bond between the players. I want to be entertained."Tuchel's first starting lineup was heavy on experience and contained one academy player, Callum Hudson-Odoi. Yet he made a point of praising Mason Mount, who was pivotal for Lampard, and indicated that Billy Gilmour might not leave on loan. The tone was positive. Tuchel laughed when asked whether he is a football nerd or a cool guy. "You want me to tell you how cool I am?" he said. "How uncool would that be? How nerdy would it be if I said now how cool I am! No, I am here as a manager. It is about football, football, football."I'm pretty normal. I like to spend time with my family. I learned that you need your time off. You cannot control everything. I am not the guy who thinks he can treat a player better than the physiotherapist, I am not the guy who thinks I can clean the boots better, or do the kit better than the kit guys or drive the bus better than the bus driver. I am the guy for the dressing room, for the tactics. I love to work in a nice environment where it is possible to smile and don't confuse it with not being competitive. I know that it's on me to live up to these principles."The only note of controversy came when Tuchel admitted to a childhood love of Tottenham, who host his side next Thursday. "Now I'm absolutely aware I work for their big rivals," he said. "You can be very, very sure we will do everything we can to beat them.'

### French Brexit travel rules raise fears over Six Nations matches

Paris, January 31 : Fresh doubts over whether the Six Nations will go ahead as scheduled have emerged with Brexit red tape presenting a stumbling block to the tournament. Organisers have revealed they are still waiting on approval from the French government over travel exemptions required with the UK no longer part of the EU - 10 days before the championship begins.After the French authorities updated their regulations this week, all travellers from non-EU countries are subject to mandatory seven-day quarantine, including French citizens. That threatens France following their match at Twickenham as well trips to Paris for Scotland and Wales.Six Nations organisers said on Wednesday they are confident of receiving exemption from the French government - but there have been recent examples of sports teams having to postpone games, including two European handball fixtures, due to tighter border controls.Despite their optimism, contingency plans for the tournament have been explored. Organisers are determined to avoid cancelling matches, favouring postponement instead, but using fallow weeks raises problems over player release and extending the tournament is fraught with difficulty. That France play England on 13 March and Wales seven days later on the tournament's final weekend could be a huge problem. The French government is increasingly concerned by the UK variant of Covid-19, and prevented clubs taking part in the latest rounds of two European competitions. The French sports minister, Roxana Maracineanu, has demanded further health guarantees before giving approval for Les Bleus to play against UK



countries and while Six Nations organisers are confident their reinforced protocols - including twiceweekly testing - will allay those concerns it remains to be seen whether they are sufficient to guarantee travel exemption."We are in constant dialogue with the French government through the |French federation]," the Six Nations chief executive, Ben Morel, said. "We've provided all our protocols, which have been considered extremely robust, and we are seeking some clarification on the specific rules on quarantine exemptions. That's on entry from the UK, whether it's reentry for a French team or other unions."The one thing that needs to be clarified is precise travel exemption between the non-EU and French territory. That affects matches a bit further along in the schedule. But we are confident we will get the right authorisation to proceed. We are confident in our ability to stage the matches at the right time, it's more what logistical gymnastics we need to adapt to."Morel also confirmed the idea of hosting the tournament in one location has been briefly discussed, but never seriously entertained. Last weekend the Racing 92 owner, Jacky Lorenzetti, offered the use of La Défense Arena in Paris, but Morel believes players and staff are safer in biosecure bubbles at their training bases.He said: "We think our protocols are better suited in keeping the unions where they are in their international training bases with charter flights and controlled travel. There are some stadium sponsor commitments relevant to each of the unions, which is also a consideration, but fundamentally our protocols are robust for the Six Nations to continue."Dates for the Women's Six Nations are expected to be confirmed next week, with a slot in early spring most likely. Morel said organisers have not found a title sponsor nor a UK broadcaster for the championship, but hope to resolve both issues. He also said the Women's Six Nations may take place at a different time of year to the men's on a permanent basis, as revealed by the Guardian last April. "I'm a strong believer that the specific window would enhance and give appropriate visibility."

There's a lot going on in the world that is far worse."She also acknowledges that she is among the more fortunate group who have not been confined to a hard lockdown. In contrast, 72 players have been locked inside their rooms for a fortnight and reduced to hitting balls against mattresses or the wall after they flew in on charter flights that carried people who then tested positive for Covid. In April 2019, Boulter and Jo Konta gave so much as GB beat Kazakhstan in a playoff to clinch promotion to the elite group stages of the Fed Cup for the first time in 26 years. Boulter played two gruelling three-set matches and, after beating Zarina Diyas 6-7, 6-4, 6-1, she sealed the tie. But in the process she suffered the spinal stress fracture that would keep her out of the game the rest of the year.Boulter's rehabilitation was also made much more difficult by her chronic fatigue. It was a trial to which she had been long accustomed as she has endured this mysterious and sapping illness since her late teens. "I reached my highest ranking of 82 only practising once a day and doing zero gym,' she says. "I'm still very careful with what I do. There are certain exercises I've categorically ruled out. But in terms of chronic fatigue I now feel like I've officially conquered it. I am as strong as I have ever been physically. And mentally I feel like I'm in a great place after that very difficult time [in 2019]. It gives me a lot of faith I can get back to being No82 and then push on from there."Covid presented a new challenge because last March, while on the comeback trail in Indian Wells, she beat Anna Blinkova, who was then world No60. "I felt I was back to my best as I'd been playing some very good tennis consistently, day in, day out. I struggled when I started again and had a tough time at the Australian [where she lost in the first round, 6-, 7-5 to Elina Svitolina, the No 5 seed]. But it was all very good because I was practising with top players every single day. So I played really well going into Indian Wells
