
World Cancer Day observed at **State cancer Institute, GMCH** organised by India Tourism, an initiative by Byatikram MASDO

A year ago on Reddit I suggested investing in GameStop. But I never expected this



Just over a year ago, I published some thoughts on r/WallStreetBets (WSB), a Reddit forum that I like to check out every now and again. The post is called GameStop Investment Thesis. My idea was that the US retailer GameStop – a bricks-and-mortar shop that sells video games, consoles, Funko Pop! toys

and other miscellanea to enthusiasts, or nerds, like myself – might be worth investing in. The business, I suggested, had a substantial amount of cash on its balance sheet, which could be translated into value, and generally had a bit more promise than met the eye.I was wrong. In fact, in their classically abrasive way, one Redditor pointed this out at the time: "The only theory supporting your \$GME long is about your mother's alcohol consumption during pregnancy." The Covid-19 pandemic proved doubly that investing in a highstreet store probably wasn't a good idea. But, just as a butterfly flapping its wings in Brazil can lead to a hurricane on the other side of the world, my thoughts may well have been the catalyst for what would this week become one of, if not the, largest

history. My post has been cited in Bloomberg and the Verge as one of early signs of Reddit's interest in the store. After the post, the investor Michael Burry - who was depicted in the book and film The Big Short subsequently made it public that he was buying GameStop. The rest is history.In case you've managed to avoid the story so far: over the past several weeks, the stock price of GameStop has gone, in Reddit-speak, "to the moon", from \$19.94 a share as of market close on

Monday 11 January to a peak of \$347.51 on Thursday 27 January. A company that had made a net loss in the previous 12 months of \$275m was briefly considered, in the eyes of the stock market, to be worth \$25bn. This wasn't anything to do with the company's underlying business decisions or "fundamentals" There were no announcements of future partnerships; no decelerating preowned sales declines; no improving same-store sales – none of the news that would traditionally signal to the investment community that the company's business performance was improving and that investors should buy the stock. It was all down to, essentially, a digital movement of ordinary people – acting with what they see as a keen sense of right and wrong.Because of continued declines in GameStop's operating income and the announcement that the next generation of gaming consoles would allow consumers to purchase new games directly online, institutional investors began to short the company, making bets that GameStop would continue to underperform. Aware of the large amount of GameStop shares that were being shorted, r/WallStreetBets decided

to collectively buy shares (and options) in the company hoping that the flood of buying activity would cause the stock price to rise and, subsequently, force the big hedge funds to buy more shares to cover their positions, driving the price even higher. To the chagrin of the financial news media, the hedge fund manager Leon Cooperman and Melvin Capital, a firm whose very solvency was reportedly in question due to its large short position on GameStop, it worked. Many posts were shared on r/ WallStreetBets detailing the huge sums of money – some of them life-changing – made by members of the community. There are members who say they made enough to pay off student debt, afford an operation for a family member, and even buy a yacht, all thanks to their fresh delivery of "tendies" – WSB jargon for money (it's an allusion to tender fried chicken). Since then, GameStop's valuation has come tumbling down. To some, the events were emblematic of broader antiestablishment sentiment; the result of what was perceived to be an inadequate response to the pandemic and the inability of lawmakers to provide adequate stimulus to those in dire financial situations. WSB members saw this as an opportunity to stick it to the man. One open letter that was widely shared on the forum detailed the user's bruising experience of the 2008 financial crisis: they claimed to have put their life savings into GameStop stock and were keeping it there, not cashing out, "to make it as painful as [they] can" for the hedge funds. As for my own balance, at the time I wrote that post a year ago, I owned 1,500 shares in GameStop – but I sold them before recent events. I guess not everyone gets to go to the moon.

V-shaped recovery

Finance Minister Nirmala Sitharaman pegged total government expenditure for the current fiscal year at 34.5 trillion rupees (\$472 billion). That's \$57 billion more than what analysts had forecast based on a muted April-to-November trend, extrapolated for a bump in December through March, the final four months of the accounting period. But not only is Sitharaman spending much more liberally than expected, she wants to loosen her purse strings by another \$5 billion in the next fiscal year. The equity market is happy for four main reasons. One, there was no major new tax - or an increase in tax rates - to meet the spending goal. Two, even as total outlay goes up by \$5 billion, the capital expenditure part, which could create new orders and profit for India Inc., is projected to rise by \$15 billion. Third, the finance minister's promise of a bad bank to take away commercial lenders' soured assets is giving the market hope that clogged-up credit will start to flow more freely. The government is also setting up a new "development" financial institution to meet the needs of the infrastructure sector. Finally, the decision to allow foreign insurers to boost their stakes in local joint ventures to 74% from 49% is a welcome reform. The bond investor, meanwhile, is nursing a rude sticker-price shock. The finance minister said the current fiscal year's budget deficit would be as wide as 9.5% of gross domestic product, about 2 percentage points more than the consensus estimate. In the coming year, she wants to trim the shortfall, but not too drastically. A targeted deficit of 6.8% of GDP will require New Delhi to borrow aggressively once again, both from the bond market and from citizens' small savings pool. All eyes are on the central bank. Given that the Reserve Bank also intends to buy the dollars flooding into India's stock market to keep the rupee from rising too much, there's a limit on how many government bonds it may purchase from banks. India wants to spend its way to a V-shaped recovery and hoping that getting there would also ease the resource crunch. For instance, next year's budget assumes a 17% jump in tax revenue and a more than five-fold jump in state asset sales. With the spread of the virus contained - and inoculation expected to gather pace - these targets may not be as daunting as they appear. Even then, a lot has to go right for financing issues to not raise their head during the year, especially if the U.S. Federal Reserve decides to start tapering its asset purchases, raising borrowing costs for emerging markets. This leaves India with very little time to steady an economy that was slowing precipitously even before Covid-19. Disturbingly, India's protectionist turn - under the garb of self-reliance - continued in the budget, with import tariffs going up on auto components and mobile-phone parts. This doesn't augur well for manufacturing, especially for smaller firms whose revival holds the key to employment. After they fled lockeddown urban centers, 60 million migrant workers - equivalent to Italy's population - found a halfway house in India's rural job guarantee last June. While demand for publicly funded lowwage jobs has since ebbed to 34 million, a fifth of Indians who lost their services, manufacturing and construction jobs are still working as farmhands or are unemployed. Still, the pandemic has finally alerted India to some long-neglected priorities: Even after taking away the cost of vaccination, the \$30 billion earmarked for health and wellbeing is a doubling of the pre-Covid-19 spending level. What remains to be seen is whether this money can actually be spent. Overall, too, execution will determine the outcome of India's high-risk spending plan. It'll decide whether the bond investor turns more sanguine about financing, or the equity market turns more skeptical of V-shaped growth. Perhaps the initial reaction of both will be proved a little right, and wrong.

Indian Army had a 'Ghost Regiment'. It spooked Pakistanis in 1971 and earned their praise



ndian Army units strive for recogni tion and legacy, which come in the form of the Army Chief and Army Commander's citations. The most coveted are battle and theatre honours, awarded after campaigns. However, even rarer is earning the enemy's appreciation. Poona Horse, the regiment led by Lt Gen. Hanut Singh that fought bravely in the 1971 war, earned the honorific 'Fakhr-e-Hind' (Pride of India) from the Pakistan Army. Capt. Vikram Batra was honoured with the title of 'Sher Shah'. We are celebrating Swarnim Vijay Varsh or Golden Jubilee of the 1971 operations. It will be appropriate to recount the story of an armoured regiment that received the title of 'Ghost Regiment' from its adversaries. Pakistanis were so confused that they called it 'khalai makhlooq' (aliens or space creatures in Urdu) in sheer desperation and grudging admiration.East Pakistan (now Bangladesh), surrounded by India, lent itself to multi-pronged offensives. Hence, operations were designed on four thrust lines and spearheaded by tanks, appropriately termed as Blitzkrieg. From the west, 2 Corps

handed over to 5 IAS. The 5 IAS, in turn, created an ad-hoc, fifth squadron with armoured cars, its original equipment, giving the Indian Army yet another additional prong. It is sheer ingenuity of the regiment that it found crews for all its equipment with administrative personnel taking on combat roles. No soldier wanted to be left out of the battle, referred disparagingly as LOB. This squadron captured Akhuara and, pushed by legendary commander Lt Gen. Sagat Singh, exploited the

led by 45 LT GEN K.J. SINGH Cavalry equipped

with amphibious PT-76 light tanks weighing just 12 tonne. In comparison, recently fielded Chinese Type-15, the socalled light tanks, weigh nearly three times, 34 tonne. Pakistan referred to PT-76 tanks disparagingly as 'pipa' (Punjabi for container). This prong was strengthened with a squadron of T-55 medium tanks of 63 Cavalry, inducted just before the operations. The offensive resulted in the capture of Jessore, after a bloody battle in the town of Dograi near Lahore. Interestingly, 2 Corps (Kharga Corps) was raised only for the 1971 offensive and was to be disbanded when the war ended. But it not only carried on, it is also now the main strike punch against Pakistan.In the north, 33 Corps prong was led by 63 Cavalry with two squadrons with T-55s, having loaned one squadron to the western thrust. The Changing Canvas of the Dairy Industry with Breed Improvement

ndia's journey from a milk deficit country to one of surplus has been momentous. Initiated in 1970, Operation Flood was arguably the world's most ambitious dairy development program that transformed India into one of the largest milk producers. India's milk production rate in the past few decades has, in many ways, been symbolic of the upward trajectory of the country's economy and influence. The per capita availability of milk in 2018-19 was 394 grams per day as against the world average of 302 grams. Between 2016 to 2019, the annual milk production in the country registered a Compound Annual Growth Rate of

6.4 percent. Today, with an annualproduction of 187.75 Million Tonnes (per 2018-19 data) India accounts for about twenty two percent of the world's milk production. However, India is yet to join the ranks of major milk exporting nations, as much of what we produce is directed towards meeting domestic demands. So, to unpack the issues facing our dairy sector, it is pertinent to dive deep and list out the factors that have been hampering the productivity levels of our cows. The dairy sector assumes a great deal of significance on account of multiple reasons for one, it has to do with the socio-cultural affinity towards cows and dairy products in large parts of the country, and as an industry, it employs more than 70 million farmers. However, the crying need of the hour is for us to identify ways in which we can enhance the return on investment for our farmers. Recent data indicates that indigenous cows produce 3.01 kgsof milk per cow per day while the yield of exotic crossbred cows is 7.95 kgs. This implies that, overall, the average productivity output of indigenous cattle (both nondescript and high yielding indigenous breeds) is only 1099 kg per animal per year, while for cross-bred cattle average productivity is 3073 kg per animal per year. So, the magic word is 'cross breeding'. Crossbreeding has taken off in a big way because of the advancements in reproductive technologies like In Vitro Fertilization (IVF), embryo transfer process, and artificial insemination. Out of these processes,

IVF and artificial insemination have proven to be the most popular and effective methods. The NAIP (Nationwide Artificial Insemination Programme) Phase-I was launched by the Hon'ble Prime Minister, NarendraModi - in Mathura on the 11th of September in 2019. Every animal in the programmewas assigned a 12-digit unique identification number under the PashuAadhar scheme to ensure accuracy in tracking - the animal is monitored continuously from the period of artificial insemination till the birth of the calf. Building upon the first phase of the programme, NAIP Phase-II was initiated on the 1st of August 2020with an allocation of Shri Atul Chaturvedi Rs. 1090 crores in 604 districts covering 50,000

animals per district and is on track to be completed by the 31st of May 2021. Under the programme, 9.06 crore artificial inseminations will be performed in 604 districts and is expected to lead to the birth of 1.5 crore high yielding female calves. Consequently, 18 Million Metric Tonnesof additional milk will be produced, as average productivity will be enhanced from 1861 kg per animal per year to 3000 kg per animal per year. Until now, Artificial Insemination (AI) technology has been the most used method in India, but its success hinges upon accuracy in heat detection and timely insemination. And this is where In Vitro Fertilization (IVF) technology will prove to be more effective. IVF has become a helpful tool in crossbreeding as under this technology semen from different bulls can be used to fertilize each oocyte from a collection, that in turn enables greater genetic diversity from a single cow. Projects for the establishment of 30 IVF labs have already been sanctioned, and 15 labs have been made functional thus far. In the past six years, the Animal Husbandry and Dairying sector has received a great deal of impetus under the Hon'ble Prime Minister's vision of 'Make in India' and towards becoming an 'Atmanirbhar(selfreliant) Bharat'. In keeping with our ethos of 'Jai Kisan, Jai Vigyan' the marriage of rural farming with the latest innovations in technology will usher in unprecedented transformations in our dairy industry.

Minister Nirmala Sitharaman's Union Budget 2021One of the criticisms of past Budgets, is not only that outlays for agriculture have remained conservative but, more importantly, the expenditure has gone to unproductive avenues-interests and subsidies rather than capital investment. Under Pillar 3 which covered 'Inclusive Development for Aspirational India', a host of measures and enhanced government expenditure announced include increasing agricultural credit to farmers; enhanced allocation to Rural Infrastructure Development Fund and doubling the Micro Irrigation Fund.Further, the scope of 'Operation Green Scheme', presently applicable to tomatoes, onions, and potatoes, has been enlarged to include 22 perishable products. The customs duty on cotton has been raised from nil to 10% and on raw silk and silk yarn from 10% to 15%. Also, a new 'agriculture infrastructure & development cess' on certain items, earmarked cess for improving agricultural infrastructure, has been announced. Being sensitive in nature, the agricultural reforms shall hopefully provide some relief

to the famers' current concerns. On health and well-being, the FM rightly recognised that there is room for public investment to establish a firstrate primary health care system. There is a stupendous outlay of `2,23,846 crores, a historic increase of 137%. Such expenses shall cover already initiatives-Swachh Bharat Abhiyan, National Digital Health, Ayushman Bharat and Mission COVID Suraksha. The adverse situation of migrants and the unorganised sectors caused by the pandemic will be addressed by nationwide implementation of One Nation One Ration Card. Moreover, a portal is being launched that will collect relevant information on gig, building, and construction workers, among others. Measures towards upgrading infrastructure and technology for efficiency and lowering financial losses has come as a relief to power discoms that have been suffering from revenue loss due to theft, poor transmission infrastructure. etc. The need for promoting competition to enable a greater choice to consumers to eliminate the monopoly of discoms is on the horizon.

"Besides, in 52% of the company-owned gardens, there are no medical officers. the CAA."According to the Manual of Parliamentary Procedures, the ministry concerned has to frame rules within six months of the passage of an Act, for its "effective implementation". In case the ministry is unable to make those rules, it needs to seek an extension from the Committees on Subordinate Legislation, but cannot be given more than three months at a time. So far, the MHA has already taken two extensions - the one till July 2021 is the third, The Print has learnt. The Matua community of Hindu migrants from the erstwhile East Pakistan has been upset over the delay in implementation of the CAA in West Bengal. The community has been vocal about its demand for Indian citizenship, and the BJP has backed it, even getting an MP from the community - Santanu Thakur - elected in 2019.On 30 January, when Home Minister Amit Shah had to cancel his visit to Matua stronghold Thakurnagar in the North 24 Parganas district, senior BJP leaders Kailash Vijayvargiya and Mukul Roy rushed to meet prominent members of the community to assure them that Shah would soon conduct another meeting. The significance of the Matuas can be gauged by the fact that they make up close to 2 crore or 20 per cent of West Bengal's entire population. The community is spread out over five districts - North 24 Parganas, Nadia, Howrah, and North and South Dinajpur - and constitutes about 40-50 per cent of the population."The Matua community had played a significant role in BJP's success in the 2019 Lok Sabha elections. Their votes had helped the BJP get a number of seats, especially in Cooch Behar, North Malda, Burdwan-Durgapur, and other regions. They have been demanding the implementation of CAA for quite some time, and the delay is only leading to more discontent," said a senior BJP leader. However, in Assam, where the BJP has been in power for nearly five years now, indigenous communities have historically opposed immigrants from East Pakistan/Bangladesh regardless of whether they are Hindus or Muslims. Prime Minister Narendra Modi's visit to Assam on 23 January was significant in this regard - while distributing land allotment certificates to people at Jerenga Pathar in Sivasagar district, he had repeatedly mentioned the indigenous Assamese communities, but did not make any mention of the CAA. The opposition in Assam has already made CAA a poll pitch, alleging that the BJP is trying to destroy Assamese culture and identity through it. In what may indicate further wait for operationalisation of the Citizenship Amendment Act (CAA), the home ministry on Tuesday informed the Lok Sabha that the committees on subordinate legislation for Lok Sabha and Rajya Sabha have granted extended time until April 9, 2021 and July 9, 2021 respectively to frame the rules under CAA. As per norms, rules to be made under a statute should be made as soon as possible and no later than six months from the date on which the statute comes into force. If it is not possible for the ministry to adhere to this timeline, it should state the reasons and seek an extension from the committee on subordinate legislation.

Los Angeles, February 04: Los Angeles Angels pitching coach Mickey Callaway, who is also a former manager of the New York Mets, "aggressively pursued" several women who work in sports media and sent three of them inappropriate photos, The Athletic reported on Monday night.Callaway sent uninvited and sometimes unanswered messages to the women via email, text or social media and asked one to send nude photos in return, according to the report. He often commented on their appearance in a way that made them uncomfortable and on one occasion "thrust his crotch near the face of a reporter" while she interviewed him, The Athletic said. Another time, he told one of the women he would share information about the Mets if she got drunk with him, the report said. More than one woman received a shirtless selfie from him, and one said he massaged her shoulders in the dugout when he thought nobody was watching, according to the report. Five women spoke to The Athletic on condition of anonymity and they indicated Callaway's actions spanned at least five years and three teams, the outlet reported. Two of the women said they had been warned about Callaway's behavior by fellow media members and others in baseball, The Athletic said. Callaway was the Cleveland Indians' pitching coach for five years before managing the Mets from 2018-19. After he was fired by New York, he spent last season with the Angels as pitching coach."Rather than rush to respond to these general allegations of which I have just been made aware, I look forward to an opportunity to provide more specific responses," the 45-year-old Callaway wrote to The Athletic in an email. "Any relationship in which I was engaged has been consensual, and my conduct was in no way intended to be disrespectful to any women involved. I am married and my wife has been made aware of these general allegations."The report came two weeks after ESPN detailed sexually explicit, uninvited text messages and images sent by former Mets general manager Jared Porter to a female reporter in 2016 when he was working for the Chicago Cubs in their front office. There's a lot of Satya in Rahane, and a bit of Satya in the Indian dressing room too. The uncanny mirroring of the two casts of characters is less of happenstance and more of life imitating art.Look for that trendsetting 90s hit on YouTube first and follow it up by revisiting the Gabba chase to marvel at the real-reel similarity. The frame of Ajinkya Rahane sit-

fall in love too. But Satya, while dealing with fear, anxiety and joy, would never break the good old mafia motto made popular by the Corleones - Never let anyone know what you're thinking. CA move to not tour **South** Africa represents serious financial loss: CSA

South Africa (CSA) on Tuesday slammed its Australian counterpart for postponing a Test tour of the country citing the COVID-19 pandemic, saying it is "extremely" disappointing and will lead to "serious financial loss". Australia postponed the tour next month owing to "unacceptable health and safety risk" in that country because of a fresh COVID-19 outbreak, a decision that virtually knocks them out of contention from the World Test Championship final later this year."We are extremely disappointed by the decision of CA," CSA's director of cricket,

Graeme Smith, stated in a press release. "CSA has been working tirelessly in recent weeks to ensure that we meet every single expectation of CAANNOUNCEMENT: Cricket South Africa was informed by Cricket Australia that their scheduled tour to SA will not be going ahead due to Covid-19 fears.

"This was set to be the longest tour in a BSE (bio-safety cabinet or biological safety cabinet) comprising a three-match Test series that was scheduled to begin with Australia's arrival later in the month. So to be informed about the CA decision at the eleventh hour is frustrating. "The Australian team was scheduled to play a three-Test series during the tour. However, with the host nation battling a second wave of COVID-19 and a new variant of the virus, Cricket Australia's (CA) interim chief executive Nick Hockley said travelling to South Africa is not possible given the current scenario. The move did not go down well with the South African cricket board.Pholetsi Moseki, CSA's acting chief executive officer said, "It is indeed sad that after all the engagements and effort made to ensure a secure visit by our Australian counterparts, the tour has been derailed."CSA has incurred significant costs related to the planning stages and the cancellation of the tour represents a serious financial loss."In this challenging period for cricket and its member countries, we believe the stance taken by

14 days prior to the arrival of the Australian team, thus altering their planning during the current tour of Pakistan," Manjra said."Amongst some of the other key arrangements made were that all four areas (two hotels and two venues) had a protocol to implement a strict BSE with no contact with anybody outside this area."We subsequently agreed to two separate BSEs and had granted Australia full and exclusive use of the Irene Country Lodge, which we shared with Sri Lanka, with a minimum staff present on site. "This is the second series to be postponed in South Africa due to COVID-19. Last year, England had pulled out of their tour midway through an ODI series after there was an outbreak of cases in the team hotel. Manjra added, "In terms of the arrangements, the Proteas were to move to a separate hotel altogether. Furthermore, all hotel staff, match officials and even bus drivers were to enter the BSE 14 days prior to Australia's arrival."In addition, CSA had also committed to importing an Australian tracking system at great cost to ensure proper tracking of close contacts in the event of a positive test.

Ashok Dinda announces retirement from all forms of cricket

New Delhi, February 4: Ashok Dinda, one of the most consistent quick bowlers in Indian domestic cricket for the past one-and-a-half decade, brought down curtains on his career on Tuesday. Dinda, who has 420 firstclass wickets in his bag, has also played 13 ODIs and nine T20s for India, taking 12 and 17 wickets respectively. He has also played in the Indian Premier League, turning out for teams like Kolkata Knight Riders and Pune Warriors."Today, I am retiring from all formats of cricket. I have sent the mails to BCCI and GCA to this effect," Dinda said during a media interaction at Eden Gardens. Dinda thanked BCCI president and former India captain Sourav Ganguly for going out of his way and giving him a debut against Maharashtra at Pune in the 2005-06 season."There have been several people who have helped me throughout my career whom I would like to thank beginning with my parents. Then it's Dada. It was because of him that I got to play for Bengal. I was not in the squad but he included me as a 16th member and handed me a debut," Dinda remembered.Calling himself a victim of politics, Dinda had announced last year that he will not play for Bengal, who had ended runnersup in the 2019-2020 season. It had been reported that he would be turning out for Goa for the following Ranji



season. This was after Dinda was dropped by Bengal after a fall-out with bowling coach Ranadeb Bose. The 36year-old was accused of publicly abusing Bose and of creating a rift within the team. He was presented with a silver plaque and a bouquet and was thanked for his contribution by Cricket Association of Bengal (CAB) president Avishek Dalmiya, secretary Snehashis Ganguly and joint secretary Debabrata Das."The contribution of Dinda is enormous. He is one of the best fast bowlers we have produced. He will be remembered for his ability to take wickets and win matches, bowl long spells and his never-say-die spirit," Dalmiya said.
