Sputnik V vaccine

New Delhi, May 14: Drug firm Dr. Reddy's Laboratories on Friday said as part of a limited pilot, the soft launch of the COVID vaccine Sputnik V has commenced and the first dose of the vaccine was administered in Hyderabad. The imported doses of the vaccine will cost Rs 995.40 per shot, said the company's partner in India Dr. Reddy's Laboratories on Friday. The price includes a GST of 5% on every dose. However, the doses of the vaccine that will be made in India are expected to be cheaper."Further consignments of imported doses are expected over the upcoming months. Subsequently, supply of the Sputnik V vaccine will commence from Indian

Guwahati, May 14: District authorities in Assam have been instructed by the State Government to paste posters outside the residences of COVID-19 positive patients. The step has been taken by the Assam Government to "protect the community at large from further spread of the COVID-19 virus". "...there have been reports that some COVID positive persons do not observe COVID appropriate behaviour and

It, however, stated that pasting of posters outside the residences of COVID-19 positive persons "will be done only if such a residence is used by the COVID-19 positive person for self-isolation or quarantine purpose and such posters shall be removed as soon as such person/persons turn COVID-19 negative". 

CM Himanta Biswa Sarma hints lockdown at specific places if needed Guwahati, May 14: At a time when many in Assam are speculating a possible

Tauktae likely to be a very severe cyclonic storm: IMD

formed, is likely to intensify into a 'very severe cyclonic storm' with wind speed of 150 to 160 kmph gusting to 175 kmph on May 17, according to the latest forecast by the India Meteorological Department (IMD). The depression over Lakshadweep area has moved north-north-eastwards with a speed of about 19 kmph and is now centred over Lakshadweep about 30 km south southwest of Amini Divi, 320 km west-southwest of Kannur (Kerala), 1120 km south southeast of Veraval (Gujarat) at about 11.30 am on May 14. It is very likely to intensify into a cyclonic storm during the next 24 hours and

New Delhi, May 14: Tauktae, once is also expected to intensify further during the subsequent 24 hours. Tauktae is likely to move north north-eastwards initially for some more time and then move north-north westwards and reach the Gujarat coast by May 18 morning. There is no consensus among models yet on whether the very severe cyclonic storm will cross the Gujarat coast. "As on today we cannot say very clearly if it will cross the Gujarat coast. But the probability of crossing the coast cannot be ruled out. It may skirt the coast early on May 18. He was a young social worker of the greater Bhimajuli area, to the north of Biswanath. His untimely death was widely mourned.

Containment Zone Declared

Any type of entry or exit and movement of individual as well as vehicular movement are strictly prohibited in the declared Containment Zones. It is to be mentioned that in Golaghat total number of Active Containment Zones rises to six.

So far, Indian Railways has delivered nearly 7900 MT of LMO in nearly 500 tankers to various states across the country. It may be noted that Oxygen Expresses started their deliveries 20 days back on 24th April 2021 in Maharashtra with a load of 126 MT of LMO. fell by almost half in the two years after the Chinese government implemented policies to reduce the number of babies born to Uyghur and other Muslim minority families, new research has claimed. The figures show unprecedented declines which were more extreme than any global region at any time in the 71 years of UN fertility data collection, including during genocides in Rwanda and Cambodia, according to the authors of the report by the Australian Strategic Policy Institute (Aspi). The data adds to mounting evidence of coercive fertility policies in Xinjiang, including firstperson accounts of forced sterilisation or birth control, and leaked policing data family planning regulations. They are among Chinese government policies believed to be designed to forcibly assimilate the Uyghur and other Muslim populations. In April, Human Rights Watch determined the Chinese government was committing crimes against humanity but said the extent of coercive birth control and sexual violence, while alarming, needed more investigation. The authors of the report, Nathan Ruser and James Leibold, said they compiled it using publicly available Chinese government statistics to create datasets of county-level birthrates from 2011 to 2019, and comparing counties with higher proportions of Uyghur and other Muslim minorities. It covered the period before, during, and after the implementation of the Chinese Communist party's campaigns against "illegal births" in April 2017, when authorities also stopped publishing statistics on the birthrates of separate minority groups. Aspi's report found the birthrate across Xinjiang fell by 48.74% between 2017 and 2019. In counties where the population was at least 90% non-Han Chinese, the birthrate dropped by an average 56.5% between 2017 and 2018. By examining county-level statistics, the report provided further evidence of "the systematic targeting" of communities, it said."Previous research by both Chinese and foreign experts has examined the tightening of birth control policy in Xinjiang and a corresponding drop in natural population growth beginning in 2015, but even more dramatically after 2017," it said. Among the evidence cited in the report, Aspi also included state media reports about crackdowns on "illegal births", and the collection of US\$1m from 629 families over four months in a single county. In other areas authorities launched hotlines and rewarded people who informed on their neighbours, and punished officials who failed to meet targets."The crackdown has led to an unprecedented and precipitous drop in official birthrates in Xinjiang since 2017. The birthrate across the region fell by nearly half (48.74 %) in the two years

between 2017 and 2019," said the

Citing state media, the report said in 2017, 460 party members and state employees were punished for illegal births in Hotan prefecture, where 97% of the population is Uyghur or from other non-Han groups. 'You might die because you desire peace': Colombians split on protests

London, May 14: Nearly two weeks after mass anti-government protests kicked off in Colombia at the end of April, President Ivan Duque has promised a national dialogue over issues raised by young demonstrators, including free university tuition."We know we must take urgent steps to generate hope and a future for our vouth." Duque said during a brief visit to Cali, a city of over 2 million that has beeen the setting for violent clashes. But the government has dismissed out of hand some of the protesters' demands, such as a basic income, and ignored broad calls for police reform. At least 47 people have died, according to local watchdogs Temblores and Indepaz, and local and international human rights organisations have blamed police for the killings. Dozens of disciplinary investigations have been launched, and three officers have been charged with murder.But the protests - mostly peaceful, some riotous and destructive - have divided the Colombian population. "Unfortunately, in my city this has not been a peaceful protest," Juan, 40, a hospital doctor in Cali, said."We are in the middle of the third Covid peak in Cali. For the last three to four weeks, we've had 85-95% occupancy in ICUs. My work at the hospital has been hugely affected by the blockades erected across and around the city." My hospital was forced to cancel ambulatory consultations and surgeries, until further notice. We are only seeing emergencies and are operating at perhaps 10% capacity."Juan is one of hundreds of people who responded to a



reader callout asking about the situation in Colombia. Carolina, 26, a paediatrician in Bogotá, where demonstrators and police have also clashed, is still on the side of the protesters. As the main breadwinner in her family, she feels it's too risky to participate in marches herself, but tries to do her bit by sharing information on social media to counter what she considers an avalanche of fake news in favour of the government."It's hard for me to go to the streets. My parents are worried I'm not going to come back, but it frustrates me so much to see so many videos of my people facing the police and being hurt," she says. "Our president ignores the complaints of the people and sends the military and police to kill us."Carolina also feels abandoned by wealthier citizens who oppose the uprising, and others from the political ruling class. "It's pretty depressing to be afraid of dying and knowing you can not call the police, because they are the ones shooting."She concedes that some protesters have damaged property and erected blockades, but blames a small minority. "Most protesters are peaceful," she says. "We listen to the helicopters at night, and the tanks driving through our neighborhoods. No matter what you do, you are a criminal in the eyes of the authorities, and you might die just because you desire peace, a better country and a non-corrupt government. We need international help."Carolina says Covid infections and deaths increased in Bogotá since the protests began. "This is the third peak in our country, and maybe the worst one so far. But believe me when I say people think the government is more dangerous than Covid. As a paediatrician, I'm tired of seeing children sick with hunger."Carolina's views mirror those of scores of university students and young people from Cali, Bogotá, Medellín, Manizales, Barranquilla and elsewhere in the country who wrote in via the callout to express their support for the protests, and their despair over police crackdowns. Decrying poor living conditions, censorship, social media blockades by the government and police brutality, various teenagers, students and young professionals commented on the scenes of violence and disorder from their homes, too scared to leave. Fabian, 25, a chemical engineer from Bogotá, fears police are trying to set up demonstrators. "The police constantly provoke clashes with protesters, but we also suspect that plain-clothed police are engaging in criminal activities to discredit the protests and justify the violence against people," he said. But this narrative is not persuading everyone, with many people believing the social unrest has gone too far.

US Target stores to stop selling Poke?mon cards after rising value prompts threats to staff

Washington, May 14: The dramatic rise in the re-sale value of the cards prompted a fight in Wisconsin during which a man pulled a gunUS retail giant Target will stop selling Poke?mon playing cards out of an "abundance of caution" for its staff and other shoppers. The re-sale value of the cards has increased dramatically during the coronavirus pandemic, prompting chaos and threats to staff. Target will also stop selling MLB, NFL and NBA sports playing cards. The decision comes after man pulled a gun during a fight over trading cards in a Target parking lot in Brookfield, Wisconsin on 7 May. Police said the 35-year-old man produced the gun when he was assaulted by four men aged 23-35 as he left the store, ABC reported. A shopper who was at the Target during the parking lot incident told Fox news at the time: "It's just kind of sad

for the kids. It just sounds kind of ridiculous that adults got into a fight in the parking lot about trading cards.""The safety of our guests and our team is our top priority," it said. "Out of an abundance of caution, we've decided to temporarily suspend the sale of MLB, NFL, NBA and Pokémon trading cards within our stores, effective May 14. Guests can continue to shop these cards online at Target.com."Joe Maddalena, executive vice-president at Texas-based Heritage Auctions, explained the skyrocketing resale value of the cards, telling Reuters: "When Covid-19 hit, a lot of Gen X and Millennials were looking for things to do and we found a lot of these guys and girls started playing Pokémon again because they grew up with it."Maddalena said boxes of the 1999 US first edition base set had sold for about

\$400,000 at auction in recent months. A single card in mint condition for the popular fire-flying character Charizard sold for \$300,000 in January, whereas in late 2019 asking prices for a Charizard card were about \$16,000, he said. Earlier this year, Target limited the number of packs per person to three and then one. The store had to stop people camping outside overnight when trading cards were restocked, The Verge reported. Earlier this year in Japan, a man broke into a trading card shop at dawn by climbing down a rope he tied to the roof of the six-storey building. He then stole 80 Poke?mon and Yugioh! cards worth more than US\$9,000, Mainichi reported. "I was in my high school's rock climbing club, so I wasn't afraid of heights," the man, who was later arrested, told police.

Gaza Crisis: where is the solution?

Violent confrontations between Palestinian citizens of Israel and Jewish Israelis have resumed in several cities inside Israel as the Israeli military continued air raids on the besieged Gaza Strip and Hamas fired rockets into Israel for a third day on Wednesday. The crisis, which started with Israeli efforts to displace Palestinian families in occupied East Jerusalem, has sparked intra-communal tensions within Israel, with some Palestinian citizens staging protests in recent days. Footage of the attack, which was aired live on television, showed a man being forcibly removed from his car and beaten by a crowd of dozens. Al Jazeera "looked like an attempted public lynching". Video footage on local media also showed dozens of people with black masks ransacking Palestinian stores, with reports saying the Jewish ultra-nationalist attackers had responded to a call issued on social networks by a group known as La Familia. Elsewhere, a video uploaded to social media appeared to show a crowd of flag-waving Israelis attacking a car in the northern city of Tiberias. Israel's Channel 13 also quoted a senior police officer as saying Palestinian citizens of Israel were suspected of attacking and seriously wounding a Jewish man in Acre, also in the country's north. Meanwhile, after a synagogue was torched in Lod, a city some 15km (9.3 miles) from Tel Aviv, Israeli authorities deployed border police and announced a curfew."We must not be dragged into provocations and inflicting harm on people or property," Chief Rabbi Yitzhak Yosef said in a rare public appeal. "The Torah of Israel grants no licence for taking the law into one's hands and acting violently." Palestinian citizens of Israel say the violence of the past two days was not directed at Jews, but rather at religious nationalists with close ties to the Jewish settlement movemnt who have moved into mixed areas in recent years, pushing Palestinian residents out."All across the country, we've seen these similar images of Jews and Arabs facing off in the streets." Al Jazeera's Fawcett said about the recent confrontations. "This is a parallel and extremely concerning development for the [Israeli] government, even as it continues to conduct this extensive and accelerating military operation in and around Gaza," he reported. Tensions have soared in recent weeks in anticipation of a court ruling on planned forced expulsions of several Palestinian families from their homes in the occupied East Jerusalem neighbourhood of Sheikh Jarrah. The ruling has been postponed. The situation escalated when Israeli forces raided Al-Aqsa Mosque compound for three straight days during the final week of the holy month of Ramadan. Hundreds of Palestinians were wounded as Israeli forces fired rubber-coated steel bullets, stun grenades and tear gas at Palestinian worshippers. Violence escalated on Monday after Hamas issued an ultimatum demanding Israel stand down its security forces from the compound. Shortly after the deadline, the Palestinian group, which rules Gaza, fired several rockets towards Jerusalem and later, Israel launched air attacks on the territory. Since then, at least 67 Palestinians have been killed in the Gaza Strip, according to the ministry of health. Israeli medics have said at least six people have been killed by rocket fire from Gaza. After police broke up a protest on Monday night in Lod, a young Palestinian resident was shot and killed by a Jewish-Israeli resident. Violence later broke out a day later at the man's funeral – and spread to other communities inside Israel, including Ramle. Meanwhile, Israeli Prime Minister Benjamin Netanyahu this week visited Lod and Acre, where he pledged to "stop the anarchy" and restore order "with an iron fist if needed". Netanyahu on Tuesday evening authorised the deployment of hundreds of police to Lod and other areas, including paramilitary border police who usually operate in the occupied West Bank. Palestinian citizens of Israel make up about 20 percent of the country's population. While they hold citizenship and have the right to vote, they face widespread discrimination and limited civil, political and socio-economic rights. Many Palestinian communities inside Israel also are under-funded and marginalised. Ghassan Munayyer, a Lodbased activist, said the veneer of coexistence conceals deeper disparities, including in housing and infrastructure. He compared the city's Palestinian neighbourhoods to "refugee camps". "The Jews love saying there's co-existence. They go out to eat in an Arab restaurant and they call it coexistence," he said. "But they don't see Arabs as equal human beings who have rights that they have to respect." Israel and Hamas are locked again in combat likely to yield – beyond tragic life and property loss – a return to a destructive status quo. The immediate triggers were the kidnapping and murder of three Israeli yeshiva students, for which Israel holds Hamas responsible, and the revenge torture and murder of a Palestinian teen by vigilante Israeli Jews. The nature and extent of Hamas's involvement in the initial obscenity remains unclear, but the attack's consequences are anything but. Since Israel launched Operation Protective Edge on 8 July, 168 Palestinians have been killed (80 per cent civilians, a fifth of whom were children) and about 1,150 wounded. Some 1,000 rockets have been launched toward Israel, of which about 200 were intercepted by the Iron Dome defence system. Previous rounds ended with each side claiming at best a Pyrrhic victory, because Israel can achieve lasting stability only when Gaza does, and vice versa. Breaking this pattern is even more urgent today, because the stakes of this escalation could be higher. The reconciliation agreement of 23 April 2014, signed by Hamas and the Palestine Liberation Organisation (PLO), led principally by Fatah, offers both a further challenge and an opportunity. The situation in Gaza has deteriorated markedly since then. The new PA government formed on 2 June was supposed to take over governance in Gaza but has not. The Strip runs on administrative inertia, since the new ministers have not assumed their responsibilities. An estimated 43,000 employees, hired since Hamas took over Gaza in 2007 and who still largely run the Strip, have not received their salaries in months; in frustration, they have prevented some of the other 70,000 employees – who were not hired by Hamas and in most cases had been paid by the Fatah-dominated Palestinian Authority (PA) on the West Bank to stay home during those years in order to weaken the Hamas government – from obtaining theirs. Electricity, fuel and medical supplies have grown scarcer. Now that conflict has erupted, the flux in the Palestinian political system introduces a new variable into efforts to achieve calm. But the reconciliation agreement might also hold the key to squaring the ceasefire circle. Though opposed by Israel, the deal, if implemented, offers the best chance of alleviating Gaza's misery and lessening Hamas's incentives to fight. The Islamist movement long resisted admitting any PA presence, but now that it has renounced governance, a door has been opened, and with it, an opportunity to redesign the peace process and advance the well-being of Gaza's 1.7 million residents.

How to spot the difference between a real climate policy and greenwashing guff



o it's goodbye climate deniers, hello and you'll pardon me for being blunt here - climate bullshitters. The impacts of the climate emergency are now so obvious, only the truly deluded still deny them. Instead, we are at the point where everyone agrees something must be done, but many are making only vague, distant promises of ineffective action. As a result, we are currently on track for a 0.5% cut in global emissions from 2010 levels by 2030, when a 45% drop is needed to avoid climate catastrophe.So how to spot this greenwash? A good rule of thumb is whether the proposal actually cuts emissions, by a significant amount, and soon, and whether the proposer is in fact making the climate emergency worse elsewhere.Let's start at the top, with the world's governments, which have been setting out more targets than an archery competition. The global leader is the UK, which recently pledged a world-beating emissions cut of 78% by 2035. Targets are a necessary first step, but need action to be met and the instant, universal response: "Show me the policies!"The problem is some actual UK policies are pushing emissions up, not down: massive road building, a scrapped home energy efficiency programme and slashed electric car incentives, new oil and gas exploration, a failure to halt airport expansions and block a new coalmine (instead, the government belatedly ordered a public inquiry). But it is not just Boris Johnson's government that says one thing while doing another. All are talking tough on climate, but China is building one large coal-fired power station a week, Japan remains one of the biggest financiers of overseas coal plants and Norway is developing giant new oil and gas fields. without giving up fossil fuels. Pierre- business. Offsets sound good in theory, sis like the emergency it is.

Canada's premier **Damian Carrington** new gas power plant in the UK Justin Trudeau says climate change is an "existential threat", yet the country's emissions have actually increased since the 2015 Paris deal, thanks to its tar sands exploitation. Oh, and many nations still subsidise fossil fuels, which is like buying more cigarettes when you're trying to quit smoking. The world's forests are suffering because of the same doublespeak. Indonesia, the Democratic Republic of the Congo, Peru and Colombia all pledged in 2014 to end deforestation by 2030. Companies are, if anything, even better bullshitters than governments, and the fossil fuel giants are masters. Many are still exploring for new reserves, when we already have more than can ever be safely burned. Chevron touts capturing CO2 emissions and storing them underground as a solution - one that of course enables the continued burning of its products. But its plans for carbon capture and storage cover less than 1% of its 2019 carbon emissions. ExxonMobil wants public money to help with its carbon capture project to store 50m tonnes of CO2 by 2030. That's just 8% of the 2020 emissions its products resulted in. Another technological fix promoted is hydrogen, in theory a clean fuel when generated using renewable energy. But its most enthusiastic backers are incumbent fossil fuel companies. Members of the global Hydrogen Council include Saudi Aramco, BP and Total, while the UK parliament's hydro-

1998 Gujarat cyclone also formed in early June. So, while cyclone formation in May in the Arabian Sea is rare, it often happens when monsoon sets in," added Sunitha. According to "Assessment of Climate Change over the Indian Region," a report released by the Union ministry of earth sciences last year, observations indicate that frequency of extremely severe cyclonic storms (ESCS) over the Arabian Sea has increased during the post-monsoon seasons of 1998–2018. Most models are projecting a higher sea surface warming in the Arabian Sea than the Bay of Bengal. "The frequency and intensity of cyclones in the Arabian Sea have increased in recent years. This is because of the rapid warming that has made the relatively cooler Arabian Sea (compared to the Bay of Bengal) a warm pool region that can actively support cyclone formation. Climate projections indicate that Arabian Sea will continue warming under increased carbon emissions, resulting in more intense cyclones in the future," explained Roxy Mathew Koll, a climate scientist at the Indian Institute of Tropical Meteorology. "Ocean warming has made some new challenges also. Cyclones are now intensifying rapidly since warm ocean waters act as fuel for them. Extremely severe cyclones like Fani and Amphan intensified from a weak to severe status in less than 24 hours due to warm ocean conditions. That gives us less time to be prepared. State-of-the-art cyclone models are unable to pick this rapid intensification because they do not incorporate the ocean dynamics accurately," he added. Light to moderate rain with extremely heavy rain (over 20 cm) is likely over Lakshadweep on May 13 and 14; over Kerala on May 13; over ghat areas of Tamil Nadu and Karnataka on May 15. It is likely to rain on May 13, 14, 15, 16 and 17 in all these places, the IMD said. In Konkan and Goa, light to moderate rainfall at many places with heavy rainfall at isolated places is very likely on May 15 and heavy to very heavy rainfall at a few places on May 16 and 17. In Gujarat, rainfall activity is very likely to begin from May 17 with a significant increase during the subsequent 2 days and heavy to very heavy rainfall at a few places over Saurashtra and Kutch on May 18 and 19. The major impact from the cyclone is expected over southeast, east-central and northeast Arabian Sea, Lakshadweep – Maldives area and Lakshadweep Islands and along and off Kerala, Karnataka, Goa, Maharashtra, Gujarat coasts. In these areas, very rough to high seas, squally weather and gales around the system centre will affect shipping vessels and fishing operations; inundation of low lying areas of the islands of Lakshadweep during May 14 to 16; very heavy to extremely heavy rainfall causing flash floods and landslides over the coastal districts of Kerala, Karnataka and Goa during May 14 to 16 and Saurashtra, Kutch during May 18:Thunder squalls and lightning could cause adverse impact on human settlements and livestock as well as damage to loose and unsecured structures along the coast line. Fishermen have been advised not to venture into the Arabian Sea during May 14 to 18. Ships too have been advised to avoid the area; ports along the west coast of India may take necessary precautions; naval base operations may maintain necessary precautions; tourism activities may be restricted over the area specified for squally weather and rough sea warning. Conditions are extremely favourable for the rapid intensification of Tauktae. Delhi will need more oxygen, AAP govt tells SC why requirement shot up 38% to 976 MT a day

New Delhi, May 14: Delhi's oxygen requirement, to treat moderate and severe cases of Covid-19 infections, is likely to increase by 269 metric tonnes (MT) in the coming days as it is looking to add more oxygenated non-ICU and ICU beds to its kitty, the Aam Aadmi Party (AAP) government has told the Supreme Court in an affidavit. The affidavit, accessed by ThePrint, states that Delhi is preparing to enhance the number of non-ICU beds with oxygen by 15,000 and ICU beds by 1,200 and, as a result, on the basis of the formula devised by the Centre, the national capital's requirement for oxygen will increase from 707 MT to 976 MT, a 38 per cent increase. The affidavit further states that to cater to the eventuality that may arise during the third wave, the Delhi government has also chalked out a strategy to increase the storage capacity for oxygen. According to the affidavit, the city has so far not been able to store oxygen because the demand has exceeded allocation and the quantity received has been distributed on the same or the next day. On 8 May, a Supreme Court bench of Justices D.Y. Chandrachud and M.R. Shah had reiterated the apex court's 5 May direction to the Modi government to supply 700 MT oxygen to Delhi. The affidavit, however, states that pursuant to the 5 May order, Delhi received 730 MT oxygen only once, on 6 May. The Supreme Court, which is hearing a suo motu cognisance matter on lack of essentials such as drugs, vaccines and oxygen during the pandemic, is likely to take up the Delhi government's affidavit Thursday. The court has already formed a National Task Force to devise a new formula for equitable distribution of oxygen to states. Until the new formula is approved, oxygen allocation will continue on the basis of the formula worked out by the central government. On its part, the Modi government has labelled Delhi's demand for oxygen as an overestimation. Opposing Delhi's plea to ensure 700 MT oxygen is supplied to it every day, the central government had on 5 May maintained that the capital's optimal oxygen demand should be in the range of 415.43 MT.According to a Delhi government note, which was cited during the arguments in the suo motu matter in the apex court last week, the national capital needed 707 MT oxygen as on 3 May to cater to the needs of the existing infrastructure. This included 304 MT oxygen for 16,272 non-ICU oxygenated beds and 218 MT for 4,866 ICU beds. The note said that for all small hospitals having less than 50 beds, the Delhi government had allotted 120 MT oxygen for cylinder refilling. It has also earmarked 28 MT oxygen for the additional 1,500 beds set up at the Radha Soami Satsang Beas, the Commonwealth Games Village and the Yamuna Sports Complex. The note further said that since 3 May, the Delhi government has added 8,000 non-ICU oxygenated beds, and is likely to add 1,200 more ICU beds – 500 each at the DRDO and Lok Nayak Hospitals and 200 at the Radha Soami Satsang. The affidavit also states that it is looking to add more beds, including 1,800 non-ICU oxygenated beds that will be set up at the district level. For now, the affidavit said, the government has commenced operations in a hospital it has built in Dwarka. But due to limited allocation of oxygen, only 250 beds are active. The Delhi government has requested the Centre to earmark more Covid-19 beds in its state-run hospitals and increase it from the current capacity of 3,409, the affidavit added. However, without adequate supply of oxygen, it submitted, the number of beds for treating Covid-19 patients cannot be increased. According to the affidavit, Delhi has total capacity to store 949 MT of oxygen.

'Making us scapegoats': 14 doctors resign in UP's Unnao over endless review of COVID-19 work

New Delhi, May 14: As the country grapples with the second wave of the deadly COVID-19, fourteen doctors posted in a government hospital in Uttar Pradesh's Unnao district reportedly resigned from their post on Wednesday complaining that they are being harassed with excessive review meetings and made the "scapegoats" for the rising number of Coronavirus cases in the state. According to a report by Dainik Jagran, all these doctors are in charge of the Community Health Centres and the Primary Health Care centres in Unnao providing treatment against COVID-19 to the villagers in the area. In a joint resignation letter signed by the doctors, 11 of the 14 doctors visited Unnao's chief medical officer on Wednesday evening and handed over the letter to his deputy. The doctors say that despite working hard during the pandemic their efforts are met with baseless punitive actions and bad behaviour."The problem is that our teams are working round the clock, but it seems we are being marked out for 'not working'. The DM, other officials, even the SDM, and the tehsildar are all supervising us and holding review meetings." said one of the signatories of the letter, Dr Sharad Vaishya as quoted . "Our teams leave at noon, track and isolate Covid positive patients, get sampling done, distribute medicines and then, once we are back, we get calls from SDM asking to come for review meetings. Even if someone is posted 30 km away, he or she is bound to travel all the 30 km for these review meetings. We have to prove that we have worked. It seems it is being suggested that because we are not working, the Covid infection is spreading," he addedThe government officials have said that they are looking into the matter and will resolve it as soon as possible. The district magistrate Ravindra Kumar issued a statement that the Chief Minister's Office has spoken to the doctors. Meanwhile, Dr Ashutosh Kumar, CMO, as quoted by Dainik Jagran said, "I have received this information about the resignation of 14 doctors. After I will reach the office, I will talk to the medical officers in charge and solve the problem. The allegation of needless pressure and mental and financial harassment is wrong". "Hi just wanted to say Thank you. Both my grandparents are over 75 & took their first jab 5 weeks back, both tested COVID positive 2 weeks back. Low fever was their only symptoms, tested negative today, on the road to recovery with no major issues," tweeted another netizen. "Thank you Bharat Biotech for your hard work and commitment to delivering vaccines to every corner of India," another Twitter user said. Another user said, "If you say that your employees are sick of covid, it speaks volumes about the effi cacy of your vaccine." Ella said as many as 18 states received Covaxin though in smaller shipments. The Hyderabad-based firm is supplying Covaxin to 18 states, including Andhra Pradesh, Haryana, Odisha, Assam, Jammu & Kashmir, Tamil Nadu, Bihar, Jharkhand and Delhi. The other states are Chhattisgarh, Karnataka, Telangana, Tripura, Madhya Pradesh, Uttar Pradesh, Gujarat, Maharashtra and West Bengal.Meanwhile, the Drugs Controller General of India (DCGI) has given its approval to Bharat Biotech to start conducting Phase two and three clinical trials of its COVID-19 vaccine Covaxin on children above 2 years old. The national drug regulator said that it has accepted the recommendation of the SEC "after careful examination" and accorded permission to Covaxin manufacturer Bharat Biotech. On Wednesday, the Hyderabadbased drugmaker said that it has got the necessary approval from an expert panel for conducting phase 2/3 trials on those aged between 2 to 18 years.

KP Sharma Oli Sworn in as Nepal Prime Minister; Retains Previous Cabinet

Kathmandu, May 14: K P Sharma Oli was sworn in as Nepal's Prime Minister on Friday, days after he lost a crucial vote of confidence in Parliament. President Bidya Devi Bhandari administered the oath of office and secrecy to Oli, 69, as the 43rd prime minister of Nepal at a ceremony at Shital Niwas, the presidential palace. Oli was appointed as prime minister by the president in his capacity as leader of the largest political party in Nepal's House of Representatives. He was reappointed to the post on Thursday night as the Opposition parties failed to secure majority seats in Parliament to form a new government.Oli, the Chairman of CPN-UML, lost a crucial trust vote in the House of Representatives on Monday. Oli will now have to take a vote of confidence at the House within 30 days, failing which, an attempt to form a government under Article 76 (5) of the Constitution would be initiated. The ministers of Oli's Cabinet were also sworn in during the ceremony. During the oath-taking ceremony, Prime Minister Oli and Deputy Prime Minister Ishwar Pokharel did not mention the word God though President Bhandari had mentioned it. I will take oath in the name of the country and the people, Oli said, while President Bhandari had mentioned God, country and the people. All the ministers and ministers of state from the old Cabinet have been included in the new Cabinet. Pradeep Gyawali has been reappointed as Foreign Minister while Ram Bahadur Thapa and Bishnu Poudyal were appointed as ministers for Home and Finance. The oath-taking ceremony was kept brief keeping in mind the raging COVID-19 pandemic in the country. Oli Reappointed Nepal PM as Oppn Fails to Muster Majority to Form New Govt Vice President Nanda Bahadur Pun and Supreme Court Chief Justice Cholendra Shumsher Rana were among the distinguished personalities who attended the ceremony. There are 22 ministers and three ministers of state in the new Cabinet.Oli previously served as prime minister from October 11, 2015 to August 3, 2016 and again from February 15, 2018 to May 13, 2021. Earlier, the president had asked the Opposition parties to come up with the support of majority lawmakers to form a new government by 9 pm on Thursday after Oli lost the vote of confidence in the House on Monday. Until Thursday, Nepali Congress president Sher Bahadur Deuba, who got backing from CPN-Maoist Centre chairman Pushpakamal Dahal "Prachanda" was hopeful to get sufficient votes in the House to stake his claim as the next Prime Minister.But as Madhav Kumar Nepal took a U-turn after his last-minute meeting with Oli, Deuba's dream to become the next Prime Minister was shattered.

Alexander-Arnold reminds us why we love football amid outside drama

London, May 14: Near the end of what has supposedly been a difficult season the Liverpool right-back treated Old Trafford as his playgroundLiverpool's Trent Alexander-Arnold shoots on a night at Old Trafford that he dominated from start to finish. There was a decoy Liverpool bus. That was the one that ended up getting its tyres slashed by Manchester United fans on a side street near Old Trafford. The real Liverpool bus, unmarked and unheralded, sneaked around the back entrance to avoid the hundreds of protesters out front. United also operated a couple of dummy buses to shuttle between the hotel and the stadium. The players themselves travelled in their own cars and arrived six hours in advance. On the concourse, riot vans and police horses jostled to keep the crowds at bay. Two arrests were made. Remind me. Why were we doing all this again? This is, perhaps, the prevailing theme of these past eight months of plague football: the vague sensation that somewhere amid the myriad contortions and unsatisfying compromises, the endless whats and wheres and whens, we mislaid the why. Decoy buses. A Thursday 8.15pm kick off to accommodate a fixture postponed because fans stopped it happening. Is this strange? Is this normal? What are we all doing here? Naturally, most of these uncertainties endure. But somehow, in amongst the six goals and the lawless entertainment, a certain logic emerged too.Liverpool are back in the top four race. United are staggering towards the end of the season like a team who have played 58 games on fumes. Harry Maguire is more important than we realised. And after the toughest season of his career, Trent Alexander-Arnold has fought his way through the storm. Tired legs, tired minds, tired bodies, tired consciences: these have been the motifs of Liverpool's pandemic, a jumble of barely legible subplots that seems to make less sense the more you look at it. And for all the turbulence and rancour off the pitch, Liverpool have looked painfully tame on it: swallowed up in a deluge of back passes and hopeless crosses, a team trying all the same things in the increasingly forlorn hope that it will all somehow click.For much of the first half hour, this game appeared to be following a similar pattern. United scored, Bruno Fernandes providing the little flick of invention the game desperately needed. Liverpool puffed and puffed and passed and passed. They had a penalty scrubbed off by the VAR. It felt like one of those nights. But out of a scruffy set piece situation, Diogo Jota diverted the ball past Dean Henderson with an instinctive flick of the heel. It was a foothold, if nothing else. Few players have embodied Liverpool's travails this season as faithfully as Alexander-Arnold. One minute you're a virtual unknown; the next you're one of the hottest footballing properties on the planet and the taker of perhaps the most famous corner in history; the next you've lost your England place and everyone has basically agreed that you can't

Leicester continue to make a mockery of the idea that a "big six" exists in anything bar inflated egos, and they can prove that once again on Saturday. Despite an incredible start in international cricket, she is not someone weighed down by expectations.In many ways, she is the poster-girl of a tournament like The Hundred, which will be her second major international assignment since last year's T20 World Cup. From pundits, players and fans, everyone's gaze will be firmly fixed on Shafali when she eventually turns up for Birmingham Phoenix. But that does not seem to faze her. For the teenager, this is like any other tournament."At a young age and on the big stage that is the World Cup, she has done well. That's an indication of her talent and temperament. She will work things out as she goes along because she is only going to get better. We should not try and tell her that this is how she should go, this is the route she has to take or this is how she has to mould herself. Let her continue playing her cricket," former coach WV Raman had told reporters after India's loss to Australia in the T20 World Cup final. Gary Neville says Glazers have turned Old Trafford into a 'prison' amid protests

Manchester, May 14: Flares and anger filled the Manchester skies as United fans staged another protest before the rescheduled match with Liverpool in which at least two arrests were made, with Gary Neville claiming security arrangements had turned Old Trafford into a "prison". The club erected barricades to protect the ground and there was a visibly heavier police and security presence ensuring those who gathered to voice opposition to the Glazer family ownership were kept at a distance and funnelled when moving around the venue. Neville, a former United captain who was inside Old Trafford as a Sky Sports pundit, was scathing about the arrangements. "Let's be clear, what we've seen on that forecourt before is effectively Man United turned into a prison, it's a devastating image for the Manchester United football club brand around the world, let's just note that," he said. "You have to put prison walls up around your ground and have hundreds and hundreds of police officers at a game where fans aren't at-

said. "The concern is that, when the fans can come back to the stadium, you could have 70,000 fans showing up at Old Trafford, frustrated with what happened. Things can get much worse."Greater Manchester police stated that two arrests had been made relating to public order offences and Chris Sykes, GMP assistant chief constable, issued a statement."We have been working closely with Manchester United and partners to ensure those in attendance outside the stadium are kept safe while exercising their right to a peaceful protest," he said. "The safety of all those concerned remains GMP's main priority. We encourage everyone to remember we are still living under restrictions due to the pandemic and have a collective responsibility to remain safe and protect one another. Enforcement remains our last resort but anyone whose behaviour crosses the boundary into a criminal offence should expect to be prosecuted. "Protesters spoken to by the Guardian expressed frustration at the Glazers, whose leveraged buyout in

"Manchester United fans are not done with this. We saw some protests a few weeks ago but I think there is still a lot to come," he

Owners like the Glazers hold the fans - the lifeblood of the club - in contempt. It's time we took our club back.'

London, May 14: Dina Asher-Smith celebrates at the 2019 world championships in Doha the last time she competed in the 200m before her victory in Savona. Seb Coe, who knows a thing or two about winning Olympic titles, is convinced that Dina Asher-Smith will be Team GB's poster girl in Tokyo. Her rivals in the 100m and 200m will have something to say about that, but there were encouraging signs as Asher-Smith blitzed her way to victory in her first outdoor race of the season in Savona. Asher-Smith has not competed in the 200m since winning world championship gold in Doha in October

2019. But in a low-key meeting in Italy all her familiar traits - including a lightning start and a bend so exquisite that the Italian commentator shouted "mamma mia!" as she powered round it were evident as she came home in 22.56sec.The 25-year-old would have perhaps wanted to go a touch faster, given the Olympics are scheduled to start in 10 weeks. But her dominance was clear with her closest challenger, Britain's Beth Dobbin, more than half a second back at 23.06sec."It's good to be back on track and it's good to be back doing the 200m," Asher-Smith said. "It has been a year-and-a-half since the world

championships in Qatar and since I was doing my last 200m, so it's nice to be back over that distance again."However she knows bigger tests await, starting in 10 days when she races in Gateshead against the reigning 200m Olympic champion, Elaine Thompson-Herah, the double Olympic 100m champion Shelly-Ann Fraser-Pryce, and the new American sensation Sha'Carri Richardson.
